Application by Cottam Solar Project Limited for an Order Granting Development Consent for the Cottam Solar Project The Examining Authority's (ExA's) Record of its Unaccompanied Site Inspection (USI)

The ExA undertook its USI on 7 September 2023 by car and on foot, on public roads and public rights of way (PR0Ws).
