Schedules of progress

As requested in the Rule 8 letter, the Applicant is submitting an updated set of Schedules of progress [EN010133/EX3/C8.1.11_B], [EN010133/EX3/C8.1.12_B] and [EN010133/EX3/C8.1.13_B].

Report on the interrelationship with other National Infrastructure projects

The applicants for Cottam, West Burton, Gate Burton and Tillbridge solar NSIP DCOs continue to collaborate and are working on an updated version of the Report on the Interrelationship with other NSIPs to be submitted at Gate Burton's next examination deadline, which is 21 December 2023 (DL6). The same Report will then be submitted to the Cottam examination the same day or very shortly thereafter, and to West Burton examinations at the next deadline. The Report is included in the list of documents above [EN010133/EX3/C8.1.8_B].

Explanatory Memorandum

The Applicant has not submitted an updated version of the Explanatory Memorandum [APP-017] for this deadline. Instead, the Applicant proposes to submit an updated version of this document for Deadline 4. This is so the document can include the changes made in the version of the Explanatory Memorandum that was submitted as part of the Change Application [EN010133/CR1/C3.2_A_CR] which was accepted on 18 December 2023, as well as any other required changes that follow from subsequent updates to the draft DCO.

Statements of Common Ground

The status of the Statements of Common Ground being agreed by the Applicant and other bodies is summarised in the Statement of Commonality [EN010133/EX3/C8.1.9_B].

Concept Design Parameters and Principles

In response to First Written Question 1.2.19, the Applicant has reviewed the distance between fibre communication chambers as described in the Concept Design Parameters and Principles [REP-039] (CDPP) and ES Chapter 4 Scheme Description [REP-012]. The distance of 1,000m stated in the CDPP is correct; the distance of 2,000m stated in Chapter 4 is incorrect. The Applicant can confirm that the environmental assessments were carried out on the basis of the parameters set out in the CDPP and correct distance was therefore used.

Planning Statement

The Applicant previously undertook to revise the Planning Statement [REP-047], in particular in relation to Neighbourhood Plans. In view of the expected adoption of relevant National Policy Statements (NPSs) in January 2024, the Applicant has not submitted an amended version at Examination Deadline 3 but intends to submit a revised Planning Statement updated in relation to both NPSs and Neighbourhood Plans at Examination Deadline 4.
