Report on the interrelationship with other National Infrastructure projects

The applicants for Cottam, West Burton, Gate Burton and Tillbridge solar NSIP DCOs continue to collaborate on the Report on the Interrelationship with other NSIPs. The latest version of the Report is included in the list of documents above **[EN010133/EX4/C8.1.8_C]**.

Statements of Common Ground

The status of the Statements of Common Ground being agreed by the Applicant and other bodies is summarised in the Statement of Commonality **[EN010133/EX4/C8.1.9_C]**.

Aerial Flyover Video

At the Examination Issue Specific Hearing (ISH) 4 on 6th December 2023, it was requested that the Applicant provide an Aerial Flyover using videography based on aerial drone imagery to present the Scheme in the context of other cumulative solar developments at Gate Burton, West Burton and Tillbridge.

An Aerial flyover utilising Google Aerial imagery has been produced and submitted at Deadline 4 [EN010133/EX4/C8.2.12]. The flyover uses topographical information available to Google to demonstrate basic terrain mapping. This allows the flyover to provide an illustrative visualisation of the changing topography across the route of the flight path. Buildings, individual trees and small woodlands are not picked up in this mapping as three dimensional imagery, however some larger woodlands are and given illustrative elevation.

The imagery commences at the Cottam 1 Site, then moves north across Cottam 2 and Cottam 3a and Cottam 3b Sites to give an aerial perspective of each of these four areas in succession with field numbering and place naming to aid the viewer. The



imagery then moves towards the south west to show the Gate Burton Energy Park (in green) and then continues south across West Burton 3, West Burton 2 and West Burton 1 Solar Sites (in pink). The imagery then rises to give a perspective of the Cottam, Gate Burton, West Burton and Tillbridge solar sites cumulatively before finally passing directly over the Tillbridge Solar Site (in yellow). The imagery is to be read alongside the Environmental Statement and the Joint Report on Interrelationships between Nationally Significant Infrastructure Projects Revision C **[EN010133EX4/C8.1.8_C]**.

Site Area

During discussions between the Applicant and West Lindsey District Council, it was noted that the figures for the areas for each of the Sites provided in ES Chapter 3: The Order Limits **[APP-038]** did not correspond to those provided in, for example, ES Chapter 5 **[APP-040]** and the Planning Statement **[EN010133/EX4/C7.5_C]**. The Applicant can confirm that the figures given in ES Chapter 3 at paragraphs 3.3.1, 3.4.1, 3.5.1, 3.6.1 are incorrect and the result of a typographical error. The figures in ES Chapter 5 and the Planning Statement are correct. All assessments within the Environmental Statement have been undertaken based on the correct figures for the areas for the Sites.
