### 1 Introduction

### 1.1 Purpose of this Document

- 1.1.1 This document has been prepared to provide the Examining Authority (ExA) with the position on Statements of Common Ground (SoCG) between Cottam Solar Project Ltd. (the 'Applicant') and statutory consultees, statutory undertakers and other Interested Parties (the 'parties') in relation to the proposed Cottam Solar Project (the 'Scheme').
- 1.1.2 This document provides a final position on the commonality on specific points reached between the Applicant and other parties in discussions relating to SoCGs at Deadline 5 (being 27 February 2024).

### 1.2 Structure of this Document

- 1.2.1 This Statement of Commonality is structured as follows:

### 2 Statements of Common Ground

### 2.1 Structure of SoCGs

2.1.1 Each SoCG has sought to adopt a standard format to ensure consistency in the approach taken to documenting those matters agreed, matters subject to ongoing discussion or matters not agreed, other than where an individual party has expressed a preference for an alternative format.

### 2.1.2 Each SoCG is structured as follows:

- Section 2 summarises the parties' engagement undertaken to date; and

### 4 Positions at Deadline 5

4.1.1 This section provides a summary of the position reached across all SoCGs submitted to Deadline 5.

### 4.2 Nottinghamshire County Council & Bassetlaw District Council

4.2.1 A final signed SoCG [EX5/C8.3.1\_B] is submitted for Deadline 5 with all matters agreed apart from some cultural heritage matters as detailed within the Cultural Heritage Position Statement submitted as Appendix A to the SoCG with Lincolnshire County Council [EX5/C8.3.2\_D]. Nottinghamshire County Council and Bassetlaw District Council share the same view on heritage matters as Lincolnshire County Council.

### 4.3 Lincolnshire County Council

4.3.1 An agreed SoCG [EX5/C8.3.2\_D] is submitted for Deadline 5 but has not yet been signed by the parties. The signed version will be submitted at Deadline 6. The SoCG includes agreement on all matters except some matters relating to the principle of development, landscape and visual, cultural heritage, soils and agriculture and waste. These matters have been agreed in part with the Council as detailed within the SoCG and accompanying Cultural Heritage and Landscape and Visual Position Statement appendices to the SoCG.

### 4.4 West Lindsey District Council

4.4.1 A final signed SoCG [EX5/C8.3.3\_B] is submitted for Deadline 5. Agreement has been reached with the Council on climate change, ecology and biodiversity, glint and glare, air quality and other environmental matters. Agreement in part has been reached on all other matters except alternatives and design evolution. The position of the Council and the Applicant on these outstanding matters is set out within the SoCG.

### 4.5 National Highways

4.5.1 All matters were agreed between the parties within a signed version of the SoCG for Deadline 1[REP-066].



### 4.6 UK Health Security Agency

4.6.1 All matters were agreed between the Parties within a signed version of the SoCG by Deadline 1 [REP-067].

### 4.7 Upper Witham Internal Drainage Board

4.7.1 All matters were agreed between the Parties within a signed version of the SoCG by Deadline 1. At Deadline 4, written confirmation from the IDB that it has provided consent under section 150 of the Planning Act 2008 to the disapplication of the legislative provisions set out in Article 6 of the DCO was appended to the signed version of the SoCG [REP4-062].

### 4.8 The Environment Agency

4.8.1 The Parties have agreed all matters within a signed version of the SoCG submitted at Deadline 5 [EX5/C8.3.8\_A].

### 4.9 Network Rail

4.9.1 A final agreed version of the SoCG [EX5/C8.3.9\_B] is submitted at Deadline 5 following discussions between the Applicant and Network Rail, however this has not yet been signed by the parties. The signed version will be submitted at Deadline 6.

### 4.10 Lincolnshire Wildlife Trust

4.10.1 All matters were agreed between the Parties within a signed version of the SoCG by Deadline 1 [REP-071].

### 4.11 Natural England

4.11.1 All matters were agreed between the parties within a signed version of the SoCG by Deadline 3 [REP3-046]. ].

### 4.12 Nottinghamshire Wildlife Trust

4.12.1 All matters were agreed between the parties within a signed version of the SoCG by Deadline 1[REP-073].

# 4.13 Gate Burton Energy Park, Tillbridge Solar Project and West Burton Solar Project

All matters were agreed between the parties within a signed version of the SoCG by Deadline 2 [REP2-066]. Nevertheless, the parties have continued discussions and continue to work together on the Joint Report on Interrelationships (JIR), an update of which is submitted for Deadline 5. [EX5/C8.1.8\_D]. This is anticipated to be the final version of the JIR to be submitted by Cottam Solar Project although it will continue to be updated and submitted into the ongoing West Burton examination and forthcoming Tillbridge examination in due course and the Applicant will continue to engage with the other developers in those updates as necessary.



### 4.14 Anglian Water

4.14.1 All matters were agreed between the parties within a signed version of the SoCG by Deadline 2 [REP2-068].

### 4.15 Historic England

4.15.1 The areas of agreement and disagreement between the parties were set out at Deadline 1 and this position has not changed during the course of further discussions. A final signed version of the SoCG has been provided for Deadline 5 which clarifies the areas of disagreement between the parties [EX5/C8.3.4\_A].

### 4.16 Scunthorpe and Gainsborough Water Management Board

4.16.1 A signed version of the SoCG with all matters agreed between the Applicant and the Scunthorpe and Gainsborough Water Management Board is submitted for Deadline 5 [EX5/C8.3.15\_A].
