Introduction

- 1.1.1 This document provides a guide to the Development Consent Order (DCO) application for Cottam Solar Project (The Scheme). The Application is made by Cottam Solar Project Limited (the Applicant) to the Secretary of State for Business, Energy and Industrial Strategy (the Secretary of State) pursuant to the Planning Act 2008 (PA 2008).
- 1.1.2 The Applicant is seeking a DCO for the construction, operation (including maintenance), and decommissioning of ground mounted solar photovoltaic (PV) panel arrays, a Battery Energy Storage System (BESS) and supporting infrastructure (the Scheme). The Application is required because the Scheme is classified as a Nationally Significant Infrastructure Project (NSIP) under the PA 2008.
- 1.1.3 This Guide provides an overview of the documents that have been submitted in order to satisfy the APFP Regulations, the EIA Regulations and section 37 of the PA 2008.

1 Document Referencing

- 1.1.1 Each document that forms part of this Application and subsequent stages of the DCO process, has been assigned a reference number that will allow it to be located within the Application document library. When an Application document refers to another document, then the full reference information is provided, highlighted with bold. This comprises the PINS reference ('EN010133'), followed by an indication that the document forms part of the Application ('APP') and then the specific document number (for example, 'C6.2.2'); this produces a full reference in the format [EN010133/APP/C6.2.2].
- 1.1.2 In order to aid navigation within Appendices of the Landscape and Visual Impact Assessment Chapter of the Environmental Statement [EN010133/APP/C6.3.8.1-C6.3.8.5], this referencing system has been extended within the documents with the use of sub-references, allowing direct references to specific sections.
- 1.1.3 Revision suffixes have been attached to documents which, since submission on 12 January 2023, have been revised and resubmitted to the Planning Inspectorate. This updated Guide, for example, is referenced as '[EN010133/EX1/C1.3_B]' which reflects the Guide's second revision since submission on 12 January 2023.
- 1.1.4 Additionally, submissions to the Planning Inspectorate post 12 January 2023 carry a 'deadline indicator' to detail by which deadline the document was submitted to the Planning Inspectorate. All documents submitted to the Planning Inspectorate 12 January 2023 carry '/APP/' within their unique reference. Those new submissions made to the Planning Inspectorate post-submission and during the pre-examination stage carry '/PEX/' instead of '/APP/' within the reference to reflect the submission being made during the pre-examination stage. New submissions made during the



- examination stage will carry '/EX1/', '/EX2/', '/EX3/' etc. depending by which examination deadline the submission of the new document is made.
- 1.1.5 Submissions relating to the Change Application submitted on 8 December 2023 are prefixed with "/CR1/". These versions are marked with '(Change Application)'. The Change Application was accepted by the ExA on 18 December 2023 [PD-014], and the Change versions have superseded previous versions and the Guide has been updated to indicate this.
