# COTTAM SOLAR PROJECT ORDER 2024 (S.I 2024/No. 943) SCHEDULE 4 TO THE PLANNING ACT 2008

### CORRECTION OF ERRORS IN DEVELOPMENT CONSENT ORDER

DATE: 25 November 2024

The Secretary of State received a request dated 16 October 2024 from Cottam Solar Project Limited ("the Applicant") for the correction of errors in the Cottam Solar Project Order 2024 ("the Order"), under section 119 of, and Schedule 4 to, the Planning Act 2008.

The Secretary of State has made the following corrections to the Order:

### Corrections to the Articles

#### Article 2(1) - Interpretation

The definition of "the Gate Burton Energy Park Order" amended to replace the words "the Gate Burton Energy Park Order means the Gate Burton Energy Park Order 2024(b)" with "the Gate Burton Energy Park Order" means the Gate Burton Energy Park Order 2024(b)".

#### Article 2(1) - Interpretation

The definition of "West Burton Solar Project Order" amended to include the word "is" before the word "granted".

Words inserted to make it clear that subject to the provisions of article 23, all private rights and restrictive covenants over land subject to compulsory acquisition under the Order are extinguished according to whichever is the earliest of sub-paragraphs (a) or (b) of article 23(1).

### Article 35(6) – Consent to transfer the benefit of the Order

Article 35(6) amended to replace the words "fourteen" with "ten".
