

Executive Summary

This Consultation Report ('Report') relates to the Stonestreet Green Solar project (the 'Project').

EPL 001 Limited¹ (the 'Applicant') has submitted an application to the Planning Inspectorate for a Development Consent Order ('DCO') from the Secretary of State for Energy Security and Net Zero for the Project (the 'DCO Application'). The Project is a Nationally Significant Infrastructure Project ('NSIP') as defined in the Planning Act 2008 (the 'PA 2008')¹.

In accordance with section 37(3)(c) of the PA 2008, the Applicant has submitted this Report as part of the DCO Application. This Report explains how the Applicant has complied with the consultation requirements set out in the PA 2008, summarises the responses received to the consultation and explains the account taken by the Applicant of those responses in finalising the DCO Application. This Report also provides information about the non-statutory consultation and engagement undertaken by the Applicant about the Project.

The Applicant carried out comprehensive pre-application consultation on its proposals prior to submitting the DCO Application, including a five-week non-statutory consultation, two five-week statutory consultations and two four-week targeted consultations. The consultation accorded with the requirements of the PA 2008, the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 ('APFP Regulations')² and the Infrastructure Planning (Environmental Impact Assessment Regulations 2017 ('EIA Regulations')³ and had regard to guidance issued under section 50(3) of the PA 2008. In addition, the Applicant undertook non-statutory engagement throughout the pre-application stage.

The Applicant consulted in a variety of ways to maximise consultee participation. A large number of consultees provided feedback and the Applicant is grateful to all those who took the time to engage in the consultation process.

1.3 The Project

1.3.1 The Project comprises the proposed construction, operation, maintenance and decommissioning of solar photovoltaic ('PV') arrays and energy storage, together with associated infrastructure and an underground cable connection to the existing National Grid Sellindge Substation. The Project will include a generating station (incorporating solar arrays) with a total capacity exceeding 50 megawatts ('MW').



The agreed grid connection for the Project will allow the export and import of up to 99.9 MW of electricity to the grid. The Project will connect to the existing National Grid Sellindge Substation via a new 132 kilovolt ('kV') substation constructed as part of the Project and cable connection under the Network Rail and High Speed 1 ('HS1') railway.

- 1.3.2 Key components of the Project include:
 - a ground mounted solar PV generating station;
 - a balance of system and battery energy storage system;
 - a Project substation and associated works;
 - works to lay high voltage electrical cables and extend Sellindge Substation to facilitate grid connection;
 - associated works;
 - site access:
 - construction and decommissioning works;
 - works to create, enhance and maintain green infrastructure, boundary treatments and crossing structures; and
 - further site wide associated development in connection with the Project.
- 1.3.3 A detailed description of the Project is set out in **Environmental Statement ('ES') Volume 2, Chapter 3: Project Description (Doc Ref. 5.2)**.
- 1.3.4 The site on which the Project is located ('Site') is approximately 192 hectares ('ha') located at Aldington to the south-east of Ashford in Kent. The Project lies within the administrative areas of Kent County Council ('KCC') and Ashford Borough Council ('ABC') local authorities.
- 1.3.5 **ES Volume 3, Figure 2.1: Field Boundaries and Site Area Plan (Doc Ref. 5.3)** provides a Field Boundaries and Site Area Plan, which numbers individual fields. For ease of reference, the areas of the Site are subsequently referred to as follows:
 - South Western Area (Fields 1 to 9);
 - Central Area (Fields 10 to 19 and 23 to 25);
 - South Eastern Area (Fields 20 to 22);
 - Northern Area (Fields 26 to 29);
 - Project Substation (location of the Project Substation, in the north western section of Field 26);
 - 'Cable Route Corridor' (export of electricity from the Project at 132kV via underground cables (the 'Grid Connection Cable') to the Sellindge Substation);
 - 'Cable Route Crossing' (use of an existing cable duct under the HS1 railway or through Horizontal Directional Drilling ('HDD') beneath HS1 for the cable connection);



- Sellindge Substation (location of the existing Sellindge Substation).

2 2022 Non-Statutory Consultation

2.1 Overview

- 2.1.1 The Applicant recognises the importance of early consultation. The Applicant therefore carried out non-statutory consultation on the Project with the local community and key stakeholders between 25 March and 29 April 2022 (known as the '2022 Non-Statutory Consultation').
- 2.1.2 As part of this 2022 Non-Statutory Consultation, the Applicant sent a Community Information Leaflet (see **Appendix A-2: 2022 Non-Statutory Consultation Materials (Doc Ref. 6.2))** on 22 March 2022 to over 2,200 homes and businesses within a 4km radius of the Site comprising the Core Consultation Zone (see **Section 5.4** of this Report for further details). The leaflet introduced the Project and explained how people could find out more about the Project, meet members of the Applicant's Project team and respond to the 2022 Non-Statutory Consultation.
- 2.1.3 Four local information events were held on the following dates and times during which the initial proposals were introduced and attendees were able to ask questions of the Applicant's Project team:
 - Sellindge Village Hall Friday 8 April 2022, 3pm to 7pm;
 - Aldington Village Hall Saturday 9 April 2022, 11am to 3pm;
 - Bilsington Village Hall Tuesday 12 April 2022, 1pm to 5pm;
 - Mersham Sports Club Wednesday 13 April 2022, 2pm to 6pm.
- 2.1.4 The local information events were publicised through the Statement of Community Consultation 1 ('SoCC 1') made available for inspection on 22 March 2022 and the related local newspaper notice (see **Section 4.3** of this Report for further details), as well as through the Community Information Leaflet (see **Appendix A-2: 2022 Non-Statutory Consultation Materials (Doc Ref. 6.2)**), the Project's Twitter feed, a press release (see **Appendix A-1: Press Release (Doc Ref. 6.2)**) and on the Project website at www.stonestreetgreensolar.co.uk/consultation. A total of 90 people attended the local information events.
- 2.1.5 The exhibition boards for the local information events (see **Appendix A-2: 2022 Non-Statutory Consultation Materials (Doc Ref. 6.2)**) were made available on the Project website from 6 April 2022.
- 2.1.6 Emails were sent to nine parish councils on 23 March 2022 (see Appendix B-5: Samples Email Consulting Community Groups on the Statement of Community Consultation 1 (Doc Ref. 6.2)). This email confirmed the publication of SoCC 1 and provided a link to SoCC 1 on the Project website. It also confirmed the details of the local information events to be held.
- 2.2 Responses to 2022 Non-Statutory Consultation



- An online feedback form (see Appendix A-2: 2022 Non-Statutory Consultation Materials (Doc Ref. 6.2)) was made available on the Project website during the consultation period for the 2022 Non-Statutory Consultation. A hard copy feedback form (see Appendix A-2: 2022 Non-Statutory Consultation Materials (Doc Ref. 6.2)) was available at the local information events, the Deposit Locations (see Section 4.3.15 of this Report for further information) and via post upon request from the Applicant.
- 2.2.2 Responses to the 2022 Non-Statutory Consultation could be provided in the methods set out in **Table 2**.

3 Consultation under EIA Regulations

3.1 Introduction

3.1.1 The Planning Inspectorate's Advice Note Fourteen: Compiling the Consultation Report⁴ states:

'Applicants may wish to draw attention to consultation responses received under the EIA process, but any reference to that consultation should be addressed separately from the statutory consultation carried out under the provisions of the PA 2008.'

3.2 Scoping

- 3.2.1 The EIA requirement for NSIPs is transposed into law through the EIA Regulations. The EIA Regulations specify which developments are required to undergo EIA and schemes relevant to the NSIP planning process are listed under either 'Schedule 1' or 'Schedule 2'. Those developments listed in Schedule 1 must be subject to EIA, while developments listed in 'Schedule 2' must only be subject to EIA if they are considered 'likely to have significant effects on the environment by virtue of factors such as its nature, size or location' (Regulation 3(1) of the EIA Regulations). The selection criteria for Schedule 2 development are set out in Schedule 3 of the EIA Regulations.
- 3.2.2 The Project is a 'Schedule 2' development under paragraph 3(a) of Schedule 2 of the EIA Regulations as it constitutes an 'industrial installation for the production of electricity' and is not a project listed in Schedule 1.
- 3.2.3 On 19 April 2022, the Applicant submitted a Scoping Report (see **ES Volume 4**, **Appendix 1.1: Scoping Report (Doc Ref. 5.4)**) in support of a request for a Scoping Opinion from the Planning Inspectorate on behalf of the Secretary of State pursuant to Regulation 10 of the EIA Regulations.
- 3.2.4 A Scoping Opinion (see **ES Volume 4, Appendix 1.2: Scoping Opinion (Doc Ref. 5.4)**) was adopted by the Planning Inspectorate on 30 May 2022. Before adopting the Scoping Opinion, the Planning Inspectorate consulted the 'consultation bodies' listed in Appendix 1 of the Scoping Opinion in accordance with Regulation 10(6) of the EIA Regulations. A list of those consultation bodies who replied within the statutory timeframe (along with copies of their comments) is provided in Appendix 2 of the Scoping Opinion. As confirmed at paragraph 1.05 of the Scoping Opinion, those comments were taken into account in the preparation of the Scoping Opinion.

3.3 Environmental Statement

3.3.1 An Environmental Statement for the Project has been submitted with the DCO Application.



- 3.3.2 **ES Volume 4, Appendix 1.3: EIA Scoping Opinion Compliance (Doc Ref. 5.4)** provides responses to the following aspects of Scoping Opinion:
 - Overarching Comments (Scoping Opinion Section 2); and
 - Cumulative Effects (Scoping Opinion Section 3.10).
- 3.3.3 Responses to Scoping Opinion comments made in relation to 'Environmental Aspect Comments' (Scoping Opinion **Sections 3.2 3.9**) are addressed in the 'Consultation' section of the technical chapters included as **ES Volume 2**, **Chapters 7 15** (**Doc Ref. 5.2**).
- 3.3.4 Responses to Scoping Opinion comments made in relation to 'Topics to be Scoped Out' (Scoping Opinion Section 3.1) are provided in ES Volume 2, Chapter 16: Other Topics (Doc Ref. 5.2).



4 Approach to Statutory Consultation

4.1 Overview

- 4.1.1 Following detailed consideration of the feedback received to the 2022 Non-Statutory Consultation outlined in **Section 2** above, together with the results of further technical surveys and analysis, the Applicant undertook:
 - Statutory Consultation and publicity between 25 October and 29 November 2022 on the updated proposals for the Project in accordance with sections 42, 47 and 48 of the PA 2008 (known as the '2022 Statutory Consultation'); and
 - Statutory Consultation and publicity between 12 June and 17 July 2023 on the further updated proposals for the Project in accordance with sections 42, 47 and 48 of the PA 2008 (known as the '2023 Statutory Consultation').
- 4.1.2 The Applicant also undertook targeted consultation between 13 November and 13 December 2023 (known as the '2023 Targeted Consultation') and between 12 February and 12 March 2024 (known as the '2024 Targeted Consultation') on minor, localised changes to the Site boundary. Consultation was carried out with persons with an interest in the land that were directly affected by the proposed changes to the Site boundary under section 42(1)(d) of the PA 2008, as well as consultees under section 42(1)(a) and (b) of the PA 2008 who the Applicant considered would be interested in the proposed changes.
- 4.1.3 The consultation periods for each of the consultations exceeded the minimum period of 28 days of consultation required by the PA 2008.
- 4.2 Legal requirements for statutory consultation
- 4.2.1 The statutory pre-application consultation for the Project was designed to comply with the statutory requirements in:
 - the PA 2008;
 - the APFP Regulations; and
 - the EIA Regulations.
- 4.2.2 The Applicant's approach to consultation has been structured to accord with the applicable legal framework and to provide a high quality and meaningful process of consultation with the local community, statutory consultees and the general public.
- 4.2.3 Appendix H: Compliance with Legislation, Guidance and Statement of Community Consultation (Doc Ref. 6.2) sets out the statutory requirements (Table 1) and the requirements from the relevant guidance on pre-application consultation (Table 2), explains how the Applicant complied with each requirement and identifies where further information can be found within this Report.



4.3 Statement of Community Consultation

- 4.3.1 As required by section 47(1) of the PA 2008, the Applicant prepared a statement setting out how it proposed to consult, about the proposed application, people living in the vicinity of the land.
- 4.3.2 An initial SoCC ('SoCC 1') was made available for inspection from 22 March 2022 (see Appendix B-3: Published Statement of Community Consultation 1 (Doc Ref. 6.2)). SoCC 1 was revised in advance of the commencement of the 2022 Statutory Consultation by a revised SoCC ('SoCC 2') that was made available for inspection from 28 September 2022 (see Appendix B-8: Published Statement of Community Consultation 2 (Doc Ref. 6.2)). SoCC 2 was revised in advance of the commencement of the 2023 Statutory Consultation by a further revised SoCC ('SoCC 3') that was made available for inspection from 24 May 2023 (see Appendix B-12: Published Statement of Community Consultation 3 (Doc Ref. 6.2)).

SoCC 1

- 4.3.3 In accordance with section 47(2) of the PA 2008, before preparing SoCC 1, the Applicant consulted each local authority within section 43(1) of the PA 2008 (i.e. the host authorities) about what was to be in the statement. For this purpose, the Applicant consulted: KCC, ABC and Folkestone & Hythe District Council ('FHDC').
- 4.3.4 An initial draft of SoCC 1 was sent to ABC on 17 December 2021 for informal feedback. ABC provided the following feedback to the initial draft of SoCC 1:
 - Request for further information about the Site and layout
 - Clarification about the villages in the Core Consultation Zone
 - Suggestion for a wider engagement plan and wider consultation zones
- 4.3.5 Regard was had to that informal feedback in preparing the next draft of SoCC 1.
- 4.3.6 A revised draft of SoCC 1 was sent to the host authorities (ABC, FHDC and KCC) for formal consultation under section 47(2) of the PA 2008 between 10 January and 7 February 2022 (see Appendix B-1: Letters Consulting Host Authorities on Statement of Community Consultation 1 (Doc Ref. 6.2) for the covering letters). A table listing the feedback received and how the Applicant had regard to that feedback in preparing the final version of SoCC 1 is provided at Appendix B-2: Regard had to Host Authorities' Responses to Statement of Community Consultation 1 (Doc Ref. 6.2).
- 4.3.7 SoCC 1 described the Project and the Site, explained the PA 2008 process, identified the Applicant as EPL 001 Limited (a subsidiary of Evolution Power Limited) and provided details of how the local community consultation would be carried out.
- 4.3.8 SoCC 1 was made available for public inspection from 22 March 2022 onwards at:

SoCC 2

- 4.3.10 After carrying out the 2022 Non-Statutory Consultation, the Applicant decided to make available an updated SoCC ('SoCC 2') to reflect that the consultation programme had changed from that initially anticipated in order to avoid any confusion within the local community.
- 4.3.11 In accordance with section 47(2) of the PA 2008, before preparing SoCC 2, the Applicant consulted each of the host authorities about what was to be in the statement.
- 4.3.12 An initial draft of SoCC 2 was sent to the host authorities on 3 August 2022 for informal feedback. The authorities provided the following feedback to the initial draft of SoCC 1:
 - Request for a public presentation about the Project where the Applicant would be available to answer questions from the community
 - Provide targeted, sponsored social media advertising to raise awareness of the consultation
 - Recommend copies of the SoCC and PEIR are provided at New Romney Library, Lyminge Library and Hythe Library
 - Content with the proposed face-to-face consultation events.
- 4.3.13 Regard was had to that informal feedback in preparing the next draft of SoCC 2.
- 4.3.14 A revised draft of SoCC 2 was sent to the host authorities for formal consultation under section 47(2) of the PA 2008 between 8 August 2022 and 5 September 2022 (see **Appendix B-6: Emails Consulting Host Authorities on the Statement of**



Community Consultation 2 (Doc Ref. 6.2) for the covering emails). A table listing the feedback received and how the Applicant had regard to that feedback in preparing the final version of SoCC 2 is provided at Appendix B-7: Regard had to Host Authorities' Responses to Statement of Community Consultation 2 (Doc Ref. 6.2).

- 4.3.15 SoCC 2 was made available for public inspection from 28 September 2022³ onwards at the following locations ('Deposit Locations'):

- 4.3.18 A table listing the material requirements of SoCC 2, and how the Applicant carried out the 2022 Statutory Consultation in accordance with each requirement, is provided in Table 3 of Appendix H: Compliance with Legislation, Guidance and Statement of Community Consultation (Doc Ref. 6.2).

SoCC 3

- 4.3.19 After carrying out the 2022 Statutory Consultation, the Applicant decided to carry out a further stage of statutory consultation, the 2023 Statutory Consultation. The Applicant therefore decided to revise the SoCC ('SoCC 3') to explain how it intended to carry out that consultation with the local community.
- 4.3.20 In accordance with section 47(2) of the PA 2008, before preparing SoCC 3, the Applicant consulted each of the host authorities about what was to be in the statement.
- 4.3.21 A draft of SoCC 3 was sent to the host authorities for formal consultation under section 47(2) of the PA 2008 between 20 January and 17 February 2023 for ABC and KCC and between 24 January and 21 February 2023 for FHDC⁴ (see **Appendix B-10**: **Emails and Letters Consulting Host Authorities on the Statement of Community Consultation 3 (Doc Ref. 6.2)** for the covering letters). A table listing the feedback received and how the Applicant had regard to that feedback in preparing the final version of SoCC 3 is provided at **Appendix B-11**: **Regard had to Host Authorities' Responses to Statement of Community Consultation 3 (Doc Ref. 6.2)**.
- 4.3.22 SoCC 3 was made available for public inspection from 24 May 2023 onwards at the Deposit Locations.
- 4.3.23 A notice (see Appendix B-13: Section 47 Notices for Statement of Community Consultation 3 (Doc Ref. 6.2) stating where and when SoCC 3 could be inspected was published in the local newspapers listed in Table 6 below in accordance with section 47(6)(a) of the PA 2008:

- 4.3.24 Once SoCC 3 was finalised and made available for public inspection, the Applicant carried out the local community consultation as part of the 2023 Statutory Consultation in accordance with that statement.
- 4.3.25 A table listing the material requirements of SoCC 3, and how the Applicant carried out the 2023 Statutory Consultation in accordance with each requirement, is provided in Table 4 of Appendix H: Compliance with Legislation, Guidance and Statement of Community Consultation (Doc Ref. 6.2).

4.3.26 The 2023 Targeted Consultation and the 2024 Targeted Consultation were carried out with persons with an interest in the land that was directly affected by the proposed changes to the Site boundary under section 42(1)(d) of the PA 2008, as well as consultees under section 42(1)(a) and (b) of the PA 2008 who the Applicant considered would be interested in the proposed changes. Due to the minor, localised nature of the proposed changes, the Applicant did not consider that reconsultation was required pursuant to section 47 or section 48 of the PA 2008.



5 2022 Statutory Consultation

5.1 Consultation material

- 5.1.1 Information on the Project and preliminary environmental information was published for the 2022 Statutory Consultation in the following documents (see **Appendix F-1: Consultation Information Pack (Doc Ref. 6.2)**):
 - Preliminary Environmental Information Report, setting out the information compiled by the Applicant to enable consultees to develop an informed view of the likely significant environmental effects of the Project, and comprising three volumes: Volume 1 (Non-Technical Summary); Volume 2 (Main Text); and Volume 3 (Appendix).
 - Consultation Booklet, providing information about the Project, the feedback received from the 2022 Non-Statutory Consultation, the local information events and how to respond to the statutory consultation.
 - **Exhibition Boards**, being the boards used at the local information events for the 2022 Statutory Consultation to provide information about the Project and the statutory consultation.
- 5.1.2 Together, these documents described the Project and the Site, identified the Applicant as EPL 001 Limited (a wholly-owned subsidiary of Evolution Power Limited), explained the consultation process and set out how consultees could respond to the consultation.
- 5.1.3 These documents, together with SoCC 2, consultation leaflets/newsletters and the notice published under section 48 of the PA 2008, were available for inspection during the consultation period free of charge at the Deposit Locations listed in **Section 4.3.15** of this Report. A check of the Deposit Locations to ensure there were sufficient copies of materials was undertaken on 15 November 2022; no Deposit Locations needed to be replenished.
- 5.1.4 Electronic copies of the consultation documents were also available to download free of charge during the consultation period on the Project website at www.stonestreetgreensolar.co.uk under the tab labelled 'Consultation'.
- 5.1.5 A copy of the consultation documents were available for inspection at the local information events listed in **Section 2.1.3** of this Report.
- 5.1.6 The Applicant offered to provide a full set of consultation documents on a USB memory stick upon request free of charge and hard copies could be obtained upon request at a cost of £500 per copy. The Applicant issued three USBs and one hard copy of a consultation document in large font following request from a local resident with poor eyesight.
- 5.2 Methods by which consultees could respond



- 5.2.1 All consultees were able to respond to the 2022 Statutory Consultation in the following ways:
 - Completing an online feedback form (see Appendix F-1: Consultation Information Pack (Doc Ref. 6.2)) on the Project website at www.stonestreetgreensolar.co.uk/consultation
 - Completing a hard copy feedback form (see Appendix F-1: Consultation Information Pack (Doc Ref. 6.2)) (available at the local information events, the Deposit Locations and by post upon request from the Applicant) and either handing it to the Project team at the local information event or submitting it by post to FREEPOST Stonestreet Green Solar
 - Submitting comments by:
 - email to info@stonestreetgreensolar.co.uk;
 - post to FREEPOST Stonestreet Green Solar; or
 - telephone at 08081 698335.

5.3 Part A: Section 42 Consultation

Introduction

5.3.1 The Applicant carried out statutory consultation with statutory consultees pursuant to section 42 of the PA 2008 between 25 October and 29 November 2022, in parallel with the section 47 consultation and section 48 publicity.

Identifying section 42 consultees

5.3.2 There are a number of different categories of consultee under section 42 of the PA 2008. The sections below explain how the Applicant identified the consultees in each category. The consultees were identified using the preferred Order limits used for the consultation. A full list of the section 42 consultees consulted as part of the 2022 Statutory Consultation is provided at Appendix C-1: List of Section 42(1)(a) and (b) Consultees for 2022 Statutory Consultation and Appendix C-2: List of Section 42(1)(d) Consultees for Statutory Consultation (Doc Ref. 6.2).

Section 42(1)(a): such persons as may be prescribed

- 5.3.3 The Applicant identified prescribed consultees with careful reference to:
 - Schedule 1 of the APFP Regulations. The Infrastructure Planning (Miscellaneous Provisions) Regulations 2024⁵ amended the APFP Regulations 2009 by substituting a new table of persons prescribed for the purpose of section 42(1)(a) of the PA 2008. Regulation 4 (the transitional provisions) of the Infrastructure Planning (Miscellaneous Provisions) Regulations 2024 states that 'the amendments in regulation 2 do not apply to any proposed application for an order granting development consent where the applicant has started to consult under section 42 of the Act before 30th April 2024.' As the statutory consultation for the Project was carried out and completed prior to 30th April 2024, the Applicant consulted



- the prescribed consultees as listed within the APFP Regulations prior to these amendments.; and
- the list of consultation bodies in Appendix 1 of the EIA Scoping Opinion (see ES Volume 4, Appendix 1.2: Scoping Opinion (Doc Ref. 5.4)) adopted by the Planning Inspectorate (on behalf of the Secretary of State) pursuant to Regulation 10 of the EIA Regulations dated 30 May 2022.

Section 42(1)(aa): Marine Management Organisation

- 5.3.4 The Project would not affect, or be likely to affect, any of the areas specified in section 42(2) PA 2008. Therefore, the Applicant did not consult the Marine Management Organisation.
 - Section 42(1)(b): each local authority that is within section 43
- 5.3.5 The local authorities within section 42(1)(b) of the PA 2008 for the purposes of the 2022 Statutory Consultation and the 2023 Statutory Consultation are identified in **Table 7**. The administrative boundaries of these authorities for the purposes of the 2022 Statutory Consultation and the 2023 Statutory Consultation are shown in **Figure 1**.



- 5.3.6 Following a reduction in the Site boundary that took place after the 2023 Statutory Consultation had ended, and which was the subject of the 2023 Targeted Consultation, the land within the Site that fell within FHDC's administrative boundary was removed from the Site, see **Section 8** of this Report for further details. This meant that the category within which FHDC falls changed from local authority (B) to local authority (A), and consequently Dover District Council was no longer a local authority consultee, under section 43 of PA 2008.




Figure 2: Administrative boundaries of section 42(1)(b) authorities (DCO Application)

- 5.3.7 The local authorities within section 42(1)(b) of the PA 2008 for the purposes of the final Project that is the subject of the DCO Application are identified in **Table 8**. The administrative boundaries of these authorities are shown in **Figure 2**.

Section 42(1)(c): Greater London Authority

5.3.8 As the Site is not within Greater London, the Applicant did not consult with the Greater London Authority.

Section 42(1)(d): each person who is within one or more of the categories set out in section 44

- 5.3.9 Under section 42(1)(d) of the Act, the Applicant must consult each person who is within one or more of the three categories set out in section 44 of the PA 2008. These categories are:
 - Category 1: A person is within Category 1 if the Applicant, after making diligent inquiry, knows that the person is an owner, lessee, tenant (whatever the tenancy period) or occupier of the land.
 - Category 2: A person is within Category 2 if the Applicant, after making diligent inquiry, knows that the person is interested in the land, or has power to sell and convey the land or to release the land.
 - Category 3: A person is within Category 3 if the Applicant thinks that, if the DCO were made and fully implemented, the person would or might be entitled as a result of (a) the implementing of the DCO, (b) the DCO having



been implemented, or (c) use of the land once the DCO has been implemented, to make a 'relevant claim'. There are three types of relevant claim: a claim under section 10 of the Compulsory Purchase Act 1965⁶; a claim under Part 1 of the Land Compensation Act 1973⁷; and a claim under section 152(3) of the PA 2008. A person is within Category 3 only if the person is known to the Applicant after making diligent inquiry. These parties were identified based on the scheme proposals, redline boundaries, construction activities, and environmental information available at the point of statutory consultation.

- 5.3.10 A full list of persons falling within section 44 of the PA 2008 is included within the **Book of Reference (Doc Ref. 4.1)** submitted with the DCO Application.
- 5.3.11 Land referencers were appointed by the Applicant to complete a diligent enquiry process prior to and throughout the pre-application stage to identify relevant persons with an interest in land. The following process was followed:
 - Landowners and other interested parties were identified initially through title searches with the Land Registry. These searches were refreshed at regular intervals to ensure the information held was accurate. Previously unregistered areas of land were also periodically checked to ensure the land remained unregistered.
 - Land referencing questionnaires, provided in Appendix F-2: Sample Letter and Land Interest Questionnaire (Doc Ref. 6.2), were issued to all interests identified through Land Registry searches. These forms sought to confirm the contact details of the affected parties and also to ask for details of any other parties who may hold an interest in the land. Where new interested parties were revealed, these parties were also issued with a request for information form to confirm the details provided. This confirmation process has been on going throughout all stages of consultation.
 - Where ownership could not be determined or request for information forms were not returned, further reminder letters were issued and site visits were conducted. The site visits involved identifying and visiting potential landowner residences, neighbours and other properties to try and identify landowners and/or occupiers. Land referencing questionnaires, provided in Appendix F-2: Sample Letter and Land Interest Questionnaire (Doc Ref. 6.2), requesting clarity on land ownership, and details of other persons with an interest in the land, were issued and completed on site where possible.
 - Further information was obtained where possible with follow up site visits, desktop research, letters, emails and telephone calls.

Consultation activities

5.3.12 The consultation letters were sent to the section 42 consultees by registered post, with the majority being posted on 19 October 2022 and the remainder being posted on 21 October 2022 (to avoid the Royal Mail strike on 20 October 2022) to arrive by the consultation launch on 25 October 2022 (see **Appendix C-3: Sample Letters**



Sent to Section 42 Consultees for 2022 Statutory Consultation (Doc Ref. 6.2) for the sample letters).

- 5.3.13 A follow up email attaching the letters was sent on 31 October 2022 to all consultees where the email address of the consultee was known.
- 5.3.14 The letters notified consultees about the launch of the consultation on 25 October 2022, identified where consultees could view the consultation material, explained how consultees could respond to the consultation and confirmed the deadline for receipt of consultation responses, being 29 November 2022.
- 5.3.15 The letters provided a link to the Project website where all of the consultation documents could be downloaded and enclosed:
 - the section 48 notice;
 - the feedback form; and
 - a Section 42 Plan for Consultation.

5.4 Part B: Section 47 Consultation

Introduction

5.4.1 The Applicant carried out statutory consultation with the local community pursuant to section 47 of the PA 2008 between 25 October and 29 November 2022, in parallel with the section 42 consultation and section 48 publicity.

Identifying the local community

- 5.4.2 A Core Consultation Zone was set by the Applicant to cover a 4km radius from the centre of the Site (see Figure 2 of SoCC 2 at Appendix B-8: Published Statement of Community Consultation 2 (Doc Ref. 6.2)). The zone centred on the Site in Aldington and extended outwards to include the nearby surrounding villages of Bilsington, Bonnington, Brabourne Lees, Kingsnorth, Mersham and Smeeth. All elements of the Project are located within this Core Consultation Zone. Residents and businesses within the Core Consultation Zone received the Project leaflets and newsletters directly.
- 5.4.3 In recognition of the expectation that there would be some people outside of the Core Consultation Zone who might be interested in the Project, the Applicant also set a Wider Consultation Zone to cover a 10km radius from the centre of the Site (refer to Figure 3 of SoCC 2 at Appendix B-8: Published Statement of Community Consultation 2 (Doc Ref. 6.2)). The Applicant used tools including media relations and advertising to notify residents and businesses within the Wider Consultation Zone about the consultation.

5.5 Consultation activities

Face-face events



- 5.5.1 Four local information events were held (open to all members of the public) to provide opportunities to view the consultation documents and speak with members of the Applicant's Project team. These were held at:
 - Mersham Village Hall Friday 4 November 2022, 3pm to 7pm
 - Aldington Village Hall Saturday 5 November 2022, 11am to 3pm
 - Sellindge Village Hall Tuesday 8 November 2022, 2pm to 6pm
 - Bilsington Village Hall Wednesday 9 November 2022, 1pm to 5pm
- 5.5.2 The exhibition boards used at these events (see **Appendix F-4: Exhibition Boards** and **Screenshots of Website (Doc Ref. 6.2)**) were available to download on the Project website during the consultation period.
- 5.5.3 A public presentation was held on Tuesday 8 November 2022, 8pm to 9.30pm, at Aldington Village Hall. A copy of the presentation, along with written answers to the questions asked, was uploaded to the Project website after the event.
- 5.5.4 These events were publicised through the notice published under section 48 PA 2008, on the Project website and in the consultation leaflet, poster and advert (see below).
- 5.5.5 A total of 138 people attended the local information events and approximately 60 attended the public presentation.

Website

- 5.5.6 The Project website (www.stonestreetgreensolar.co.uk) was kept up to date for the duration of the 2022 Statutory Consultation.
- 5.5.7 Amongst other things, it contained copies of the consultation material, SoCC 2, the online feedback form and contact details for the Applicant. It continued to host the consultation information after consultation close for reference purposes (see Figure 3).

5.5.8 A Community Information Leaflet (see **Appendix F-1: Consultation Information Pack (Doc Ref. 6.2)**) was sent to over 2,200 homes and businesses within the Core Consultation Zone on 14 October 2022. This provided details of the statutory consultation, including where and when the consultation documents could be accessed and how and by what deadline any responses could be submitted.

Consultation Poster

5.5.9 A consultation poster (see **Appendix F-3: Consultation Advert and Poster (Doc Ref. 6.2)**) was emailed to relevant local authorities, parish councils, MPs, the Project CLP, community groups and other interested parties on 17 and 18 October 2022 for them to print out and display in their offices. The poster provided a link to the Project website where the consultation documents could be viewed and set out the details of the local information events and public presentation.



Consultation Advert

5.5.10 A consultation advert (see **Appendix F-3: Consultation Advert and Poster (Doc Ref. 6.2)**) was placed in the Kentish Express (Ashford and District) on 20 October 2022, containing similar information as that set out in the consultation poster described above.

Consultation Notice

5.5.11 A copy of the section 48 notice (see Part C: Section 48 Publicity below) was displayed at the Site during the consultation period (see **Appendix E-3: Site Notices for 2022 Statutory Consultation (Doc Ref. 6.2)**), which provided details of the consultation.

Emails to parish councils and others interested consultees

- 5.5.12 An email (see a sample email in **Appendix D-2: Emails to Community Organisations 2022 Statutory Consultation (Doc Ref. 6.2)**) was sent on 17 and 18 October 2022 to the relevant local authorities, ten parish councils, MPs, the Project CLP, community groups and other interested consultees who registered for Project updates on the Project website. Six of the parish councils who received the email are the relevant parish councils under section 42 of the PA 2008.
- 5.5.13 The email notified the parish councils and the interested consultees of the commencement of the 2022 Statutory Consultation and provided information about the local information events and the public presentation, and included a copy of the Community Information Leaflet.

- 5.5.16 A range of online and offline communication methods was used to engage a wide number of people in the consultation process, as explained throughout this section.
- 5.5.17 The Consultation Booklet (see Appendix F-1: Consultation Information Pack (Doc Ref. 6.2)) was written in an easy to understand, plain English style. A Non-Technical Summary of the PEIR (see Appendix F-1: Consultation Information Pack (Doc Ref. 6.2)) was provided in non-technical language to summarise the findings of the PEIR. The feedback form (see Appendix F-1: Consultation



- **Information Pack (Doc Ref. 6.2)**) was designed in an easy to use format that provided structure for consultees whilst ensuring that they had the opportunity to provide any other comments they might have about the Project.
- 5.5.18 A Freephone number, staffed by the Applicant's community relations team, was available throughout the 2022 Statutory Consultation period. The Applicant received one request for a telephone surgery, which took place on 15 November 2022. A Freepost service was also available for people to send feedback by post if desired.
- 5.5.19 Large print, audio or braille versions of the consultation documents were available upon request. One request for a large print copy of a technical report was received by the Applicant, which was sent out on 17 November 2022.

Social Media

- 5.5.20 In advance of and during the consultation period, updates about the consultation were posted on the Project's Twitter feed @SGS solar
- 5.5.21 The Applicant also advertised the consultation on Twitter and Facebook. Combined data from Twitter and Facebook show over 40,000 people saw the posts about the consultation.
- 5.6 Part C: Section 48 Publicity

Introduction

5.6.1 The Applicant publicised the proposed application pursuant to section 48 of the PA 2008, in parallel with the section 42 and section 47 consultation.

Publication of section 48 notice

- 5.6.2 A copy of the notice published as part of the 2022 Statutory Consultation in accordance with section 48 of the PA 2008 is provided in **Appendix E-1: Section 48 Newspaper Notices for 2022 Statutory Consultation (Doc Ref. 6.2)**. - 5.7.1 In accordance with Regulation 8(1)(b) of the EIA Regulations, the Applicant notified the Secretary of State as part of its Scoping Report (see **ES Volume 4, Appendix 1.1: Scoping Report (Doc Ref. 5.4)**) submitted on 19 April 2022 that it proposed to provide an environmental statement in respect of the development.
- 5.7.2 In addition to the notification provided within the Scoping Report, notification was also provided in the section 46 letter sent to the Planning Inspectorate in advance of the 2022 Statutory Consultation.

Section 46

- 5.7.3 In accordance with section 46 of the PA 2008, the Applicant wrote to the Planning Inspectorate (on behalf of the Secretary of State) on 24 October 2022 in advance of section 42 consultation commencing on 25 October 2022. A copy of that letter is in and a copy of the Acknowledgment of s46 Notification dated 26 October 2022 is in Appendix C-4: Section 46 Notification and Acknowledgment for 2022 Statutory Consultation (Doc Ref. 6.2).
- 5.7.4 The letter provided details of where the consultation materials could be accessed and enclosed:

- 5.8 Part E: Responses to Consultation

Introduction

5.8.1 This section of the Report explains the level and nature of feedback received by the Applicant in response to the 2022 Statutory Consultation.

Number of consultation responses received



- 5.8.2 The Applicant treated all responses received on or before 29 November 2022 as relevant responses. Responses that were received after that deadline but with a postmark dated prior to that deadline were accepted up to 8 December 2022.
- 5.8.3 A total of 168 relevant responses were received to the Applicant's 2022 Statutory Consultation.
- 5.8.4 **Table 10** shows the breakdown of response types received during the consultation:

5.8.7 There was a technical error in the collection of data from the online feedback form. This meant online responses to Question 1b (a question seeking general views on solar as part of the UK energy mix and not a specific question in relation to the Project) were not received. The number of responses for that question listed above therefore only relates to the hard copy feedback form responses. To correct this, the same question was included again in the feedback form for the 2023 Statutory Consultation, and this issue was identified in the Consultation Booklet and section 48 notice published in support of the 2023 Statutory Consultation (see **Section 6** of this Report).

Consideration of responses

- 5.8.8 The information contained within the consultation responses was collated into a spreadsheet and categorised by consultee category and theme.
- 5.8.9 The Applicant then undertook a careful and thorough review of the consultation responses received in accordance with the relevant guidance, with consideration of how regard could be given to the responses.
- 5.8.10 Appendix F-5: Regard had to Section 42 Consultee Responses and Appendix F-6: Regard had to Section 47 and 48 Responses (Doc Ref. 6.2) include a table for each of the strands of consultation (section 42, section 47 and section 48):



- summarising the responses received by the Applicant, grouped into headline issues;
- explaining how the Applicant had regard to these responses;
- identifying whether changes were made to the Project as a result of the responses; and
- if no changes were made then an explanation of why not.

6 2023 Statutory Consultation

6.1 Consultation material

- 6.1.1 Information on the Project and further preliminary environmental information was published for the 2023 Statutory Consultation in the following documents (see Appendix G-1: 2023 Statutory Consultation Information Pack, Parts 1, 2 and 3 (Doc Ref. 6.2)):
 - A Consultation Booklet providing information about the updated proposals and the 2023 Statutory Consultation
 - A Book of Plans showing the Site location and the layout and landscape proposals
 - The PEIR (originally published as part of the 2022 Statutory Consultation)
 - The PEIR Addendum which updated the PEIR and included an updated non-technical summary
 - A 'You said, we did' document outlining responses to feedback received by that date
 - A consultation leaflet
 - The exhibition boards that were used at the local information events listed in Section 6.5.3 of this Report.
- 6.1.2 Together, these documents described the updated Project and Site, identified the Applicant as EPL 001 Limited (a subsidiary of Evolution Power Limited), explained the consultation process and set out how consultees could respond to the consultation.
- 6.1.3 These documents, together with SoCC 3, consultation leaflets/newsletters and the notice published under section 48 of the PA 2008, were available for inspection during the consultation period and until 1 August 2023 free of charge at the Deposit Locations listed in **Section 4.3.15** of this Report. A check was made of the Deposit Locations on 6 July 2023 to ensure there were sufficient copies of materials; no Deposit Locations needed to be replenished.
- 6.1.4 Electronic copies of the consultation documents were also available to download free of charge during the consultation period on the Project website at www.stonestreetgreensolar.co.uk under the tab labelled 'Consultation' then 'Statutory Consultation (Summer 2023)'.
- 6.1.5 A copy of the consultation documents was available for inspection at the local information events listed in **Section 6.5.3** of this Report.
- 6.1.6 The Applicant offered to provide a full set of consultation documents on a USB memory stick upon request free of charge and hard copies could be obtained upon



request at a cost of £500 per copy. The Applicant issued three USB copies of the consultation documents.

6.3 Part A: Section 42 Consultation

Introduction

6.3.1 The Applicant carried out statutory consultation with statutory consultees pursuant to section 42 of the PA 2008 as part of the 2023 Statutory Consultation between 12 June and 17 July 2023, in parallel with the section 47 consultation and section 48 publicity.

Identifying section 42 consultees

6.3.2 The sections below explain how the Applicant identified the consultees in each category under section 42 of the PA 2008. A full list of the section 42 consultees for the 2023 Statutory Consultation is provided at Appendix C-5: List of Section 42(1)(a) and (b) Consultees for 2023 Statutory Consultation and Appendix C-2: List of Section 42(1)(d) Consultees for Statutory Consultation (Doc Ref. 6.2).

Section 42(1)(a): such persons as may be prescribed

6.3.3 The Applicant used the same approach as set out in **Section 5.3** for identifying prescribed consultees.

Section 42(1)(aa): Marine Management Organisation

6.3.4 The Project would not affect, or be likely to affect, any of the areas specified in section 42(2) PA 2008. Therefore, the Applicant did not consult the Marine Management Organisation for the 2023 Statutory Consultation.



Section 42(1)(b): each local authority that is within section 43

6.3.5 The Applicant consulted the same local authorities within section 42(1)(b) of the PA 2008 for the purposes of the 2023 Statutory Consultation as it did for the 2022 Statutory Consultation as listed in **Section 5.3** of this Report.

Section 42(1)(c): Greater London Authority

6.3.6 As the Site is not within Greater London, the Applicant did not consult with the Greater London Authority for the 2023 Statutory Consultation.

Section 42(1)(d): each person who is within one or more of the categories set out in section 44

- 6.3.7 The Applicant used the same approach as set out in **Section 5.3** of this Report for identifying persons falling within the three categories set out in section 44 of the PA 2008.
- 6.3.8 A full list of persons falling within section 44 of the PA 2008 is included within the **Book of Reference (Doc Ref. 4.1)** submitted with the DCO Application.
- 6.4 Consultation activities
- 6.4.1 The consultation letters were sent to the section 42 consultees by registered post with the majority being posted on 8 June 2023 to arrive by the consultation launch on 12 June 2023. Due to delivery issues, a small number of letters were posted on 22 June 2023. See Appendix C-6: Sample Letters Sent to Section 42 Consultees for 2023 Statutory Consultation (Doc Ref. 6.2) for the sample letters. A follow up email attaching the letters was sent on 12 June and 22 June 2023 to consultees where the email address of the consultee was known.
- 6.4.2 The letters notified consultees about the launch of the consultation on 12 June 2023, identified where consultees could view the consultation material, explained how consultees could respond to the consultation and confirmed the deadline for receipt of consultation responses, being 17 July 2023. An extended deadline of 31 July 2023 was provided to those section 42 consultees whose letters were sent on 22 June 2023.
- 6.4.3 The letters provided a link to the Project website where all of the consultation documents for the 2023 Statutory Consultation could be downloaded and enclosed:
 - the section 48 notice;
 - the feedback form;
 - a plan showing the site location and preferred Order limits; and
 - (for section 42(1)(d) consultees) a land plan.
- 6.5 Part B: Section 47 Consultation

Introduction



6.5.1 The Applicant carried out statutory consultation with the local community pursuant to section 47 of the PA 2008 as part of the 2023 Statutory Consultation between 12 June and 17 July 2023, in parallel with the section 42 consultation and section 48 publicity.

Identifying the local community

6.5.2 The same consultation zones (being the Core Consultation Zone and Wider Consultation Zone) as described in **Section 5.4** of this Report were used for the 2023 Statutory Consultation.

Consultation activities

Events

- 6.5.3 Four local information events were held (open to all members of the public) to provide opportunities to view the consultation documents and speak with members of the Applicant's Project team. These were held at:
 - Sellindge Village Hall: Friday 23 June 2023, 2pm to 6pm
 - Mersham Village Hall: Saturday 24 June 2023, 11am to 3pm
 - Aldington Village Hall: Monday 26 June 2023, 3pm to 7pm
 - Bilsington Village Hall: Tuesday 27 June 2023, 1pm to 5pm
- 6.5.4 The exhibition boards used at these events (see Appendix G-3: 2023 Statutory Consultation Exhibition Boards and Screenshots of Project Website (Doc Ref. 6.2)) were available to download on the Project website during the consultation period.
- These events were publicised through the notice published under section 48 PA 2008 (see Appendix E-4: Site Notices for 2023 Statutory Consultation (Doc Ref. 6.2)), on the Project website and in the consultation leaflet, poster and advert (see Appendix G-2: 2023 Statutory Consultation Leaflet, Advert and Poster and Appendix G-3: 2023 Statutory Consultation Exhibition Boards and Screenshots of Project Website (Doc Ref. 6.2)) (see below).
- 6.5.6 A total of 90 people attended the local information events.

Website

6.5.7 The Project website was kept up to date for the duration of the 2023 Statutory Consultation. It continued to host the consultation information after consultation closed for reference purposes (see Figure 4).

6.5.8 A consultation leaflet (see **Appendix G-2: 2023 Statutory Consultation Leaflet, Advert and Poster (Doc Ref. 6.2))** was sent to over 2,200 homes and businesses within the Core Consultation Zone on 5 June 2023. This provided details of the 2023 Statutory Consultation, including where and when the consultation documents could be accessed and how and by what deadline any responses could be submitted.

A Non-Technical Summary of the PEIR Addendum (see Appendix G-1: 2023 Statutory Consultation Information Pack, Part 3 (Doc Ref. 6.2)) was provided written in non-technical language to summarise the findings of the PEIR as updated by the PEIR Addendum. The feedback form (see Appendix



- G-1: 2023 Statutory Consultation Information Pack, Part 1 (Doc Ref. 6.2)) was designed in an easy to use format that provided structure for consultees whilst ensuring that they had the opportunity to provide any other comments they might have about the Project.
- 6.5.18 Emails were sent to a number of hard to reach groups (agreed with ABC) informing them of the consultation on 17 October 2022, with an invitation to the public presentation and an offer to answer any questions they may have. The groups sent this email included the following: Action with Communities in Rural Kent (subsequently closed), The Sedgwick Godfrey Trust, Kent Community Energy and Kent Community Foundation.
- 6.5.19 Further information about how potential effects on equality of the construction, operation and decommissioning of the Project is in the **Equalities Statement (Doc Ref. 7.18)**.
- 6.5.20 A Freephone number, staffed by the Applicant's community relations team, was available throughout the 2023 Statutory Consultation period. The Applicant did not receive any requests for a telephone surgery. A Freepost service was also available for people to send feedback by post if desired.
- 6.5.21 Large print, audio or braille versions of the consultation documents were available upon request. No requests for large print copies of technical reports were received by the Applicant.

Social Media

- 6.5.22 In advance of and during the 2023 Statutory Consultation period, updates about the consultation were posted on the Project's Twitter feed @SGS_solar
- 6.5.23 A social media advertising campaign was run on Twitter and Facebook throughout the five weeks of the consultation. This resulted in over 40,000 views and 1,422 link clicks to the Project website.
- 6.6 Part C: Section 48 Publicity

Introduction

6.6.1 As part of the 2023 Statutory Consultation, the Applicant publicised the proposed application pursuant to section 48 of the PA 2008, in parallel with the section 42 and section 47 consultation.

- 6.8.1 As mentioned in **Section 5.7.1** of this Report, the Applicant notified the Secretary of State as part of its Scoping Report (see **ES Volume 4, Appendix 1.1: Scoping Report (Doc Ref. 5.4)**) submitted on 19 April 2022 that it proposed to provide an environmental statement in respect of the development.
- 6.8.2 In addition to the notification provided within the Scoping Report, notification was also provided in the section 46 letter sent to the Planning Inspectorate in advance of the 2023 Statutory Consultation.

Section 46

- 6.8.3 In accordance with section 46 of the PA 2008, the Applicant wrote to the Planning Inspectorate (on behalf of the Secretary of State) on 8 June 2023 in advance of section 42 consultation commencing on 12 June 2023. A copy of that letter and a copy of the Acknowledgment of s46 Notification dated 12 June 2023 is in Appendix C-7: Section 46 Notification and Acknowledgment for 2023 Statutory Consultation (Doc Ref. 6.2).
- 6.8.4 The letter provided details of where the consultation materials could be accessed and enclosed:



- sample covering letters sent to the section 42 consultees;
- the section 48 notice;
- the feedback form;
- a plan showing the site location and preferred Order limits; and
- a sample land plan.

6.9 Part E: Responses to Consultation

Introduction

6.9.1 This section of the report explains the level and nature of feedback received by the Applicant in response to the 2023 Statutory Consultation.

Number of consultation responses received

- 6.9.2 The Applicant treated responses received on or before 17 July 2023 as relevant responses. Responses that were received after that deadline but with a postmark dated prior to that deadline were accepted up to 31 July 2023.
- 6.9.3 For the small number of section 42 consultees who were given an extended deadline by exception, responses received on or before 31 July 2023 were treated as relevant responses. Responses that were received after that deadline but with a postmark dated prior to that deadline were accepted up to 14 August 2023. A late response received from Dover District Council on 12 October 2023 was also accepted.
- 6.9.4 A total of 101 relevant responses were received to the 2023 Statutory Consultation.

6.12 Part F: Changes to land interests and prescribed consultees

Introduction

6.12.1 This section of the report explains the consultation undertaken by the Applicant to address the identification of new land interests and prescribed consultees after the 2023 Statutory Consultation ended.

Guidance and advice

- 6.12.2 Paragraph 24 of the Planning Act 2008: Pre-application stage for Nationally Significant Infrastructure Projects' guidance (April 2024)⁸ states that: 'land interests can change over time and new or additional interests may emerge after an applicant has concluded statutory consultation but just before an application is submitted. In such a situation, the applicant should provide a proportionate opportunity to any new person identified with a land interest to make their views known on the application.'
- 6.12.3 Paragraph 3.13 of the Planning Inspectorate's Advice Note 'Fourteen: Compiling the Consultation Report' (February 2021) states: 'If additional persons with an interest in land were added and consulted following changes to the project boundary during the Pre-application stage, it is useful to describe:

How many additional persons with an interest in land were consulted;



when they were consulted;

how they were consulted; and

what information they were consulted with.'

New land interests

- 6.12.4 New persons with an interest in land within the Site boundary were identified by the Applicant after the 2023 Statutory Consultation ended. In accordance with the guidance, the Applicant therefore sent those persons (see Appendix K-1: List of Consultees (Doc Ref. 6.2) for a list of the consultees) letters inviting them to comment on the Project (see Appendix K-2: Sample Letter and Enclosures to New Land Interests and Prescribed Consultees (Doc Ref. 6.2) for a sample letter). The letters provided details about the Project, explained where copies of the previous consultation materials could be located and gave those consultees the opportunity to submit comments to the Applicant by a deadline that was at least 28 days beginning with the day after the day on which the consultees received the consultation documents.
- 6.12.5 Comments could be submitted by:

 - telephone (free of charge) at 08081 698335

Canal and River Trust

- 6.12.6 The Applicant did not consult the Canal and River Trust as part of the 2022 Statutory Consultation or 2023 Statutory Consultation on the basis that the Project was thought not likely to impact an inland waterway or land adjacent to an inland waterway, as the absence of a right to navigation over the part of the East Stour River that runs through and adjacent to the Site means that it cannot be used as a waterway for river transport.
- 6.12.7 However, after the 2023 Statutory Consultation ended the Applicant decided, adopting a highly precautionary approach, to consult the Canal and River Trust on the Project. Therefore, on 20 February 2024, the Applicant sent a letter to the Canal and River Trust inviting them to comment on the Project (see **Appendix K-2: Sample Letter and Enclosures to New Land Interests and Prescribed Consultees (Doc Ref. 6.2)** for a copy of the letter). On the same date, the Canal and River Trust responded to the Applicant by email to confirm that 'the Trust do not own or manage and land or waterspace in the vicinity of this project, so have no comments to make.'

NHS Kent and Medway Integrated Care Board

6.12.8 As part of the section 42 consultation undertaken during the 2022 Statutory Consultation and 2023 Statutory Consultation, the Applicant consulted NHS Kent



- and Medway as the relevant integrated care board. However, after the consultation ended, the Applicant double checked its records and noted that it had consulted NHS Kent and Medway using its previous name the Kent and Medway Clinical Commissioning Group.
- 6.12.9 On 20 February 2024, the Applicant therefore reissued NHS Kent and Medway with a corrected letter which referred to the Integrated Care Board ('ICB') (see **Appendix K-2: Sample Letter and Enclosures to New Land Interests and Prescribed Consultees (Doc Ref. 6.2)** for a copy of the letter). On the same date, NHS Kent and Medway responded to the Applicant by email to 'confirm that NHS Kent and Medway has no objections to the proposed development'.

Responses

6.12.10 In addition to the responses above received from the Canal and River Trust and NHS Kent and Medway ICB, two responses were received from the new persons with an interest in the land. This included one response returning a land interest questionnaire form and one response querying the land of interest and where access would be required. Table 17 shows the breakdown of response types received:

- 6.12.11 The Applicant had regard to these four responses above in the following way:
 - Canal and River Trust The Applicant noted the response from the Canal and River Trust and noted that they do not own or manage any land or waterspace in the vicinity of this Project;
 - NHS Kent and Medway Integrated Care Board The Applicant noted that this Care Board do have not have any objections to the Project;
 - Person with an interest in the land who returned land interest questionnaire form – The Applicant recorded these details in the Project's land referencing database; and
 - Person with an interest in the land with a query about the land of interest and where access is required – The Applicant confirmed with the consultee



the affected land and the proposed access arrangements. The consultee did not respond further.



7 Non-Statutory Engagement

7.1 Overview of non-statutory engagement

7.1.1 In addition to the stages of non-statutory and statutory consultation set out above, the Applicant also undertook non-statutory engagement through newsletters, CLP meetings and meetings/briefings with stakeholders.

7.2 Newsletters

- 7.2.1 The Applicant sent a newsletter on 22 June 2022 to homes and businesses in the Core Consultation Zone along with consultees who had registered for Project updates (see **Appendix I-2: June 2022 Newsletter (Doc Ref. 6.2)**). The newsletter contained an overview of the feedback from the 2022 Non-Statutory Consultation and an update on the Project.
- 7.2.2 The Applicant also sent a newsletter during the week beginning 20 November 2023 to homes and businesses in the Core Consultation Zone along with consultees who had registered for project updates (**Appendix I-3: November 2023 Newsletter (Doc Ref. 6.2)**). The newsletter contained an overview of the feedback from the 2023 Statutory Consultation and information on the next steps leading up to submission of the DCO Application.

7.3 Community Liaison Panel meetings

- 7.3.1 A CLP for the Project was set up in March 2022 and the first meeting took place in June 2022. As explained in the Terms of Reference for the CLP (see Appendix I-4: Community Liaison Panel Terms of Reference and Meeting Minutes (Doc Ref. 6.2)), the purpose of the CLP is to facilitate communication, share information and engage in balanced discussions about the DCO Application and its subsequent examination and to keep the local community informed about all pertinent aspects of the Project.
- 7.3.2 The CLP is Chaired by an Independent Chair and comprises representatives from each of:
 - the Applicant;
 - four local residents:
 - two representatives from Aldington and Bonnington Parish Council;
 - five local Borough Councillors (three from ABC and two from FHDC);
 - two local KCC Councillors; and
 - two representatives from local community groups.



- 7.3.3 To date, the meetings of the CLP have taken place on 9 June 2022, 11 August 2022, 7 February 2023, 15 June 2023 and 21 September 2023.
- 7.3.4 Key topics discussed at the meetings has included:
 - Clarification about the consultation process and relevant consultees
 - Questions and discussion about the proposed community benefit fund
 - Project updates by the Applicant
 - Discussion on biodiversity net gain
 - Questions about solar panel technology
 - Changes to the PRoWs
 - Traffic impacts
 - Visual impacts.
- 7.3.5 At the 21 September 2023 meeting it was agreed the next CLP meeting would be held post submission of the Application. CLP members have been updated regularly on EPL 001's progress with updates provided on 22 November 2023, 16 February 2024, 25 March 2024 and 22 April 2024.
- 7.3.6 CLP meeting minutes and attendees are in **Appendix I-4: Community Liaison**Panel Terms of Reference and Meeting Minutes (Doc Ref. 6.2).
- 7.4 Meetings/briefings with stakeholders
- 7.4.1 Throughout the pre-application stage, the Applicant has engaged with key stakeholders.
- 7.4.2 In advance of the launch of the 2022 Non-Statutory Consultation, the Applicant held a number of briefings to introduce the community and local stakeholders to the Project. A briefing pack was sent by email on 4 November 2021 containing an introductory leaflet, details of the Project and a link to the Project website. Elected members were emailed again on 23 March 2022 with details of the 2022 Non-Statutory Consultation.
- 7.4.3 **Table 18** summarises the non-statutory engagement undertaken before the 2022 Non-Statutory Consultation.

7.5 Consultation responses received outside of statutory consultation

- 7.5.1 On 31 January 2024, the Applicant received an Adequacy of Consultation Representation to the Secretary of State Report prepared by Aldington and Mersham Support Group. In the following weeks a further 15 responses were received from members of the public confirming their support of the report.
- 7.5.2 The Applicant also received a letter from Ashford Borough Council on 11 April 2024 which referenced a number of the points raised by the Aldington and Mersham Support Group.
- 7.5.3 Although these responses were received outside of statutory consultation, the Applicant had regard to the responses which is set out in **Appendix M: Regard had to Consultation Responses Received Outside of Statutory Consultation (Doc Ref. 6.2)**.



8 Targeted Consultation

8.1 Introduction

- 8.1.1 Following the end of the 2023 Statutory Consultation, the Applicant made a number of minor, localised amendments to the Site boundary as a result of feedback received from the consultation, ongoing design development and discussions with stakeholders. Targeted consultation was carried out in respect of these amendments.
- 8.1.2 The amendments that were the subject of the 2023 Targeted Consultation were:
 - Removal of the alternative Grid connection route: The 2023 Statutory Consultation scheme included a preferred grid connection route and an alternative grid connection route as alternative options for how the Project could connect to the existing Sellindge Substation. UKPN formally confirmed on 1 September 2023 that the grid connection for the Project could be directly into Sellindge Substation. As a result, the Applicant removed the alternative grid connection from the Site. This means that the Site no longer includes land within FHDC's boundary and so FHDC is no longer a host local authority.

Removal of land from the Order limits:

- Land in the western part of the Site containing agricultural buildings was removed from the Order limits as this land was no longer required for the Project; and
- The majority of the Sellindge Substation site was removed from the Order limits, and a small extension was added to the Order limits to the eastern side of the Substation, following further consultation with UKPN who confirmed the area required to allow the connection into Sellindge Substation.

Addition of land to the Order limits:

- The cable corridor route was widened following further input with UKPN regarding installation requirements.
- Additional land was added at Bank Farm to provide site access for the duration of the Project;
- The road verge along Goldwell Lane was included in the Order limits to provide a wider turning circle for construction vehicles, avoiding the need to remove vegetation for access purposes; and
- Part of the road and the road verge at Station Road was included in the Order limits to provide space for necessary visibility splays and to ensure the Project is compliant with UK road safety requirements.



- 8.1.3 The only amendment included in the 2024 Targeted Consultation was the additional of a small circa 7m² parcel of land to enable the proposed diversion of PRoW AE 454 to connect to the existing PRoW AE 474.
- 8.2 Relevant guidance
- 8.2.1 Paragraph 20 of the 'Planning Act 2008: Pre-application stage for Nationally Significant Infrastructure Projects' guidance (April 2024) states that:

'Once applicants have completed the consultation process set out in their SoCC, where a proposed application is amended in the light of responses to consultation then, unless those amendments materially and substantially change the proposed application or materially changes its effects as a whole, the amendments themselves should not trigger a need for further consultation. The amendments can be reported as part of the consultation report submitted with the application.

Only where the project taken as a whole changes very significantly, and to such a large degree that what is being taken forward is fundamentally different from what was previously consulted on, should re-consultation on the proposed application as a whole be considered.

For any material change to a part of the proposed application where the project as a whole is not fundamentally changed, for example in the case of linear aspects where new information leads to a new alignment for a particular section of the proposal, a bespoke and targeted approach to further consultation can be adopted, which can address the specific consultation obligations arising proportionately.'

- 8.2.2 Page 13 of SoCC 3 states that '...we may also decide to hold further rounds of statutory or non-statutory consultation, including targeted consultation with specific groups, where appropriate'.
- 8.3 Targeted consultation
- 8.3.1 In accordance with this guidance and SoCC 3, the Applicant undertook the 2023 Targeted Consultation between 13 November and 13 December 2023 and the 2024 Targeted Consultation between 12 February and 12 March 2024 under section 42 of the PA 2008. A targeted approach, rather than a full re-consultation, was considered to be appropriate given the minor, localised nature of the proposed changes.
- 8.3.2 Consultation was carried out with persons with an interest in the land that was directly affected by the proposed changes to the Order limits under section 42(1)(d) of the PA 2008. Diligent enquiry was undertaken in order to identify those persons with an interest in the land affected. The Applicant also consulted with section 42(1)(a) and (b) consultees who the Applicant considered would be interested in the proposed changes.
 - 2023 Targeted Consultation



- 8.3.3 A full list of the consultees for the 2023 Targeted Consultation is provided in **Appendix J-1: List of Consultees (Doc Ref. 6.2)**. All of these consultees had previously been consulted about the Project and no new interests were identified as a result of the proposed changes.
- 8.3.4 Letters were sent to the above consultees on 10 November 2023 by email (where known) and hard copy, with the hard copy to arrive by the consultation launch on 13 November 2023 (see **Appendix J-2: Sample Letter and Enclosures to Consultees (Doc Ref. 6.2)** for sample letters). The letters provided details of the proposed changes to the Order limits, by reference to the enclosed 'Proposed Project Changes Summary Note' (**Appendix J-2: Sample Letter and Enclosures to Consultees (Doc Ref. 6.2)**) and explained how the consultees could submit responses to the consultation to the Applicant by the deadline of 13 December 2023. For those persons with an interest in the affected land, a land plan identifying their interest was also enclosed.
- 8.3.5 At the end of the consultation, the Applicant received a 'return to sender' of the hard copy letter that had been sent to Aldington and Bonnington Parish Council. However, the letter had been emailed to Aldington and Bonnington Parish Council on 10 November 2023 and a consultation response had been received from the council before the end of the consultation period.
- 8.3.6 In February 2024, it was identified that the hard copy letter sent to the River Stour (Kent) Internal Drainage Board ('IDB') on 10 November 2023 was sent to an incorrect address. The Applicant therefore provided a hard copy letter to the correct address of the IDB in March 2024 informing them of the consultation and requesting a response. The IDB confirmed by email on 27 March 2024 that it had no further comments to make at this stage and that its previously comments can be dealt with at the detail design stage.

9 Conclusion

- 9.1.1 As explained throughout this Report, the Applicant carried out comprehensive preapplication consultation on its proposals prior to submitting the DCO Application, including a five-week non-statutory consultation, two five-week statutory consultations and two four-week targeted consultations. The pre-application statutory consultation accorded with the requirements of the PA 2008, the APFP Regulations and the EIA Regulations and had regard to guidance issued under section 50(3) of the PA 2008. In addition, the Applicant undertook non-statutory engagement throughout the pre-application stage.
- 9.1.2 The Applicant consulted in a variety of ways to maximise consultee participation. A large number of consultees provided feedback and the Applicant is grateful to all those who took the time to engage in the consultation process.
- 9.1.3 The Applicant had careful regard to the consultation responses received as it has finalised this application for the Project, as explained in detail in this report and Appendix A-3: Regard had to 2022 Non-Statutory Consultation Feedback, Appendix F-5: Regard had to Section 42 Consultee Responses, Appendix G-4: Regard had to Section 42 Consultee Responses, Appendix G-5: Regard had to Section 47 and 48 Responses, Appendix J-3: Regard had to 2023 Targeted Consultation Consultee Responses, Appendix L-3: Regard had to 2024 Targeted Consultation Consultee Responses and Appendix M: Regard had to Consultation Responses Received Outside of Statutory Consultation (Doc Ref. 6.2).
