

### 1. Introduction

Evolution Power Limited¹ (Evolution Power) is intending to develop a renewable energy generating project, including solar photovoltaic (PV) arrays and on-site energy storage, together with associated infrastructure and an underground cable connection, on land at Aldington near Ashford in Kent, to be known as Stonestreet Green Solar (the project). Evolution Power welcomes your views on our proposals for Stonestreet Green Solar.

### 2. The purpose of community consultation and this SoCC

This Statement of Community Consultation (SoCC) explains how Evolution Power intends to consult with you on our proposals for Stonestreet Green Solar in accordance with Section 47 of the Planning Act 2008 before we submit an application for development consent for the project.

This SoCC explains how we have identified who to consult, the consultation methods proposed, the timescales for consultation and how consultees can help shape the project.

The publication of this SoCC is being advertised in local newspapers and is available on the project website (<a href="www.stonestreetgreensolar.co.uk">www.stonestreetgreensolar.co.uk</a>) and at the Deposit Locations listed on page 15 of this document.

Evolution Power will carry out consultation with the local community in accordance with this SoCC. We recognise that local people have a vital role to play at the pre-application stage and that carrying out consultation on the project with the local community will help to inform the development of our proposals. The pre-application consultation provides the opportunity for the local community to engage with and comment on the project as the project plans evolve. We want to listen to your views and work with you to develop our proposals for Stonestreet Green Solar. This will allow us to develop our plans responsibly and in a manner that supports local community and national objectives.

We will use the feedback that we receive during the consultation to help us develop our final proposals for Stonestreet Green Solar before submitting our application.

### 3. About Evolution Power

Evolution Power is a UK-based, independent solar developer. The company aims to develop affordable and sustainable renewable energy projects to help the UK meet its legally binding 2050 net zero emissions target. Evolution Power's ambition is to develop innovative, renewable energy projects in the 'right' way. Evolution Power carefully selects sites to minimise local impact and targets sites where it has identified potential opportunities to provide energy to local customers to maximise sustainability, environmental and social outcomes.

Our aim is to work with local communities, maximising opportunities for community participation and providing meaningful community benefits.

### 4. The planning process

As the proposed generating capacity exceeds 50 megawatts (MW), Stonestreet Green Solar is classified as a Nationally Significant Infrastructure Project (NSIP) under Sections 14(1)(a) and 15(1) and (2) of the Planning Act 2008. Our project must therefore apply for a Development Consent Order (DCO) through the Planning Act 2008 process. Consent for the solar PV arrays, on-site energy storage, associated infrastructure and underground cable connection will be included in the DCO if granted.

The DCO application will be submitted to the Planning Inspectorate (PINS), the agency responsible for managing the examination process for NSIPs. If accepted, the application will be examined by an independent Examining Authority at PINS who will review the application and may ask written questions and hold hearings during the examination. Throughout the examination, interested parties (including members of the local community who submit a relevant representation form to PINS) will be entitled to participate in the examination. The Examining Authority will then prepare a detailed report and make a recommendation to the Secretary of State (SoS) for Business, Energy and Industrial Strategy. The SoS will then make a decision on whether to grant a DCO for the project.

Before PINS will accept the application, we must demonstrate that pre-application consultation has been undertaken. Consultation must be carried out with statutory consultees under Section 42 of the Planning Act 2008 and the local community under Section 47 of the Planning Act 2008. The proposed application must also be publicised under Section 48 of the Planning Act 2008. Before carrying out consultation under Section 47 we are required to prepare and publish a SoCC to explain how we will consult the local community. Consultation with statutory consultees under Section 42 and publicity under Section 48 are outside the scope of this SoCC but will be undertaken in accordance with the Planning Act 2008 and will be reported in the Consultation Report submitted as part of our DCO application.

### 5. The project

The project will be located approximately 2.4km to the south-east of Ashford and approximately 13.7km to the west of Folkestone Town Centre, in the county of Kent. It is situated on approximately 189 hectares (467 acres) of land to the north and west of the village of Aldington. Figure 1 below provides an indicative site location.

The proposed development comprises the proposed construction, operation and maintenance, and decommissioning of a renewable energy generating project. The proposed development will include solar PV arrays and on-site energy storage, together with associated infrastructure and an underground cable connection to the existing National Grid Substation at Sellindge. The development will be split between various parcels of land which will minimise any visual impact.

The proposed development will in summary include the following key infrastructure:

- · Solar PV modules;
- PV module mounting structures:
- On-site electrical stations including inverters/switchgear and transformers;
- On-site and grid connection cabling with a maximum voltage of 132 kilovolts;
- Project substation, including high voltage switchgear and control equipment;
- · An energy storage system;
- A spare parts storage building or enclosure;
- · Boundary fencing and closed-circuit television security measures; and
- · Access tracks.

There are currently two options under consideration for the proposed grid connection arrangement: a Preferred Option and an Alternative Option. The indicative site location plan at Figure 1 includes the land required to deliver both options. The Preferred Option would connect directly to the existing Sellindge Substation. The Alternative Option would instead connect to the existing Sellindge Substation via an existing nearby tower. As shown on Figure 1, the Alternative Option requires additional land, of which approximately 340m of cable route and 500m of access track would be located within the administrative boundary of Folkestone and Hythe District Council. If this additional land is not required, which is Evolution Power's preference, the application site would lie entirely within the administrative boundaries of Ashford Borough Council and Kent County Council. The exact point of connection for the project is subject to final confirmation from UK Power Networks. This will be confirmed prior to the submission of the DCO application, and the Order Limits will reflect this.

The energy storage will be provided by batteries installed on the site – these will either be located in a large single compound or distributed throughout the site, depending on the technical approach in relation to charging. This will be determined prior to the DCO application being submitted.





Stonestreet Green Solar will provide a range of benefits including:

- The project will export up to 99.9MW of clean, renewable electricity, contributing to the UK's 2050 net-zero target.
- This renewable energy generated will be sufficient to power around 48,000 homes, saving around 37,000 tonnes of CO2 per annum.
- The project will include energy storage on-site, which will enable the storage, import and export of electricity to and from the grid.
- The project will generate subsidy-free electricity, without public financial support.
- The project will provide an inflation-linked community benefit fund for the lifetime of the project to be used locally for social and environmental projects.
- During the lifetime of the project, the biodiversity of the site will be greatly enhanced and the soil condition will be improved.

### 6. Who will we consult?

In accordance with this SoCC, we will consult with the local communities in the vicinity of the land to which the proposed DCO application relates. We also welcome feedback from anyone who may be interested in or in any way feel impacted by our proposals for Stonestreet Green Solar.

People can register their interest at our project website (www.stonestreetgreensolar.co.uk – use the 'Contact Us' tab) to receive regular updates on the project.

We will also consult relevant parish and town councils, area committees, community groups, organisations representing local businesses, communities and tourist boards. In addition, we will also be consulting on our proposed project with a range of other statutory and non-statutory consultees.




Figure 2: Core Consultation Zone Map

### Core Consultation Zone (see Figure 2)

A core consultation zone has been defined to cover a 4km radius from the centre of the site. The zone centres on the proposed development site in Aldington and extends outwards to include the nearby surrounding villages of Bilsington, Bonnington, Brabourne Lees, Kingsnorth, Mersham and Smeeth. All elements of the project (as described in Section 5 of this SoCC) will be located within this core consultation zone. Residents and businesses within the core consultation zone will receive our leaflets and newsletters directly.

### Wider Consultation Zone (see Figure 3)

Evolution Power recognises that there will be some people who do not live within the core consultation zone but are nevertheless interested in our proposals. We want to ensure that these people are aware of our proposals and the opportunities to get involved. Therefore, we will use tools such as media relations and advertising to notify residents and businesses within a wider consultation zone about the consultation, covering a 10km radius from the site.

Together, the core consultation zone and the wider consultation zone comprise our consultation area.

Evolution Power will be visiting areas within the consultation area throughout the development of the proposals to meet with communities, provide information and listen to feedback on the proposals.

### 7. What will we consult on?

We will be seeking feedback on all aspects of our plans for Stonestreet Green Solar. We will encourage the local communities to give their views about how our proposals may affect them or their area. For example, we will be seeking feedback to help develop our proposals regarding impacts such as, but not limited to:

- Short term, temporary construction impacts, such as upon wildlife and local residents.
- Long term, operational impacts, such as upon wildlife, landscape and views.
- Benefits, such as contributing towards low carbon energy production and providing security of energy supply.

More information will be available regarding technical aspects of the project as our proposals develop, which will be provided as part of our consultation material.

### 8. Environmental information

In accordance with Regulation 12 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017, we confirm that the Stonestreet Green Solar development is an Environmental Impact Assessment (EIA) development as defined in those regulations and that we intend to publicise and consult on preliminary environmental information. We will be undertaking an EIA for Stonestreet Green Solar in accordance with Regulation 5 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017, including the preparation of an Environmental Statement (ES).

### Scoping

We will be seeking a Scoping Opinion from PINS (on behalf of the SoS) on the scope and level of detail of the information to be provided in the ES. Our request for that Scoping Opinion will include a Scoping Report that will describe the project and explain our initial analysis of the anticipated likely significant environmental effects and the scope of technical assessment required. PINS will seek feedback on this from consultation bodies before issuing a Scoping Opinion. A copy of the Scoping Report and the Scoping Opinion will be made available on the PINS project website (<a href="https://infrastructure.planninginspectorate.gov.uk/projects/south-east/stonestreet-green-solar/">https://infrastructure.planninginspectorate.gov.uk/projects/south-east/stonestreet-green-solar/</a>) and on the project website (<a href="https://www.stonestreetgreensolar.co.uk">www.stonestreetgreensolar.co.uk</a>).

### **Preliminary Environmental Information Report (PEIR)**

Following the publication of the Scoping Opinion, a PEIR will be produced which will provide an initial statement of the environmental information compiled by Evolution Power for the Stonestreet Green Solar study area. The PEIR will build upon findings from the Scoping Report. It will incorporate the findings of the surveys and initial assessments and will enable consultees to develop an informed view of any likely significant environmental effects of the





development. We will be seeking feedback from the local communities and other stakeholders on the PEIR.

### **Environmental Statement (ES)**

The ES will advance the content of the PEIR and incorporate the responses from the consultation and results of the surveys undertaken. It will also describe any changes made to the project and any mitigation measures that need to be implemented. The ES will form part of the DCO application.

Details of when the Scoping Report, Scoping Opinion, PEIR and ES are expected to be published can be found in Section 10 of this SoCC, which displays the indicative consultation timeline.

### 9. The consultation process

The consultation process for Stonestreet Green Solar will be an iterative one as the design of the project develops in response to the consultation. The following consultation process shapes the indicative consultation timeline, as presented in Section 10 of this SoCC.

### Stakeholder briefings – Spring 2022

Following publication of this SoCC, we will introduce community members to our proposals for Stonestreet Green Solar. This will include initial meetings with members of the community and stakeholders.

### Non-Statutory Consultation - Spring 2022

Local information events will take place in spring 2022. These will provide interested members of the local community with the opportunity to view the initial proposals and submit feedback. A consultation leaflet will also be delivered to all residents and businesses within the core consultation zone. The feedback received to this non-statutory consultation will help shape the proposals for Stonestreet Green Solar.

### Statutory Consultation – Summer 2022

Local information events and further consultation are expected to take place in summer 2022 and will run for at least 28 days. This statutory consultation, in accordance with Section 47 of the Planning Act 2008, will allow us to update you on the project development, allow you to provide formal comments and also feedback on the PEIR, as described in Section 8 of this SoCC. More specific details of the consultation will be publicised through adverts in the local press, via newsletters to residents and businesses in the core consultation zone, via email to local parish councils, via the project Twitter feed and via the project website, in advance of the consultation starting. Notices about the statutory consultation will be placed in local and national newspapers and at the site in accordance with the Planning Act 2008.





### **Ongoing engagement**

Anyone interested in our proposals is welcome to get in touch with us at any time during the pre-application process. Our contact details are listed at the end of this SoCC. We will consider the feedback and comments we receive on an ongoing basis. You will also have the opportunity to comment on our proposals for the project when the DCO application is submitted to PINS.

In addition to the above, we may also decide to hold further rounds of statutory or non-statutory consultation, including targeted consultation with specific groups, where appropriate.

### 11. How will we consult with you?

### Face-to-face

Our pre-application consultation will include two rounds of local information events which are open to all interested members of the public. Attendees will have the opportunity to view informative materials about the project, discuss the proposals with members of the team and provide their feedback on the proposals. A copy of this SoCC will be made available at these events.

All the materials available at the local information events will also be made available to view on the project website in case people are unable to attend in person.

If social distancing measures, or other restrictions resulting from the Covid-19 pandemic, are in place at the time of the consultation, virtual exhibitions will be held instead, details of which will be communicated to residents using the methods set out in Section 9 of this SoCC. Virtual events allow people to participate in the consultation from remote locations (such as their

home or office) using technology (such as a smart phone or laptop computer). Virtual events are held on the same basis and are subject to the same provisions of the Planning Act 2008 as physical events.

Following the statutory consultation, we will carefully consider all the responses that we receive and have regard to this in finalising our proposals for the Stonestreet Green Solar project, ahead of submitting our DCO application. Our DCO application will include a

- · describe our consultation process;

- detail how we worked with the local planning authority to ensure our consultation was suitable for your area;
- provide a summary of all consultation responses (from the local communities, statutory and non-statutory consultees and the general public);
- describe any changes we have made to our application as a result of what you told us;
   and
- explain why, if any, changes were not made to the application that you told us needed changing.

We will ensure that the Consultation Report complies with data protection legislation including that personal data of individuals is treated appropriately. Evolution Power may be asked to provide a copy to PINS of any or all of the statutory consultation responses that were received and we will ensure that we comply with any applicable obligations under data protection legislation.

"However, the design leaves a lot to be desired."



The effect of the Order is:-

- b) all of the slip and link roads leading to and from the carriageways in a) above at Park Farm Interchange (A2042) and Sevington Roundabout;
  c) all of the side roads at junction with the carriageways in a) above;
- the gap in the central reservation at the junction of the carriageways in a) above with Church Road (thereby preventing right turns into Church Road); and
- the cvcle tracks i) adjacent to the westbound carriageway of the A2070 between Waterbrook
- Avenue and Avocet Way; and ii) adjacent to the eastbound carriageway of the A2070 between a point opposite Avocet Way and the northbound carriageway of the Boulevard;
- 2) to impose, over 24-hour periods, a mandatory 40 mph speed restriction on:a) the eastbound carriageway of the A2042 and A2070 between Flanders Field
- Roundabout (A2042) and the existing 50mph to 40 mph transition; the westbound carriageway of the A2070 between the existing 40mph to 50mph transition and its divergence from the off-slip at Park Farm Interchange (A2042);
- c) the northbound carriageway of Avocet Way between its junction with the A2070 and a point 60 metres south;
  d) both carriageways of Waterbrook Avenue between its junction with the A2070
- and a point 20 metres south; and
- the southbound carriageway of the Boulevard between its junction with the A2070 and a point 20 metres north; and
- 3) to operate a 24-hour contraflow alternately westbound and eastbound as required on either carriageway of the A2070 between a point approximately 220 metres east of the centreline of Park Farm Interchange underbridge and a point approximately 275 metres south-west of Sevington Roundabout.

Lane closures and carriageway closures under traffic light control will also be operated These measures are in the interests of road safety while contractors undertake junction vement works, to include the conversion of the Orbital Park Roundabout into

a signalised junction, and all associated works. It is expected that the work will last for approximately 6 months starting on or after

Monday 11th April 2022. The Order will come into force on 9th April 2022 and have a maximum duration of

eighteen months, ceasing when the works are complete. Traffic affected by the carriageway and slip closures will be diverted using the A28, A2042, A2070, North Street and Canterbury Road. Traffic wishing to join the westbound A2070 from Church Lane will be diverted using Cheesemans Green Lane, Finn Farm Road, Church Hill, and Ashford Road to join the A2042. Traffic affected by the Church Road right turn ban will continue northbound on the A2070 to Jet Roundabout and return. Light vehicles (only, owing to low bridges on route) affected by the closure of the Boulevard at junction with the roundabout/works will be diverted northbound on the Boulevard, Crowbridge Road, and Newtown Road to join the above carriageway diversion.

The cycle tracks will be closed alternately so pedestrian and cyclists will use the the other side of the road, or use a segregated area o carriageway as available.

The temporary closures, speed restrictions, contraflow, and diversion routes will be clearly indicated by traffic signs when they are in operation during the works period.
