1.1 Introduction

- 1.1.1.1 This document has been prepared in response to Section 51 advice from the Examining Authority in relation to the figures included in the Mona Offshore Wind Project DCO application. The point from the Section 51 advice is as follows:

Para 12.1 of the Application Letter (Doc A1) states that the proposed operational access to the existing National Grid Substation from the proposed Mona Substation access from Glascoed Road has been assessed in the Environmental Impact Assessment (EIA) but part of it is not currently shown on all the EIA figures.

The Inspectorate advises the Applicant to undertake a thorough audit of the ES figures to ensure that they are consistent with the Onshore Work Plan (Doc B3). Amended ES figures should be provided, together with a list of the figures subject to amendment.

1.2 Response

- 1.2.1.1 The Applicant has updated the figures of the Environmental Statement and other relevant application document figures as appropriate to show the proposed operational access to the existing National Grid Substation from the proposed Mona Substation access road. 




Figure 1.2: Figure 1.2 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.3: Figure 1.3 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).






Figure 1.6: Figure 1.6 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.8: Figure 1.8 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.9: Figure 1.9 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.10: Figure 1.10 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).






Figure 1.12: Figure 1.12 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).






Figure 1.14: Figure 1.14 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.15: Figure 1.15 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.16: Figure 1.16 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.17: Figure 1.17 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.18: Figure 1.18 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.19: Figure 1.19 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.20: Figure 1.20 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.21: Figure 1.21 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.22: Figure 1.22 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.23: Figure 1.23 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).






Figure 1.25: Figure 1.25 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.26: Figure 1.26 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.27: Figure 1.27 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.28: Figure 1.28 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.29: Figure 1.29 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.30: Figure 1.30 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).



Figure 1.31: Figure 1.31 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).






Figure 1.33: Figure 1.33 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.34: Figure 1.34 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.35: Figure 1.35 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).







Figure 1.37: Figure 1.37 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.39: Figure 1.39 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.41: Figure 1.41 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.42: Figure 1.42 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.43: Figure 1.43 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.44: Figure 1.44 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.45: Figure 1.45 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.46: Figure 1.46 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).






Figure 1.48: Figure 1.48 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).






Figure 1.50: Figure 1.50 of Volume 7, Annex 3.2: Extended Phase 1 habitat survey technical report (APP-122).




Figure 1.51: Figure 1.1 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).




Figure 1.52: Figure 1.2 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).






Figure 1.54: Figure 1.4 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).




Figure 1.55: Figure 1.5 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).




Figure 1.56: Figure 1.6 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).




Figure 1.57: Figure 1.7 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).




Figure 1.58: Figure 1.8 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).




Figure 1.59: Figure 1.9 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).




Figure 1.60: Figure 1.10 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).




Figure 1.61: Figure 1.11 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).




Figure 1.62: Figure 1.12 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).




Figure 1.63: Figure 1.13 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).







Figure 1.66: Figure 1.16 of Volume 7, Annex 3.3: Great Crested Newt Survey Technical Report (APP-123).




Figure 1.67: Figure 1.1 of Volume 7, Annex 3.4: Hedgerow survey technical report (APP-124).






Figure 1.69: Figure 1.3 of Volume 7, Annex 3.4: Hedgerow Regulations survey results (APP-124).




Figure 1.70: Figure 1.4 of Volume 7, Annex 3.4: Hedgerow Regulations survey results (APP-124).




Figure 1.71: Figure 1.5 of Volume 7, Annex 3.4: Hedgerow Regulations survey results (APP-124).




Figure 1.72: Figure 1.6 of Volume 7, Annex 3.4: Hedgerow Regulations survey results (APP-124).




Figure 1.73: Figure 1.7 of Volume 7, Annex 3.4: Hedgerow Regulations survey results (APP-124).




Figure 1.74: Figure 1.8 of Volume 7, Annex 3.4: Hedgerow Regulations survey results (APP-124).






Figure 1.76: Figure 1.10 of Volume 7, Annex 3.4: Hedgerow Regulations survey results (APP-124).




Figure 1.77: Figure 1.11 of Volume 7, Annex 3.4: Hedgerow Regulations survey results (APP-124).




Figure 1.78: Figure 1.12 of Volume 7, Annex 3.4: Hedgerow Regulations survey results (APP-124).




Figure 1.79: Figure 1.13 of Volume 7, Annex 3.4: Hedgerow Regulations survey results (APP-124).
