To whom it may concern.

I writing in relation to the Change 1(a and b): The amendment of the proposed Order limits to include an existing access track for temporary construction access during onshore site preparation works and a parcel of land to the west of the onshore substation for temporary construction access during onshore site preparation works and construction of the onshore substation and surrounding works. This involves the inclusion of two new plots of land (plots 11-197a and 11-197b) which would be subject to powers of temporary possession only.

As Highway Authority we have had no consultation on this to my knowledge.

I have the following concerns in relation to the following on a road which according to our records is adopted highway.

- The junction visibility.
- The carriageway width.
- The condition of the road.
- The drainage/ditches.
- The vehicle numbers and size proposed to use this road

Sorry for the lack of in depth information, but my time in responding has been limited, I would welcome a meeting to discuss the proposed use of this Highway and any further information you may have.
