Good afternoon,

In respect of the Hearing Action Point 2 arising from ISH6 held on 10 and 11 December, I would like to confirm on behalf of Denbighshire County Council highways authority that its previous objection to Change 1a to the DCO as requested by the Applicant is withdrawn and the proposal is now found acceptable pending submission of an updated CTMP. The Applicant and DCC Highways met on 12 December to discuss the concerns held by DCC as stated in its response to the change request consultation. This meeting was productive and a number of controls to be added to the outline CTMP were discussed. Having had sight of a draft updated version, with additional information on access AC-T1, the measures it secures are found acceptable and satisfactorily address the concerns previously raised. It is understood that the Applicant is to submit this updated document into Examination imminently.

We intend to provide an additional entry to the DCC Statement of Common Ground to further confirm this position in writing at Deadline 6, however we notify you at this stage in recognition that confirmation of the DCC highways position is important for the ongoing consideration of the ExA in relation to the change request.
