And that's going to start in 2025. So it's going to kind of sever an awful lot of public walking areas. And I go over there are an awful lot and I see lots of walkers. We have cyclist in the area because of all the bridal wares, and also horse riders. So we're going to have disruption from Northumbrian Water. So if this is agreed, and we're gonna get a large solar farm, you know, in the area as well, it's just gonna cause an absolute mayhem for residents. It's good for our public, our personal and physical health and mental health. And also the wildlife is very important. You know, the kind of river skirt and corridor is one of the most important biodiversity corridors in the area in the cutting country, the skirt and runs right through there. And that runs down into the tees. So it's a very well used area. And you don't need me to tell you that you care is one of the worst nature depleted countries in the world. So we need to protect as much as possible. On that side. Food security is very, very important. We only produce about 50% of the food that we're consuming, consuming. Sure. So taking out vast swathes of good food growing farmlands for 40 years plus I think is quite worrying. When when we look at what's going on in Europe at the moment and advice

kilowatts, you know, we're not going to be self sufficient. These actually six wind turbines not far from this area, it may warehouse farm, behind bumped and village. Now there's only six of them. And they actually produce 12,000 megawatts per year. Now this development taken out massive amounts of farmland is talking about 50 megawatts of power each year. So if 12 if six can produce 12, it's two megawatts per wind turbine. And I read on the internet, and I know you're not supposed to believe everything on the internet. But you know, wind turbines are more efficient than solar farms. And it did say one wind turbine would produce more electricity than seven football fields of solar farms. Now, if we got wind turbines in the area, because I'm all for renewable energy, it's very important that we become self sufficient and produce it. But why not look at wind turbines, you know, if we got 25 to 30, wind turbines in that area, the farmers could still find the one. The wildlife can roam freely. And also the residents still have access to some beautiful countryside, unable to do the near to nature watching. And that's me. Thank you very much.

So it shows how scenic the area is and how well it is used. And more importantly, it's a massive wildlife corridor. Because once we get over the river skorne It's just a vast array of, you know, wildlife areas, there's no roads apart from farm trucks. So to take all that out, is, you know, really going to be quite bad for four years. Yes, we will still have some walking routes, but walking alongside a two meter three meter security fence with CCTV cameras that follow your along isn't going to be the same as walking along hedgerows. And you know, seeing the wildlife be able to move freely. Country is that area.

I think we all accept that there are tolerances in the way reports can be written so that sometimes there may be couched in a way that the perhaps the peer Master is wanting. I'm going to speak from personal local, real knowledge, not arbitrary desktop studies.

In the last harvest we had in 2023.

53:30

I know from family and relatives and friends, that the average production of crops wheat in the fields around our area was over four tons per acre.

Now on a 759 acre site, that's almost 3000 tons of wheat lost on one installation. I'm bearing in mind, the problems we have in Ukraine and Europe that you know, food security is important. I am a fully aware that the government has an emphasis on food for security, food security, and also on net zero. But the left hand doesn't ever seem to be talking to the right hand.
