## 1. Introduction

#### **1.1.** Purpose of this document

- 1.1.1. This document sets out a suggested itinerary for an Accompanied Site Inspection (ASI) by the Examining Authority (ExA), as part of the Examination of the Byers Gill Solar Development Consent Order (DCO) application.
- 1.1.2. The itinerary has been prepared by RWE (the Applicant) in response to the request made by the ExA in Annex B of the Rule 8 Letter issued 30 July 2024 for an ASI in the week commencing 14 October 2024.

## 2. Suggested itinerary

#### 2.1. **Proposed route**

2.1.1. The suggested itinerary for the ASI is set out in Table 1. This is accompanied by a map representing the route and the stops in Appendix A.

#### 2.2. Notes about the proposed route

#### Start and finish point

2.2.1. The itinerary is designed to travel from Bishopton Village Hall, heading first east and then west, returning to Bishopton. On-street parking is available in Bishopton. Agreement is required from Bishopton Village Hall to use the facilities during the ASI.

#### Transport

- 2.2.2. It is proposed that a minibus is the most appropriate vehicle for the ASI. Spaces in the minibus for members of the public wishing to attend will be on a first-come, first-served basis. Once the vehicle is at capacity, attendees will be required to use their own vehicle to follow the itinerary.
- 2.2.3. There is limited parking at some of the proposed stop locations, should any parties in attendance choose to or are required to travel in their own vehicles.

#### Timings

2.2.4. The ExA will confirm the start and finish times of the ASI, however indicative durations for each stop (including travel from the previous point) are included in Table 1. The total expected duration of the ASI is approximately 8 hours and 10 minutes.

#### Plans and information

2.2.5. The Applicant will provide relevant plans as submitted as part of the DCO Application. This will be in either hard copy or electronic format and specific requirements can be determined in discussion with PINS nearer the time.

#### Attire

- 2.2.6. Attendees are advised to wear appropriate clothing, including sturdy footwear appropriate for walking on uneven or wet ground. Waterproof clothing should be worn in the event of inclement weather.
- 2.2.7. The Applicant will provide high-visibility jackets to be worn by attendees.

#### Lunch and comfort breaks

- 2.2.8. A lunch break at Bishopton Village Hall has been scheduled on the itinerary however the Applicant will not provide lunch, and attendees are advised to bring their own lunch and water.
- 2.2.9. Some limited facilities are available at the Tesco Extra, Durham Road, Stockton-on-Tees, which is approximately 5 minutes' drive from Carlton, the stop prior to the lunch break.
- 2.2.10. Two other comfort breaks are proposed, in the morning and afternoon, at Bishopton Village Hall.

#### Land access

2.2.11. Where private land access is required, this is detailed in Table 1. Landowner details will be provided once the final route is confirmed by the ExA. The Applicant will seek to make access arrangements with the landowners or occupiers, followed up by contact from the ExA. Every effort will be made to access land but depending on the landowner/occupier this may not be possible in all cases.

#### First aid facilities

2.2.12. There are no first aid facilities on site, however the intended attendees from RWE do include a First Aider. The nearest hospitals with accident and emergency facilities are University Hospital of North Tees in Stockton-on-Tees and Darlington Memorial Hospital in Darlington.

#### Key site hazards

- 2.2.13. The following key hazards have been identified:
  - The roads in the site vicinity are country lanes with some narrow sections and limited visibility;
  - Some land parcels to be visited are active farms;
  - The stopping points of the minibus may include areas of uneven ground and therefore care should be taken when stepping on and off the bus;
  - Some lay-bys to be used for parking have limited space to accommodate vehicles. The minibus will not stop in such locations unless it is safe to do so and use of hazard lights is advised;
  - Site visit attendees may be approached by members of the public and/or landowners when present on site; and
  - There is potential for poor or changeable weather conditions and attendees should be dressed appropriately for such risk.
