Following our Relevant Representation (RR) [RR-168] dated 17 May 2024, we had a meeting (12 June 2024) with the applicant and their consultants to address the issues raised.

Points 1-6 that we raised in our RR are still outstanding. However, the applicant has committed to resolving these issues.
