1. Introduction

1.1. Purpose of this document

- 1.1.1. This Statement of Commonality (SoC) sets out the current position on Statements of Common Ground (SoCG) between RWE (the Applicant) and prescribed consultees and other interested parties in relation to Byers Gill Solar (the Proposed Development). It also demonstrates points of commonality between the SoCGs.
- 1.1.2. It has been prepared by RWE for use by the Examining Authority (ExA) and will be updated throughout the Examination of the Byers Gill Solar Development Consent Order (DCO) application to reflect the current position of the SoCGs.
- 1.1.3. Prior to the submission of the DCO application, a Potential Main Issues for Examination (PMIE) document [APP-169] was submitted with the DCO application, this included a Principle Areas of Disagreement Summary Statement (PADSS) with Darlington Borough Council (DBC).
- 1.1.4. The Applicant had also engaged with the following parties pre-application regarding a PADSS, however at that time it was not considered necessary or appropriate to submit a draft PADSS as part of the application:
- Durham County Council (DCC)
 - Stockton-on-Tees Borough Council (SBC)
 - Natural England (NE)
 - Environment Agency (EA)
 - Historic England (HE)
- 1.1.5. The Rule 6 letter [PD-003] requested SoCGs with the parties listed in Table 3-1, alongside four Statutory Undertakers (National Grid, Network Rail, National Gas, Northern Powergrid). As per the Applicant's Response [PDA-001], the Applicant has prepared SoCGs with the requested parties, with the exception of these four Statutory Undertakers. The Applicant will continue to update the Statutory Undertakers Position Statement (Document Reference 7.7, Revision 2) to reflect the position with these bodies, as provided at this deadline (Deadline 2).
- 1.1.6. The Applicant will continue to engage with all stakeholder parties and update this SoC and the individual SoCGs throughout the Examination.

2. Structure of Statements of Common Ground

2.1.1. To ensure consistency in the approach taken to documenting matters agreed, those subject to further negotiation, or those not agreed, each SoCG follows a standard format.

2.1.2. The SoCGs have the following structure:

- Section 1 provides an introduction to the SoCG and a description of its purpose;
- Section 2 sets out the current position on different topics between the Applicant and the relevant party; and
- Appendix 1 details the record of engagement between the Applicant and the party.

3. List of Statements of Common Ground

- 3.1.1. The parties with which the Applicant has prepared an SoCG are listed in Table 3-1 below. The ExA requested the preparation of these SoCGs in the Rule 6 letter [PD-003].

4. Summary of current position

6. Current position

6.1.1. This section provides a summary of the current position between the Applicant and the other parties. The individual SoCGs provide full detail on specific matters.

6.2. Local authorities

Durham County Council

6.2.1. The Applicant issued a draft SoCG to Durham County Council (DCC) on 18 July 2024, taking into account the Relevant Representation from DCC [RR-144].

6.2.2. The principle matters that are anticipated to be discussed throughout the Examination, as listed in DCC's Relevant Representation [RR-144] and reflected in the draft SoCG (Document Reference 8.4.1) provided at Deadline 1, are:

- Landscape and visual effects;
- Cultural heritage and archaeology;
- Traffic and transport;
- Public Rights of Way (PRoW); and
- Flood risk and drainage.

6.2.3. The Applicant, following agreement with DCC, provided a draft SoCG (Document Reference 8.4.1) at Deadline 1. It should be noted that this does not reflect DCC's comments in their LIR [REP1-024 – REP1-025], and an updated draft SoCG which considers the comments raised will be provided at a future deadline.

Darlington Borough Council

6.2.4. The Applicant issued a draft SoCG to Darlington Borough Council (DBC) on 18 July 2024, taking into account the draft PADSS which was submitted with the application, and the Relevant Representation from DBC [RR-107].

6.2.5. The Applicant and DBC met on 19 August 2024 following receipt of DBC's LIR [REP1-021 – REP1-023]. It is the intention of both parties to provide a draft SoCG which considers the matters raised at a future deadline.

6.2.6. The principle matters that are anticipated to be discussed throughout the Examination, as listed in DBC's Relevant Representation [RR-107] are:

- Landscape and visual effects;
- Impact on living conditions in relation to noise, glint and glare and air quality;
- Biodiversity and arboriculture impacts;
- Impacts on the Public Rights of Way (PRoW) network;
- Traffic and transport;
- Flood risk and drainage; and

- Impacts on cultural heritage and archaeology.

Stockton-on-Tees Borough Council

- 6.2.7. The Applicant issued a draft SoCG to Stockton-on-Tees Borough Council (STBC) on 18 July 2024, taking into account the Relevant Representation from STBC [RR-498].
- 6.2.8. The principle matters that are anticipated to be discussed throughout the Examination, as listed in STBC's Relevant Representation [RR-498] are:
- Loss of Best and Most Versatile Land (BMV);
 - Landscape and visual effects;
 - Impact on living conditions in relation to noise, glint and glare and air quality;
 - Biodiversity and arboriculture impacts;
 - Traffic and transport;
 - Public Rights of Way (PRoW);
 - Flood risk and drainage;
 - Contamination and radon gases;
 - Cultural heritage and archaeology; and
 - Health and safety.
- 6.2.9. The Applicant, following agreement with STBC, provided a draft SoCG (Document Reference 8.4.3) at Deadline 1. It should be noted that this does not reflect STBC's comments in their LIR [REP1-026], and an updated draft SoCG which considers the comments raised will be provided at a future deadline.

6.3. Other interested parties

Tees Valley Combined Authority (TVCA)

- 6.3.1. The Applicant issued a draft SoCG to TVCA on 18 July 2024, taking into account the Relevant Representation from TVCA [RR-513].
- 6.3.2. All matters have been agreed between the parties. A final, signed SoCG has been submitted at Deadline 2 (Document Reference 8.4.4).

Historic England

- 6.3.3. The Applicant issued a draft SoCG to Historic England on 18 July 2024, taking into account the Relevant Representation from TVCA [RR-207].
- 6.3.4. The Applicant, following agreement with Historic England, has provided the draft SoCG (Document Reference 8.4.5) at Deadline 1.

- 6.3.5. It is noted that the draft SoCG provided at Deadline 1 presents the view that all matters discussed to date are agreed. It is the intention of both parties to provide a signed, final copy of the SoCG at a future deadline.

Environment Agency

- 6.3.6. The Applicant issued a draft SoCG to the Environment Agency (EA) on 18 July 2024, taking into account the Relevant Representation from the EA [RR-168].
- 6.3.7. The EA returned comments on the draft SoCG to the Applicant on 7 August 2024, which has not been submitted into the Examination at this time.
- 6.3.8. The EA and the Applicant are continuing to discuss the matter below, and will provide an update at a future deadline.
- 6.3.9. The principle matter to be discussed throughout the Examination is in relation to the assessment of flood risk, including application of the Sequential Test.

National Highways

- 6.3.10. The Applicant issued a draft SoCG to National Highways on 18 July 2024, taking into account the Relevant Representation from National Highways [AS-009].
- 6.3.11. All matters have been agreed between the parties. A final, signed SoCG has been submitted at Deadline 1 (Document Reference 8.4.7).

Bishopston Villages Action Group (BVAG)

- 6.3.12. The Applicant issued a draft SoCG to BVAG on 18 July 2024, taking into account the Relevant Representation from BVAG [RR-548]. BVAG returned an updated draft SoCG to the Applicant on 10 August 2024 which sets out the Group's position on the Proposed Development.
- 6.3.13. BVAG, in their returned draft of the SoCG, have added a further two columns to the document which aims to establish agreement with how the topic and matter(s) have been presented in the draft, and have also added new matters for the Applicant to respond to.
- 6.3.14. The Applicant has not provided comment or input into this SoCG at this time, and intends to review and amend the Applicant position as necessary at a future deadline, and subject to any further discussions held with BVAG.
- 6.3.15. BVAG and the Applicant are meeting on 17 September 2024 to discuss the draft SoCG and will provide an update at a future deadline.
- 6.3.16. The principle matters to be discussed throughout the Examination are:
- The principle of development;
 - Policy compliance, in particular in relation to food security;

- Alternatives, including rooftops and brownfield sites, and alternative sites;
- Health and well-being impacts;
- Sufficiency of the description of development;
- Sufficiency of the landscape and visual assessment;
- The proposed landscape mitigation and Landscape and Ecological Management Plan (LEMP);
- Impacts on cultural heritage assets, including from decommissioning and flood risk stemming from the proposed ground mounting pads;
- Concerns regarding increased crime as a result of the Proposed Development;
- Impacts on ecological assets and biodiversity;
- The level of detail provided in the various management plans within the DCO application;
- The status of mitigation habitats following decommissioning;
- Flood risk;
- Further information required to assess noise and vibration impacts, along with an independent assessment;
- Economic benefits to the local area;
- Impacts of construction traffic;
- Adequacy of local road network to provide access to the Proposed Development;
- Impacts on Mill Lane of construction traffic;
- Further consultation on glint and glare;
- The assessment of the scheme in terms of climate change; and
- Cumulative impacts.

6.4. Parish Councils

Bishopton Parish Council

- 6.4.1. Following discussions at the first Issue Specific Hearing which took place on 23 July 2024, the Applicant issued a draft SoCG to Bishopton Parish Council on 25 July 2024 which comprised a blank template to enable the Parish to provide an account of their position with regards to particular topics forming part of the DCO Application.
- 6.4.2. Bishopton Parish Council returned an updated draft SoCG to the Applicant on Monday 12 August 2024 which sets out the Parish's position on the Proposed Development. The Parish Council also drafted the RWE position in the 'Applicant's position' column of Table 2-1 of the SoCG, and set out the expected likelihood of resolving the matter via the traffic light system. This was provided at Deadline 1.
- 6.4.3. The Applicant has not provided comment or input into this SoCG at this time, and intends to review and amend the Applicant position as necessary at a future deadline, and subject to any further discussions held with the Parish Council. An offer to meet

has been extended to the Parish Council by the Applicant however no date is yet set for a meeting.

Redmarshall Parish Council

- 6.4.4. The Applicant issued a draft SoCG to Redmarshall Parish Council on 18 July 2024, following discussions held at the first Issue Specific Hearing during the Examination.
- 6.4.5. The Parish Council returned comments to the Applicant on 29 July 2024, which have been reflected in the draft SoCG provided at Deadline 1 (Document Reference 8.4.10).
- 6.4.6. The principle matters to be discussed throughout the Examination are:
- Alternatives, including rooftops and brownfield sites;
 - The use of agricultural land;
 - The Order Limits being considered previously developed land following decommissioning;
 - Increased traffic levels;
 - Economic benefits to the local area.
- 6.4.7. The Applicant and the Parish Council are meeting on Monday 16 September 2024 to discuss the draft SoCG and will provide an update at a future deadline.

Great Stainton Parish Meeting

- 6.4.8. The Applicant issued a draft SoCG to Great Stainton Parish Meeting on 18 July 2024, following discussions held at the first Issue Specific Hearing during the Examination.
- 6.4.9. The principle matters to be discussed throughout the Examination are:
- Impact on the local community;
 - The scale of the Proposed Development;
 - The proposed landscape and visual impact mitigation;
 - Accordance with good design principles;
 - Cumulative impacts of the Proposed Development alongside other nearby solar schemes;
 - Impacts on wildlife;
 - Impacts of the Proposed Development on soil quality and the possibility of sheep grazing within the Order Limits;
 - The possibility of growing wildflowers within the Order Limits;
 - The soil quality assessment;
 - Flood risk;
 - Impacts on existing land drains;
 - Noise, traffic and transport effects resulting from construction;

- Concerns regarding increased crime as a result of the Proposed Development;
- The safety of the Battery Energy Storage Systems (BESS); and
- Impacts on local community assets.

6.4.10. The Applicant and the Parish Council are meeting on 18 September 2024 to discuss the draft SoCG and will provide an update at a future deadline.

Stillington and Whitton Parish Council

6.4.11. The Applicant issued a draft SoCG to Stillington and Whitton Parish Council on 18 July 2024, taking into account their Relevant Representation [RR-497].

6.4.12. The Parish Council returned comments to the Applicant on 29 July 2024, which have been reflected in the draft SoCG provided at Deadline 1 (Document Reference 8.4.12).

6.4.13. The principle matter to be discussed throughout the Examination is a concern regarding the impact of increased HGV traffic on the roads in and around Stillington and Whitton and the surrounding area.

6.4.14. The Applicant and the Parish Council met on Tuesday 20 August 2024 to discuss the draft SoCG and will provide an update at a future deadline.
