Development Consent for the Byers Gill Solar scheme: EN010139 Applicants submission – Deadline 6b (17 December 2024)

On 30 July 2024, the Examining Authority ("ExA") issued a letter under Section 89 of the Planning Act 2008 and Rules 8 and 9 of the Infrastructure Planning (Examination Procedure) Rules 2010 ("the Rule 8 letter") which confirmed the Examination timetable and procedure relating to the Byers Gill Solar Development Consent Order (DCO) application. The Rule 8 letter set out the submissions required by the ExA to be provided for each Deadline of the Examination.

On 1 November 2024, the ExA issued a procedural decision [PD-009] in response to a request from the Applicant to make a change to the DCO, as made on 18 October 2024. This requested the submission of a number of documents relating to the change application and set several additional deadlines, including Deadline 6b (17 December 2024).

Discussion of the change application documents at Issue Specific Hearing 5 (ISH5) further clarified the documentation to be submitted at Deadline 6b, as reflected in Hearing Action Point 11 arising from that hearing [EV13-006].



This letter encloses the Applicant's summary of the submission made at Deadline 6b and the reasons for the submission.

## **SUMMARY OF DEADLINE 6b SUBMISSION**
