STATEMENTS OF COMMON GROUND

The Rule 8 letter lists a number of Statements of Common Ground (SoCGs) requested by the ExA to be produced jointly by the Applicant and third parties. At this Deadline, three updated SoCGs are provided. This includes a new SoCG, which is a landscape-specific SoCG with BVAG, as requested under ISH4 Action Point 8 [EV12-008]. The SoCG with Great Stainton Parish Meeting (Document Reference 8.4.11, Revision 3) is now final and signed. Discussions with other parties are ongoing and it is anticipated that final, signed versions of the remaining SoCGs in draft will be submitted at Deadline 8. The accompanying Statement of Commonality (SoC) (Document Reference 8.4, Revision 7) sets out the status of all SoCGs in production and progression made since Deadline 6.
