

To ensure that individuals and organisations situated outside of the CCZ are given the opportunity to participate, we will raise awareness of the consultation in the following ways: • Directly notify those people and organisations who have registered an interest in the Proposed Development through direct engagement or participation in informal consultation phase. • Publish a Section 48 notice in the local and national press and London Gazette. • Publicise the consultation by advertising in local media. • Publish consultation materials on the project website. Additional measures have been set out in Table 1, para 8.2.6 of the Socc. |
