Hi Peter

I hope all is well with you.

I am emailing about a couple of separate things. Firstly, and I will send a more formal email requesting your comments on the DCO application for the Helios renewable energy project near Drax which we have corresponded about a while ago but you may have seen the formal scoping come in now and we are about to get started on a rolling programme of geophys following the crop removal on the parcels of land, do you have a contact for the Conservation Officer covering Selby? I cant seem to find anything!

Secondly – Im not sure if Keith Emerick has been in touch from Historic England, but we have been dealing with some unauthorised works at Church Fenton Airfield on the SM by the owner, Chris Makin. He has been issued a conditional caution and we are in the process of undertaking a number of WSIs and documents to fulfil the conditions, undertake archaeological survey on the damaged areas and make good the damage by way of repair and restoration. We are also undertaking a monument wide earthwork survey to underpin a Monument Management Plan which will hopefully stop anything like this happening in the future.

Obviously, the reports generated by these works will be submitted to the HER but I thought I would let you know out of courtesy and if you had any queries on this, please don't hesitate to get in touch.
