#### SoCGs

In addition to the SoCGs set out above, the ExA's Rule 8 letter [PD-008] requested that the Applicant submits SoCGs with National Grid, Network Rail, Cadent Gas and 7000 Acres no later than Deadline 6. The Applicant wishes to clarify that, following continued due diligence and engagement with National Gas Transmission plc, and as noted by the Applicant at ISH1, it has been determined that they do not have an interest within the Order land. As such, the Applicant will seek to agree an SoCG with Cadent Gas Limited as the primary gas undertaker in respect of the apparatus that may be impacted by the Scheme.



While discussions between the Applicant and these parties remain ongoing, a draft SoCG has not yet been sufficiently progressed with each of these parties to submit at this deadline. The Applicant is continuing to liaise with these parties with a view to refining or resolving any outstanding issues and will look to submit SoCGs to capture these discussions at a subsequent deadline. For the purposes of Deadline 1, the Applicant can provide the following update:

- <u>National Grid</u>: NGET provided the Applicant with a copy of their standard protective provisions, which the Applicant is currently reviewing. The Applicant will provide NGET with our comments on their provisions in due course, with a view to refining and resolving issues as far as possible.
- <u>Network Rail</u>: Protective provisions have been agreed with Network Rail, however, the parties remain in discussion regarding separate agreements that will sit alongside these provisions (those agreements being private as between the parties).
- <u>Cadent Gas</u>: Discussions between the Applicant and Cadent are progressing well, with the protective provisions for inclusion in the draft DCO substantively agreed with the exception of a few outstanding matters. The parties are working to refine and resolve these matters, with a view to submitting an agreed set of protective provisions at Deadline 2 once agreement has been reached.
- <u>7000 Acres</u>: The Applicant is currently liaising with 7000 Acres to set up an initial meeting to work through the issues to be covered in an SoCG between the parties.

#### **Draft itinerary for Accompanied Site Inspection**

In accordance with the ExA's Rule 8 letter dated 24 October 2024 [PD-008], the Applicant has prepared a draft itinerary for an Accompanied Site Inspection (ASI) which is to take place during the week commencing 13 January 2025. This is attached to this cover letter as **Annex A**.

#### **Comments on Additional Submissions**

The Applicant has reviewed the additional submissions ("Additional Submissions") from other parties at and following Procedural Deadline A. The Applicant considers that the matters raised in the Additional Submissions are sufficiently addressed in the Applicant's Response to Relevant Representations [EN010142/APP/9.1].

#### 1. Introduction

### 1.1 Purpose of this Document

- 1.1.1 An application ("the Application") for the Tillbridge Solar Project ("the Scheme") was made by Tillbridge Solar Limited ("the Applicant") to the Secretary of State for Energy Security and Net Zero ("the Secretary of State") for a Development Consent Order (DCO) ("the Order") under section 37 of the Planning Act 2008 ("PA 2008") (Ref. 1). The Application was accepted for examination on 8 May 2024.
- 1.1.2 On 17 September 2024 the Examining Authority (ExA) issued its Rule 6 letter [PD-005] which set out in Annex D a request for a draft itinerary for the Accompanied Site Inspection (ASI) to be submitted by the Applicant at Deadline 1
- 1.1.3 Annex F of the Rule 6 letter sets out that the draft itinerary for the ASI should include:
  - a. relevant locations referred to in the Relevant Representations received;
  - any other locations at which the Applicant has predicted likely significant environmental effects; and
  - c. the locations suggested by Interested Parties submitted by Procedural Deadline A.
- 1.1.4 On 24 October 2024 the ExA issued its Rule 8 letter **[PD-008]** which also sets out that the Applicants draft itinerary for an ASI should be submitted at Deadline 1 on 29 October 2024, and that time has been reserved in the Examination Timetable to undertake an ASI during the week commencing 13 January 2025.
- 1.1.5 The Rule 8 letter **[PD-008]** differs from the Rule 6 letter **[PD-005]** and states that the Applicant's draft itinerary for an ASI is required for locations, if any, where accompanied access is required onto private land. There is only one proposed inspection point where accompanied access is required on private land, and therefore this document provides an itinerary for an ASI to this inspection point only.
- 1.1.6 The ExA will review comments received from Interested Parties at Deadline 1 and the draft itinerary (this document) and may make changes to it, and will publish their final itinerary for an ASI on the National Infrastructure Planning Tillbridge Solar Project webpage.

## 2. Draft Itinerary for the ASI

### 2.1 General Arrangements

#### **Route and Timings**

- 2.1.1 The Applicant suggests that a time period of 15 minutes is provided at the inspection point set out in **Table 2-1** below.
- 2.1.2 The Applicant has also included a 5-minute allowance for getting on and off the transport provided (see 2.1.7 below). The time taken to travel from the starting point to the inspection point and back again has also been considered in the route and timings provided within this document.
- 2.1.3 Table 2-1. Planned Route and Timings for an ASI**Table 2-1** below sets out the planned location for the ASI, approximate timing, and information relevant to the location. The location of the inspection point is shown on **Figure 2-1**, at **Appendix A** below. The timings provided below are approximate and will depend on factors such as traffic.
- 2.1.4 It is important to note that access to the inspection point on the ASI will be subject to the landowner's approval. While the Applicant has requested that such access be granted for the purpose of the ASI, it may not be possible to access this inspection point should the landowner's consent be withheld.
- 2.1.5 In the event that a request to access the inspection point proposed for the ASI is declined by the landowner, the Applicant will inform the ExA at the earliest opportunity and suggest alternative arrangements to replicate the routing as closely as practicable.

#### **Bathroom provisions**

2.1.6 Bathrooms will be available at Thonock Park Golf Course in the morning before departing for the ASI, and after the ASI.

#### **Transport**

- 2.1.7 The Applicant will provide transport for all attendees for the ASI. The meeting place to board the transport (and hence also the starting point for the ASI) will be Thonock Park Golf Course.
- 2.1.8 The transport provided by the Applicant will return to Thonock Park Golf Course at the conclusion of the ASI.
- 2.1.9 Attendees will need to make their own arrangements to get to and from Thonock Park Golf Course.

### Clothing

- 2.1.10 The ASI may include some walking on uneven or wet ground. It is therefore advised that attendees bring sturdy footwear and wear clothing that is appropriate for the weather/conditions on the day.
- 2.1.11 Conditions in some areas and the weather on the day may require that wellington boots are required.

2.1.12 Foliage on PROWs and at field boundaries/entrances can be tall and overgrown. All attendees are requested to wear clothing that keeps their arms and legs covered at all times.

#### **Health and safety**

- 2.1.13 It will be necessary to wear a high visibility vest at all times during the ASI. The Applicant will provide a vest for use during the course of the ASI if attendees do not have their own high visibility vest.
- 2.1.14 The ASI will involve walking on terrain that may be uneven. Anyone who may find it challenging to walk in these conditions is advised to assess whether it is suitable for them to attend the ASI, either partially or in its entirety.
- 2.1.15 Some obstructions on public rights of way (PRoWs) and at field entrances may require attendees to crouch down to pass.
- 2.1.16 A first aid kit will be provided on the transport for the ASI.
- 2.1.17 The Applicant will carry out a walk of the route ahead of the ASI to identify potential hazards in advance.
- 2.1.18 The Applicant will carry out a briefing ahead of the start of the ASI. The aim of this briefing will be to ensure that attendees are aware of any health and safety risks.


