#### BESS – updates to Schedule 1 and Outline Design Principles

At Issue Specific Hearing 1 (ISH1), the ExA raised a query regarding the terms "BESS station" and "BESS compound" in the **Outline Design Principles Statement** [EN010142/APP/7.4(Rev02)] and their relationship to the Work Numbers set out in Schedule 1 of the draft DCO [EN010142/APP/3.1(Rev04)].

The Applicant has since been reviewing these two documents to ensure they are aligned and that it is clear as to what works are provided for under each Work Number. This work remains ongoing, and the Applicant intends to provide the ExA with an update (including, where necessary, updated versions of either or both documents), at Deadline 4.

#### SoCGs

The ExA's Rule 8 letter **[PD-008]** requested that the Applicant submit updated SoCGs with all the parties listed in Annex B at Deadline 3 and final signed versions of the SoCGs between the Applicant and parties no later than Deadline 6.

The Applicant is submitting SoCGs with the parties listed in the table above at Deadline 3 but will not be submitting SoCGs with Lincolnshire County Council ("LCC"), 7000 Acres, Other Solar Developers, Anglian Water, Trent Valley Internal Drainage Board ("Trent Valley IDB") or Network Rail at Deadline 3.

While discussions between the Applicant and these parties remain ongoing, there is no material update to the SoCGs previously submitted to the ExA. The Applicant is continuing to liaise with these Parties with a view to refining or resolving any outstanding issues and will look to submit SoCGs to capture these discussions at a subsequent deadline.

For the purposes of Deadline 3, the Applicant can provide the following updates:

- <u>LCC</u>: Discussions remain ongoing with LCC as the parties seek to narrow areas of disagreement, however LCC stated that they would not be able to respond to agree the latest draft SoCG at Deadline 3, as they wish to review the Applicant's Deadline 3 submissions before updating the SoCG. It was therefore agreed that an updated LCC SoCG would be submitted at Deadline 4.
- <u>Trent Valley IDB</u>: Trent Valley IDB has confirmed that it is comfortable with standard protective provisions such that bespoke provisions are not required. The Applicant has provided Trent Valley Drainage Board with a copy of its standard protective provisions for review and comment and is awaiting a response.
- <u>Anglian Water</u>: the Applicant can confirm that the protective provisions included in the draft DCO for the benefit of Anglian Water are agreed between the parties, however there are other aspects of Anglian Water's position that are the subject of ongoing discussions between the parties. The Applicant and Anglian Water will be in a position to provide the ExA with an update on these aspects, by way of an updated SoCG, at Deadline 4.
- <u>7000 Acres</u>: The Applicant has provided a draft SoCG to the 7000 Acres Group for review and is continuing engagement on the content of the SoCG. It is intended that a draft SoCG will be submitted at Deadline 4.
- <u>Other Solar Developers</u>: All positions within the SoCG are agreed apart from the final position relating to the further cooperation agreement, which has been circulated to the other solar developers for comment. The parties hope to submit an updated SoCG at Deadline 4.
- <u>Network Rail</u>: The Applicant is engaged in ongoing discussions with Network Rail in relation to its position on the Scheme, with the Heads of Terms and a Framework Agreement currently being reviewed by the Applicant.

#### Requests to be heard

In response to the ExA's Rule 13 letter dated 6 December 2024, the Applicant confirms that the attendees on behalf of the Applicant at Issue Specific Hearing 2 (ISH2), Open Floor Hearing (OFH2), Issue Specific Hearing 3 (ISH3) and Compulsory Acquisition Hearing 1 (CAH1) scheduled between 14 and 16 January 2025, will be:
