it's just about six o'clock. So we'll make a start. Welcome to this open floor hearing for the East Yorkshire solar farm project. Can I just check that everyone can hear me at the back? Seems like I'm a long way away from everybody. Can I check that the streaming recording is going, my name is Simon border, I'm appointed by the Secretary of State as the single examining inspector for this application. And you'll also hear me refer to as the examining authority. A few housekeeping points for those who weren't here this afternoon. If you could please switch off mobile phones or any other devices, or at least put them to silent, you probably noticed that the toilets are away to our left through the lobby if you need them. There was no fire drill expected this afternoon. So the fire escape if all that if the alarm does go off, the fire escape is through the doors behind us to the right here, around the building to the front by the flag poles where hopefully, member of staff will be able to assist us. The meeting today is conducted in a hybrid fashion, which means obviously, as well as the people in the room, there are some people who may join us virtually using Microsoft Teams, they'll try to make sure that I give everyone a fair opportunity to participate as we go along. There will be a recording of the hearing. And that will be made available on the project section of the national infrastructure planning website as soon as the hearing is finished within reason. With this in mind, please ensure that you do speak into a microphone, and you state your name and who you're representing each time before you speak. The table microphones do have on and off buttons. But I would suggest that you turn the microphone off if you're not involved at that particular time. Another point that I need to make is that there was a link to the planning inspector, it's privacy notice in the notification for the hearing. And I'm going to proceed on the basis that everyone is familiar with that. Because it sets out the way in which personal data is handled in accordance with the principles and the data protection laws. If you have any concerns on that front, Matthew Shepard is the person to speak to about it. Now, because this is an open floor hearing, there's no formal agenda, because the purpose is to hear the representations from interested parties who is registered enough to speak this evening. As there's not a huge number of people who are registered to speak, I think the simplest thing would be to take people in alphabetical order. So the purpose is simply to give you an opportunity to raise anything directly that you feel is relevant and important. And you think I should know about and consider. It's not specific to any location or topic, the subject matter is up to you. There again, because there are a relatively small number of people who wish to speak, I'm not going to set a strict time limit for speaking. But I think in everyone's interests, and perhaps if you could make sure that your submissions are fairly concise to the point and importantly don't repeat points which may have been made by others beforehand. As a rule of thumb, I would ask people to try and keep their submissions to no more than 10 minutes. Once you've spoken I might have some questions and the applicant will have the opportunity to respond. I would suggest that we will you

respond on just looking at the applicant respond at the end of the session rather than after each individual person I think it will be make the hearing golden but more smoothly if we do it that way. Before I do ask people to to come up perhaps I could ask the applicants to to come up to the table. I don't think there were roving microphones this evening. So just to introduce yourself.

So that is no benefit to my uninterrupted views that I have at present, especially with the high security fencing and cameras they're planning to put around this said scheme and the height of the solar panels. We have seen wildlife where we live, that is part of the pleasure of living where we do apart from it being a quiet countryside location. I've lived there for 24 years. It's a beautiful, tranquil piece of East Yorkshire countryside. In one of my sort of thoughts, really, they told me that the roads wouldn't be used for if the it goes ahead, they will use farm tracks and the farm vehicles. Now, reading in between that afterwards. I'm not sure that's happening. If it goes ahead. Because of the roads or single track, if you use a bus, you have to reverse. If you meet a car, you have to get off the road. They the roadsides have deep roots, they're not maintained roads so that it's unsuitable for it does tractors that's about it. If you've got an Arctic, you've got no chance you have to reverse at least half a mile. As I say we live on the crossroads. So I see quite often. There's also Rumor has it that obviously the goods have to be removed after 40 years. I'd like to know if this is correct as in removed as in the pile driving the concrete in the ground to turn it back to agricultural land. Again, I probably won't see this in my lifetime. But it would, it's a question that I have is the land if it goes ahead, going to be put back to purpose even though there'll be no nutrition in the land. We have, apart from the wind turbines that we've accumulated where we live, we have an anaerobic digester. This will pass planning on the vision that the anaerobic product was put on the local farmland. So if it

goes on to the local farmland, but the farmland is turned into solar, where does it go? That is that was signed up by all the local farmers, predominantly three quarters of which are in this agreement

Could I just explain that although Emma has mentioned some things that are in mind, but I want to read the whole thing because I've prepared it and so rather than trying to cut bits out, I shall read it if that's okay. My presentation is an addition to and following on from my previous submissions, where I have explained how badly affected we are many other residents will be. In this I want to highlight some of the many failures in the applicant's communication with the local community, thus, exacerbating the feeling of hopelessness that we all feel. Our situation has recently been described in the press as a David and Goliath battle. Our Georgian homes some wood house in Spalding mountain, we have lovingly restored over the past 22 years, and it will become an island in between two huge fields of solar panels. To give an idea of the proximity, the field to f is just 10 meters from our front gate, and 35 meters from our house. Every view from the house will be a sea of solar panels, there will be no escape. We will be part of a huge industrial power plants as we have already got five industrial wind turbines just 1000 meters away, plus an ad plants further to the west. We invited the applicants to come to our property so that we could show them how affected we will be but they refused. The cumulative effect of this development will be devastating. Because of the sheer numbers of applications in East West and North Yorkshire and North Lincolnshire already in the system. The development is far too close to residential properties. The long term effects of solar farms are still unknown. Issues such as noise, including the construction possibly using pile driving, and the noise from the motors and cooling fans once the panels are installed. Radiation and electromagnetic fields

fire risk creation of microclimates flood risk by filling the fields with concrete, light pollution, health risks, both mental and physical, and toxic runoff are all under investigated and dismissed as insignificant by the applicant. There has been a piecemeal approach to this no logical consistency to what land is to be used. Only land that has been offered by local landowners is being used instead of the developer researching the most appropriate land which they are supposed to do as part of the planning process. They must prove that there isn't more suitable land available, they have not done this, because if they had much of the land in these plans would have been dismissed because of the proximity to homes. If this had been broken down into several smaller applications, some of it would almost certainly have been refused on the cumulative effect. There has been a lack of consideration given to adequate buffer zones. The plans are inconsistent in that some properties have been given significant buffer zones and others have not. There is no logic to this at all. It is worth noting, however, that none of the landowners involved were being paid for the use of their land have any fields adjoining their homes, but it seems it's okay for the rest of us to be surrounded by them and receive absolutely no compensation at all for the disruption And the inevitable reduction in the value of our properties. All the land in the application is arable land ideal for growing cereal crops. We are told by the applicant that it is largely grade four or three B, but we only have their word on this. There should have been independent surveys done taken across all of the land not just filled margins. But this hasn't been done to our knowledge as they have been done by so analysts appointed by the applicant, the government or the last government have said independent soil assessments must be carried out for all applications. It is far too easy to just dismiss the land as poor when in fact two years ago the local wheat yields were at a record level. In these uncertain Global Times, we should be concentrating on retaining all of our food producing land, not using it to cover in metal and plastic for the next 40 years. Once that land has gone and become Brownfield, it will never be farmed again. Despite what the proponents of solar farms will tell you to the contrary. Solar panels should be on all new warehousing factories carparks a new build houses, not on farmland. Wildlife is abundant in this area, ground nesting birds that just skylark oystercatcher and lapwing all nest and fly over these fields. Rodia, a prolific small herds living and breathing all around the area. We have a little herd that rests in our paddocks at night moving out to graze during the day, brown hair as seen regularly in the fields to the north and south of our property, along with our resident pair of barn owls that breed here every year, and tons over our paddocks and out into the fields to the northwest and south and roost in our field shelter at night. We also have little owls and tawny owls. There are a bunch of set from several of the designated field boundaries. We have several species of bats. We had to have extensive bat surveys done when we put in for planning for our business and now have bat boxes all around our property. Has the applicant done this. We had one request to come on our property ages ago, but we never replied because their attentions was intentions were very unclear at the time. And they have never asked again despite the fact that we have invited them to come and see for themselves how badly affected we will be. And the attitude about wildlife demonstrated by the applicant's representatives at the consultations was breathtaking in its utter ignorance and arrogance. Most of the roads involved in the plans are single track with passing places and many are already in a poor state of repair. These roads were originally built for horses and carts they've subsequently struggle to cope with increasing numbers of vehicles, including modern farming machinery. How will these roads that the local community depend on cope with hundreds and hundreds of extra lorry movements for at least two years of construction. A huge amount of damage was done when the wind farm on Spaulding to an airfield was built with expected traffic traffic for the solar farm will be on a whole new level. Our rural community has no public transport at all. So these small roads are our only

means of getting from A to B. In addition to this most of our utilities are under the verges water. telephone, broadband and electricity. We have been told by the applicant that we must expect road closures and traffic control measures throughout the construction period for up to two years. The inspector should know that the applicant failed to notify the whole community about these traffic control measures and only wrote to those directly living on the access routes. They should have notified all residents living in a local community. In fact, I believe that the applicant has been extremely negligent in its dealings with the local community to the point of dismissiveness. For example, many residents have complained that they have never received any acknowledgement from the applicants their emails, completed forms or general queries. The applicant failed to respond at all in many cases. And when they did, they failed in most cases to answer genuine concerns, simply sending back generic responses, which in a massive proposal like this should have been responded to on an individual basis. I was told that they hadn't sent out individual individual responses because of the number of communications they'd received. Another issue became apparent at all the consultations as all the maps that we used were very misleading because the applicant effectively removed all dwellings and buildings this giving the impression that very few if any people actually were going to be affected by the developments. They also used out of date OS maps. Finally, there is a very real risk of crime. The police in some areas of the country have expressed concern about the potential for gangs traveling to solar farms to steal copper and other components. This will mean higher stronger fencing, not simple deer fencing, but chain link prison staff fencing with CCTV cameras on poles and security lighting. This is a quiet, tranquil rural area in some solar farms under construction and those already constructed. The risk of factors meant that there are people with guard dogs patrolling at night with all sorts of implications, loss of privacy, dogs barking or PIR Lights being triggered all night. The worry of being burgled will make our predicament even worse. It is a dystopian nightmare. We would challenge anyone accusing us of nimbyism, these things should not be in anyone's backyard

Has the applicant made themselves so aware of the location of local residents water supplies, meters and other services located within those couples required merges the applicant should be required to reassure every household within which, with services in the verges that they're supplied to their homes will be safeguarded? How does the applicant propose to protect the residence leave it living in close proximity to the solar panels in the event of a fire spreading across the site. The land that these solar panels are going to be on are on a high water table. So unless they put tracks onto those lands, then no firefighting vehicle will be able to access the panel's. We don't dispute the results of the need, for example, for solar, for rooftop solar on warehouses, etc. But there is a need also for large scale ground mounted solar which the applicant is bringing forward. In doing so the applicant has sought to bring forward a sensitive scheme, one which is sensitive to the landscape, which is sensitive to the environment and sensitive to the local community. As part of that the plugin has put forward a whole host of mitigations through its management plans, which will it will be legally obliged to deliver and which will also be subjected to detailed design and approval by the relevant local planning authorities who will have control of the discharge of conditions stage and the ultimate shape of the skin act that includes provision for trend traffic and transport management, landscape management, and indeed the requirement to set up a communities and grip throughout construction to ensure that all the issues which any issues which the local community may have and appropriately dealt with at that time. So there are various other detailed points, I think it's probably best given the range of them that they

For example, there are no additional impacts or constraints on services, which would want for example, a section 106 review, which is normally what a section one reflexive event will have to deal with, in terms

of just a broad community benefit fund. I understand that it's something that is considered by the applicant that is not offered and shouldn't be relied upon within the planning process, because it's not required to make the development acceptable in planning terms.
