1 Introduction

1.1 Purpose of this document

- 1.1.1 This Schedule of Changes to the Book of Reference (BoR) relates to an application made by East Yorkshire Solar Farm Limited (the Applicant) on 21 November 2023 under section 37 of the Planning Act 2008 (the Act) for an order to grant development consent for East Yorkshire Solar Farm (the Proposed Development).
- 1.1.2 The DCO application was accepted for examination on 19
 December 2023. A detailed description of the Scheme can be found in Chapter 2 of the Environmental Statement (Document Reference 6.1).
- 1.1.3 This Schedule of Changes should be read in conjunction with the updated BoR.
