# 1. Introduction and Purpose

## 1.1 Purpose of this Statement of Common Ground

- 1.1.1 This Statement of Common Ground (SoCG) has been prepared to support an application (the Application) made to the Secretary of State for Energy Security and Net Zero for a Development Consent Order (DCO) under section 37 of the Planning Act 2008 (PA 2008) for the proposed East Yorkshire Solar Farm (the Scheme). The Application is submitted by East Yorkshire Solar Farm Limited (the Applicant).
- 1.1.2 This SoCG has been prepared between (1) the Applicant and (2) Historic England (HE) (jointly referred to as the Parties).
- 1.1.3 HE is the Government's lead advisor on the historic environment and protects England's historic environment through championing historic places; identifying and protecting England's heritage; managing change; understanding historic places; and providing expertise at a local level. HE is listed as a prescribed consultee in Schedule 1 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 and so has been consulted throughout the preparation of the Application.
- 1.1.4 The Examining Authority has requested that the SoCG include the following matters as set out in the Rule 6 Letter **[PD-002]**:
- a. Effects on the Historic Environment including the adequacy of assessments, methodology and proposed mitigation;
  - b. Impacts on the setting of designated heritage assets;
  - c. Effects on archaeology;
  - d. Effectiveness of proposed mitigation and monitoring measures and method for securing such measures within the draft DCO **[REP1-006]**; and
  - e. Drafting of the draft DCO **[REP1-006]**, including the Articles and Requirements.
- 1.1.5 It can be taken that any matters not specifically referred to in section 2 and 3 of this SoCG are not of material interest or relevance to HE's representations and therefore have not been considered in this document.
- 1.1.6 This SoCG has been produced to confirm to the Examining Authority where agreement has been reached between the Parties, where agreement has not been reached (and that is the Parties' final position) and where discussions are still ongoing. This SoCG will be revised and updated as discussions between the Parties progress during the Examination.

## 1.2 Description of the Scheme

- 1.2.1 The Scheme comprises the construction, operation (including maintenance) and decommissioning of a solar photovoltaic (PV) electricity generating facility with a total capacity exceeding 50 megawatts (MW) and export connection to the national grid, at National Grid's Drax Substation. A detailed description of the Scheme is included in Chapter 2: The Scheme, Environmental Statement Volume 1 which was submitted with the DCO

Application **[APP-054]** and a description of the development to be authorised is set out in Schedule 1 of the draft DCO **[REP1-006]**.

## 1.3 Format of Document and Terminology

1.3.1 Section 2 of this SoCG summarises the engagement the Parties have had with regard to the Scheme.

1.3.2 Section 3 of this SoCG summarises the issues that are 'agreed', 'not agreed' or are 'under discussion'. 'Not agreed' indicates a final position where the Parties have agreed to disagree, whilst 'Agreed' indicates where the issue has been resolved. The Parties have also indicated the likelihood that agreement will be reached on each item.

## 2. Record of Engagement

### 2.1 Record of Engagement

2.1.1 The tables below set out a summary of the meetings and correspondence between the Parties in relation to the Scheme.

Feedback was provided by the consultees on the PEI Report with an opportunity for discussion. The Applicant explained that the methodology in Chapter 7: Cultural Heritage, ES Volume 1 **[REP2-006]** does not conflate significance of effect with the effect on (heritage) significance and it is recognised that these are separate Issues. It was agreed that the proposed methodology was acceptable.

HE also raised that the emphasis on Grade II buildings should be ranked higher than 'Medium' in the PEI Report. The Applicant explained that the assessment reflects the separation of the grades in paragraph 206 of the National Planning Policy Framework (December 2023). This methodology was agreed by HE.


