- WHERE ANY TEMPORARY TRAFFIC MANAGEMENT WORKS ASSOCIATED WITH THE CONSTRUCTION OF THE SCHEME EXTEND OUTSIDE OF THE ORDER LIMITS PRESENTED AND THOSE AREAS DEFINED IN SCHEDULE 8 OF THE DEVELOPMENT CONSENT ORDER, A SEPARATE AGREEMENT WOULD NEED TO BE SOUGHT WITH THE RELEVANT LOCAL AUTHORITY.

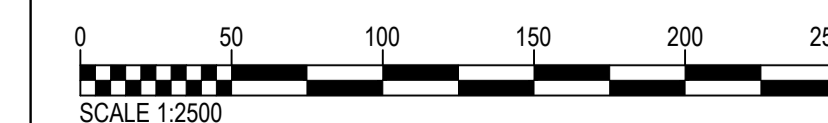
