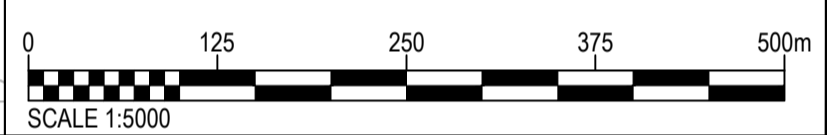

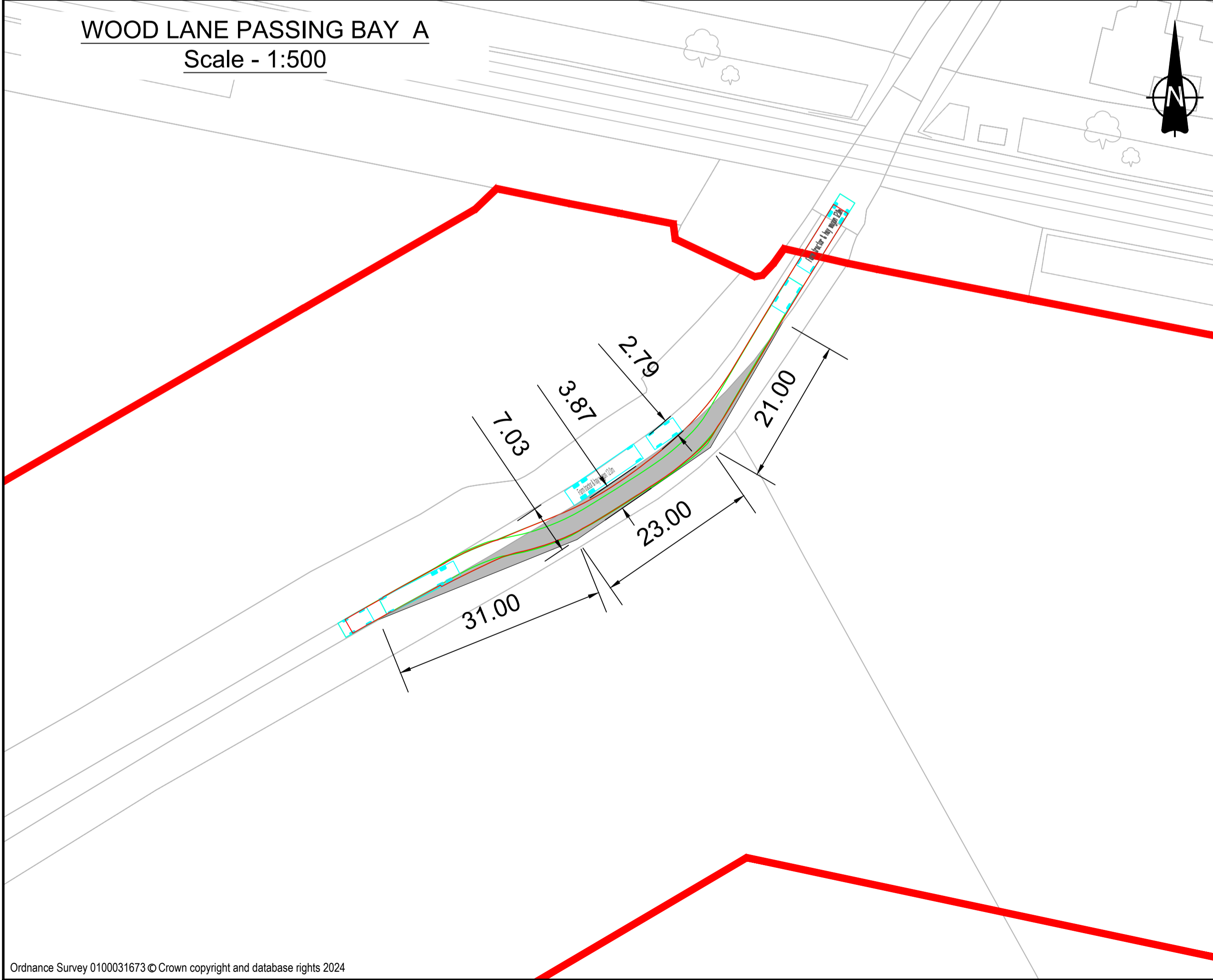
TRACTOR AND 12m TRAILER DETAILS FOR SPA

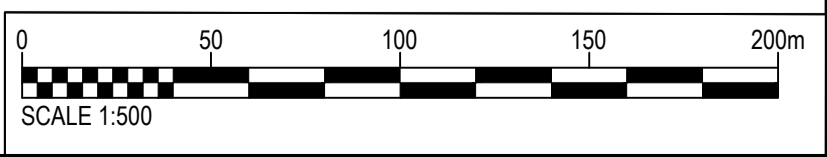
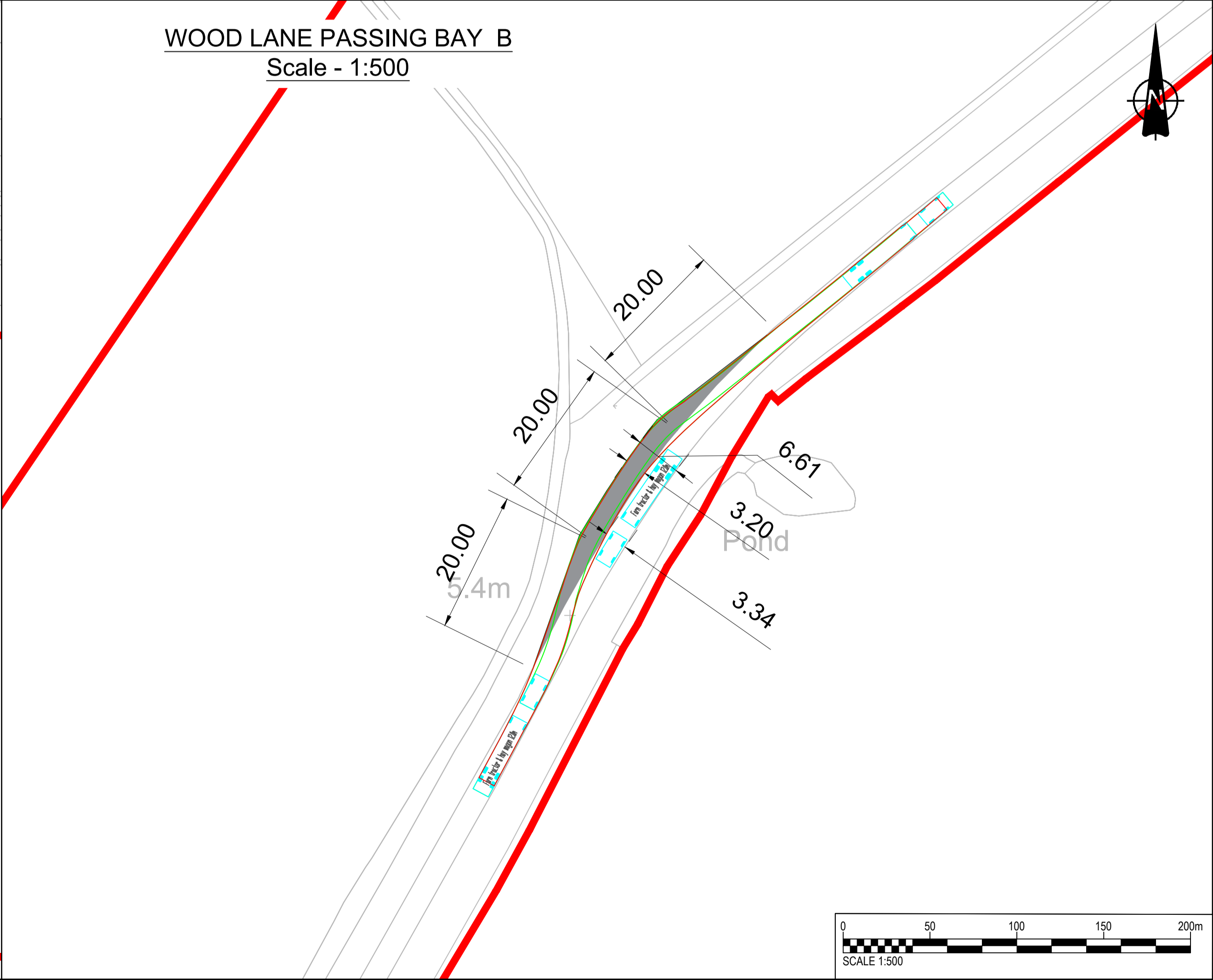
WOOD LANE PASSING BAY A
