1.	Paragraphs 6.1.2 and 6.1.3	Paragraphs 6.1.2 and 6.1.3 state that the three main project sites (Northern, Central and Southern) are illustrated on Figure 1.2 (Masterplan Overview). However, it is not clear on Figure 1.2 which areas within the Order Limits fall within each site.		
	(also see Masterplan Overview Figure 1.2)	For ease of reference, it would be useful if the Applicant could indicate on Figure 1.2 the extent of the Northern, Central and Southern project sites.		
		Figure 1.1 (Site Location and Order Limits Overview) illustrates the Northern, Central and Southern areas. The Applicant may need to review their documents and ensure consistency across their application documents prior to submission.		
2.	Paragraph 6.4.21	The explanation of what conservation grazing involves is missing from this paragraph.

3.	Paragraph 6.1.9	Paragraph 6.1.9 states that in areas where electrical cables cross areas of archaeological sensitivity, the cabling will be hung on frames beneath the solar arrays or placed in protected ducting on the surface of the land. It would be beneficial to understand whether these alternative cabling methods will be compatible with the conservation grazing / small scale horticultural production use that is proposed for these areas.		
4.	Paragraphs 6.1.11 and 6.4.16	Paragraph 6.1.11 states that within the cable corridors, there are four locations where alternative cable routes are possible. However, paragraph 6.4.16 states that there are three areas within the cable corridor where alternative cable routes are possible. The Applicant may wish to clarify both the number and location of alternative cable routes within the project description.

5.	Masterplan Overview - Figure 2.2a Central Site Area 1 of 4	The Applicant should ensure consistency across their application documents upon submission and make clear what the purpose of the 'Skylock Plots' will be.

6.	Temporary Facilities - Figure 3.1a Northern Site Area 1 of 2	The figure inset showing the location of the temporary haul road in the northern site area is blurry / illegible.		
7.	Illustrative Masterplan - Figure 2.3	The "Proposed Infrastructure and Land Use Elements" section of the legend for this figure includes an "Educational Area" however there is no reference to or explanation of what this comprises in the project description.

Should further draft documents be provided for review, the Applicant may wish to consider providing a full list of known application documents (for purpose of signposting) as well as their respective reference number.
- 2. [MHCLG] Application form guidance, paragraph 3, states: "The application must be of a standard which the Secretary of State considers satisfactory: Section 37(3) of the Planning Act requires the application to specify the development to which it relates, be made in the prescribed form, be accompanied by the consultation report, and be accompanied by documents and information. The Applications Regulations set out the prescribed form at Schedule 2, and prescribed documents and information at regulations 5 and 6."
