## Re: Your Recent Scoping consultation on Environmental Statement (ES)

I refer to your scoping consultation on Environmental Statement (ES) notification letter dated 13/11/2023 regarding the proposed Nationally Significant Infrastructure Project (NSIP) above, which comprises the construction, operation and maintenance, and decommissioning of a solar photovoltaic (PV) electricity generating station with a capacity exceeding 350 MW (megawatts), and associated development including a Battery Energy Storage System (BESS) of up to 360MW and a 5MW community solar PV array, a new National Grid 400kV Substation (the National Grid Substation) on 3 separate parcels on land:

- Maen Hir North: Maen Hir North is located at OS grid reference SH 4064391159 (approximate centre). The parcel equates to approximately 413ha.
- Maen Hir Central: Maen Hir Central is located at OS grid reference SH 4075988131 (approximate centre). The parcel equates to approximately 425 ha located to the north and east of Llyn Alaw reservoir.
- Maen Hir South: Maen Hir South is located at OS grid reference SH 4449282579 (approximate centre). This parcel equates to approximately 396ha comprising hedges, trees and woodland form the boundaries to the fields.

The proposed development will be located inland of Anglesey approximately 26 km from the Conwy CBC boundary. Distance views into the land may be possible from the highlands within the coastal areas of Conwy CBC such as Llandudno (Great Orme), Llanfairfechan, Penmaenmawr or Conwy.

Based on the scale, nature and siting of the development and the potential impact on Conwy CBC, the Conwy Local Planning Authority considers that information of landscape and visual impact should be provided in the Environmental Statement (ES).
