The Secretary of State received a request dated 29 February 2016 from Bircham Dyson Bell LLP acting on behalf of National Grid Electricity Transmission plc ("the Applicant") for the correction of errors in The National Grid (Hinkley Point C Connection Project) Order 2016 ("the Order"), under section 119 of, and Schedule 4 to, the Planning Act 2008. This request was further clarified to the Secretary of State in a letter dated 5 December 2016.

The Secretary of State has made the following corrections to the Order:

Corrections to the Articles

"(2) Pylon LD32 must be constructed, 40 metres northwards from the position shown on the Works Plans within the limits of deviation relating to that Work as shown on those plans together with a corresponding increase in height of pylon LD32 to 36.5m and of pylon LD31 to 40 metres comprised in Work No. 1D shown in the sections (Drawing No 13/NG/0271 – 01_13205_84 revision C, Sheet 4)";

and substitute:

"(2) Pylon LD32 must be constructed 40 metres northwards (plus or minus 5 metres northwards or southwards to allow local ground conditions to be taken into account) from the position shown on the Works Plans within the limits of deviation relating to that Work as shown on those plans, together with a corresponding decrease or increase in height of pylon LD32 and of pylon LD31 as appropriate comprised in Work No. 1D shown in the sections (Drawing No 13/NG/0271 – 01_13205_84 revision B, Sheet 4)."

Secretary of State's rationale:

To correct a drafting error so as to enable the final siting of pylon LD32 to be determined by extant ground conditions, and to remove an erroneous drawing reference and to substitute a reference to the correct drawing.

Omit paragraph 71(2).

Secretary of State's rationale:

To remove a reference that is no longer required.

Corrections which the Secretary of State has not made

Corrections to the Contents Page

The Applicant proposed inserting the word "PLANS" after the text "Schedule 2".

Secretary of State's rationale:

The Contents page is not part of the Order, and it is therefore not possible to make any changes to it through the correctable errors process.

Schedule 3, Requirement 27 (travel plan)

The Applicant proposed correcting the Order, which requires the preparation and agreement of a single travel plan for the whole of the authorised development, so that a Travel Plan is prepared for each particular stage of the Development.

Secretary of State's rationale:

The Secretary of State does not consider this to be a correction but rather a variation to the Order and therefore out of the scope of Schedule 4 to the Planning Act 2008.

Schedule 3, Requirement 39 (overhead line conductors)

The Applicant proposed correcting the Order, which requires the preparation and agreement of the details of the overhead line conductors and the Quality Assurance

system for their transportation and implementation, to apply to 400kV overhead electric lines.

Secretary of State's rationale:

The Secretary of State does not consider this to be a correction but rather a variation to the Order and therefore out of the scope of Schedule 4 to the Planning Act 2008.

Schedule 9 (deemed marine licence)

The Applicant requested a correction to paragraph 5 of the Deemed Marine Licence so that it refers to the Planning Act 2008 and not the Marine and Coastal Access Act 2009.

Secretary of State's rationale:

The Secretary of State does not have powers to make corrections to the deemed marine licence under Schedule 4 to the Planning Act 2008.

Schedule 16 (amendment of local legislation)

The Applicant requested the removal of the byelaws contained in Schedule 16 following the conclusion of an agreement with the named internal drainage boards which means they are no longer required.

Secretary of State's rationale:

This requested correction reflects an agreement reached by parties after the Secretary of State's decision was issued. The Secretary of State is therefore unable to accept this as a correction.
