	The Planning Inspectorate advised that revised		
	application guidance for the consultation period has been		
	issued by DCLG, which can be found on the National		
	Infrastructure Planning website.		
	NG confirmed that this has been incorporated into the SoCC		
	and that formal meetings with Local Authorities will be held		
	as part of the consultation strategy.		
	NG updated PINS on the logistical arrangements made so		
	far: The project is of a linear nature and encompasses 37		
	miles of overground and underground connections. For		
	logistical purposes, the project has been divided into sections		
	NG and 3G have been researching potential venues in the		
	vicinity of the proposed scheme and presented their findings.		
	PINS advised that NG are free to use any venue during the		

consultation period. PINS venue requirements only apply during examination. PINS reiterated that there will be a high degree of flexibility; the key requirement for all venues used during an examination is full disabled access/DDA compliance. PINS also explained how the booking process would work in practice, and that PINS will liaise directly with the venues in question wherever possible and practical. It was stressed that the venue must be as neutral as possible, and that any display of the applicant's logos on banners, display boards or similar will not be permitted.

PINS advised that there will be uncertainty around where hearings will be required until the Examining Authority has been appointed and principal issues have been identified. Also, the number of hearings, location of hearings and general timetabling will be a matter for the Examining Authority. Holding simultaneous hearings may be a possibility, also holding several hearings on the same day.

The importance of audio recordings was reiterated: PINS stressed that it is the applicant's responsibility to ensure that hearings are recorded so that the recordings can be published on the National Infrastructure Planning website. Equally it is important to test the audio set-up prior to a hearing to ensure that the Examining Authority can be heard in the entire venue, but is equally able to hear all participants.

3G explained that all options for hearings will be considered, particularly for the Preliminary Meeting. Should the selected venue prove too small for the expected number of attendees, the hearing could be screened in marquees or similar temporary structures.

PINS explained that feels a need for additional security arrangements, PINS advise plain-clothes security staff, who could integrate themselves into the crowd during hearings, rather than a visible security presence that could be intimidating.

NG asked how the Accompanied Site Visit would take place, i.e. how would the linear nature of the proposed scheme impact on arrangements.

PINS advised that this would also a matter for the appointed Examining Authority. Possibilities would include several shorter site visits to specific parts of the proposed scheme or visiting the scheme in its entirety. At this point in time PINS cannot provide any specific advice.

In summary, **PINS** advised that the requirements for venues during the examination period are kept as simple as possible and arrangements are made with a view to ensure full accessibility for and participation of the general public.
