PROPOSED BRAMFORD TO TWINSTEAD TEE 400KV CONNECTION PROPOSED BY NATIONAL GRID.

Further to our letter dated 15 March 2013, we would like to provide further clarification on the comments we provided relating to Water Quality (chapter 9 of the Scoping Report). I understand that you will be able to pass these comments to the applicant and publish them on your website.

Water Quality

As we previously advised, we welcome that the ES will include a qualitative assessment to determine the proposals compliance with the objectives of the Water Framework Directive (WFD), the issues set out for the watercourses under the Anglian RBMP and any WFD mitigation measures to improve the status of locally designated water bodies.

We will be happy to advise the applicant on the extent they will need to address these requirements of the WFD. To enable us to do this we will need some additional information including:

- The name of each waterbody affected by the works (including those not in the Anglian River Basin Management Plan);
- The length of each waterbody to be affected by the works;
- A brief explanation of how each waterbody will be affected by the works (e.g. channel diversion, sediment management, culverting, tree removal, new structures within 9m of the main river channel, river-adjacent earthworks, etc)

Further, contrary to paragraph 9.4.8 of the Scoping Report, an appraisal of the construction effects of the proposal will be required as although the period of construction activity may be temporary, the period of construction effects may be non-temporary (e.g. increased surface runoff leading to additional allochthonous fine sediment inputs and in-stream landform formation).
