1. Introduction

1.1 Overview

- 1.1.1 National Grid Electricity Transmission plc (here on referred to as National Grid) is making an application for development consent to reinforce the transmission network between Bramford Substation in Suffolk, and Twinstead Tee in Essex. The Bramford to Twinstead Reinforcement ('the project') would be achieved by the construction and operation of a new electricity transmission line over a distance of approximately 29km (18 miles), the majority of which would follow the general alignment of the existing overhead line network.
- 1.1.2 This Important Hedgerow Assessment has been produced to support the application for development consent and the accompanying Environmental Statement (ES) under the Planning Act 2008.

1.2 Purpose of this Report

- 1.2.1 The Hedgerows Regulations 1997 protects important countryside hedgerows by controlling their removal through a system of notification. Under these Regulations, hedgerows over 30 years old are assessed against criteria listed in Part II of Schedule I of the legislation relating to their features of archaeological, historical, landscape and wildlife interest. Hedgerows which meet the criteria are considered to be 'Important' under the Regulations.
- 1.2.2 To qualify as Important a hedgerow must meet the criteria set out in Regulation 4 of The Hedgerows Regulations 1997:
- They have been in existence for 30 years or more; and
 - They satisfy at least one of the criteria set out in Part II of Schedule 1 to The Hedgerows Regulations 1997 (see Section 2.1 for detailed criteria).
- 1.2.3 This appendix identifies which hedgerows within the Order Limits are 'Important' as per the criteria set out in The Hedgerows Regulations 1997 based on the findings of a desk study and site surveys. The relative hedgerow impact assessments can be found in ES Chapter 7: Biodiversity (**application document 6.2.7**) and ES Chapter 8: Historic Environment (**application document 6.2.8**).

1.3 Definitions

- 1.3.1 The Hedgerow Survey Handbook (Defra, 2007) defines a hedgerow as any boundary line of trees or shrubs over 20m long and less than 5m wide at the base, provided that at one time the trees and shrubs were more or less continuous. This includes shrubby hedgerows and very gappy hedgerows, where each section may be less than 20m long, but the gaps are less than 20m.
- 1.3.2 Lines of trees (as defined by Butcher *et al.*, 2020) are excluded from this hedgerow assessment.

2. Methodology

2.1 Desk Study

General

- 2.1.1 A desk study was undertaken using Ordnance Survey mapping data and aerial photographs (dated 2021) to identify hedgerows within the Order Limits. These were digitised and given an individual hedgerow identifier. The identifier was generated using the project section prefix and a number which increased from east to west e.g.H-AB-01 where H = hedgerow, AB = Section AB of the project and 01 = consecutive number east to west.
- 2.1.2 Where additional hedgerows were identified during the later field survey, these were added to the dataset and may not be consecutive in numbering from east to west.
- 2.1.3 The desk study resulted in the initial classification of a hedgerow as being 'not important' if one of the following criteria was met:
- It was less than 30 years old as shown on historical maps and aerial photography; or
 - It marks the boundary of a garden.

Archaeology and History

- 2.1.4 The archaeology and history desk-based assessment involved a review of the following sources of information:
- Pre-Ordnance Survey maps (Tithe, estate maps etc.) and early edition Ordnance Survey maps to identify field boundaries and historic parish boundaries, then relating them to present-day aerial images (2021) to identify historic boundaries that have survived into the present day;
 - Historic Landscape Character data for characterisation descriptions, which may indicate the period from which the existing field patterns relate to, and therefore the approximate age of the hedgerows; and
 - The county Historic Environment Records to relate the known archaeological remains with the hedgerows.
- 2.1.5 The desk study identified which hedgerows were classed as important under the archaeology and history criteria in Schedule 1, Part II of the Regulations, which are summarised here (a full description can be found within The Hedgerows Regulations 1997):
1. The hedgerow marks the boundary, or part of the boundary, of at least one historic (pre-1850) parish or township;
 2. The hedgerow incorporates an archaeological feature (e.g. a scheduled monument or recorded at the relevant date in the Sites and Monuments Record);
 3. The hedgerow is situated wholly or partly within an archaeological site or on land associated with such a site and is associated with any monument/feature on that site;

4. The hedgerow marks the boundary of a pre-1600 AD estate or manor recorded at the relevant date in a Sites and Monuments Record or is visibly related to any building or other feature of such an estate or manor; and
5. The hedgerow is recorded as an integral part of a field system pre-dating the Inclosure Acts or is part of, or visibly related to, any building or other feature associated with such a system, and that system is substantially complete or is of a pattern which is recorded, as a key landscape characteristic.

Wildlife and Landscape

2.1.6 The desk study identified which hedgerows were classed as important under the wildlife and landscape criteria in Schedule 1, Part II of the Regulations, which are summarised here (a full description can be found within The Hedgerows Regulations 1997):

6. The hedgerow contains bird, animal or plant species protected within the Wildlife and Countryside Act 1981, or a Red Data Bird declining breeder or a species categorised as endangered, extinct, rare or vulnerable in Britain or is referred to in a record held by a Local Biological Record Centre for having contained any such species;
7. The hedgerow contains at least five woody species and/or a number of features (for example a bank or wall, a standard tree or a ditch) specified in Schedule 1, Paragraph (7) sub-paragraph (4) or the hedgerow is connected another hedgerow, pond or woodland;
8. The hedgerow is adjacent to a public right of way (PRoW) and includes at least four woody species.

2.1.7 The wildlife and landscape desk study was also supported by the findings of the 2021 and 2022 UK Habitat Classification presented in ES Appendix 7.1: Habitats Baseline Report (**application document 6.3.7.1**) and data received from the Local Records Centre (Essex Wildlife Trust, 2021b; Essex Field Club, 2021; Suffolk Biodiversity Information Service, 2022b British Trust for Ornithology, 2021) supported the desk study. In addition, the report has used the results of the species surveys, which are reported in ES Appendix 7.2: Species Baseline Report (**application document 6.3.7.2**), ES Appendix 7.7: Bat Survey Report (**application document 6.3.7.7**), ES Appendix 7.8: Dormouse Survey Report (**application document 6.3.7.8**) and ES Appendix 7.9: Badger Survey Report (**application document 6.3.7.9**).

2.2 Field Survey

2.2.1 Hedgerows within the Order Limits were surveyed where land access was granted and it was safe to do so. The field survey involved walking both sides of a hedgerow for its whole length. Where walking the full length and both sides was not possible (for example due to landowner restrictions), then the survey followed the requirements set out within Regulation 7(3) based on the length of the hedgerow.

2.2.2 Between one and three 30m sample sections were surveyed per hedgerow, depending on the hedgerow's total length. Species were recorded using the dominant, abundant, frequent, occasional, rare (DAFOR) scale.

2.2.3 In each 30m section, the following was recorded:

- Features listed in Schedule 1 Part II of The Hedgerows Regulations 1997;

- Woodland species as listed in Schedule 2 of The Hedgerows Regulations 1997, for example bluebell (*Hyacinthoides non-scriptus*) and primrose (*Primula vulgaris*); and
- Woody species as listed in Schedule 3 of The Hedgerows Regulations 1997 (including tree species considered rare in Great Britain as listed in Schedule 1 Part II paragraph 7 of The Hedgerows Regulations 1997). These are black poplar (*Populus nigra subsp. Betulifolia*), large-leaved lime (*Tilia platyphyllos*), small-leaved lime (*Tilia cordata*) and wild service-tree (*Sorbus torminalis*).

2.3 Approach in the Absence of Field Survey

- 2.3.1 Field surveys were not possible in all locations due to access restrictions or late changes to the design. A survey has not currently been undertaken of the temporary access route off the A131. National Grid is proposing to survey this route in spring 2023 subject to landowner agreement. In these locations further desk study was used to assign a level of importance as follows.
- 2.3.2 Where the initial desk study identified a hedgerow as important using the archaeology and history criteria (Criteria 1-5 in Section 2.1), the hedgerow was confirmed as important in the absence of field survey and no further wildlife and landscape effort was deemed necessary.
- 2.3.3 Where the archaeology and history desk study did not identify a hedgerow that met the importance criteria, additional desk study was undertaken to determine if a hedgerow would likely be 'important'. This involved using aerial photographs (2021) to identify presence of standard trees and OS mapping to identify features such as PRoW, parallel hedgerows, green lanes and ditches and banks. In addition, survey results of connected and nearby hedgerows were used to assess the likeliness of species composition and hedgerow features of hedgerows that were not surveyed.
- 2.3.4 Where hedgerows had been previously surveyed in 2013, the survey data were reviewed to identify features that indicate the presence of importance criteria. The results were also verified using aerial photographs (2021) to identify similarities. In addition, the hedgerows identified as not important and 'species poor' in the 2013 survey (National Grid, unpublished) that did not hold a desk-based record for a protected species (Criteria 6 in the wildlife and landscape desk study), were assessed as being 'not important'.
- 2.3.5 Where there was any remaining uncertainty, a precautionary approach was applied, and a hedgerow was defined as 'important'.

3. Results

- 3.1.1 The results of the Important Hedgerow Assessment can be found in Table 3.1 and ES Figure 7.5.1 (**application document 6.4**). Hedgerows that could not be surveyed in the field (and whose assessment of importance is as a result made on the desk-based evidence only), have an asterisk in the overall assessment column.
- 3.1.2 Where hedgerow identifiers are not continuous in Table 3.1, this is where hedgerows are either: now located outside of the Order Limits; were found to be lines of trees; or formed the boundary of a garden.
- 3.1.3 Table 3.1 shows that of the 288 hedgerows within the Order Limits, 230 (or 80%) are considered to be 'important' under The Hedgerows Regulations 1997.
