

Application by National Grid Electricity Transmission (NGET) for an Order granting Development Consent for the Bramford to Twinstead Reinforcement (Case Reference: EN020002)

Examination Authority's note of Unaccompanied Site Inspection 3 (USI3) undertaken on 13 September 2023

Two members of the Examining Authority (ExA) (Jason Rowlands and John McEvoy) undertook an Unaccompanied Site Inspection (USI3) on 13 September 2023 to support the examination of the application by National Grid Electricity Transmission plc for the proposed Bramford to Twinstead Reinforcement project. The inspections were generally made from public roads by car. Some locations included additional inspections on foot, as indicated on Table 1.

The route for USI3 was planned with regard to the Procedural Deadline A (PDA) submission from Suffolk County Council [PDA-007], and it focussed on the highway structure locations on the abnormal indivisible load routes from Ipswich (paragraph 7.8). The route and order of visits taken is shown in Figure 1 and Table 1. For the avoidance of doubt, the ExA did not travel on any routes between the Port of Ipswich and Bramford substation.

The weather was dry with clear skies. Visibility at all locations was very good.

It is anticipated that further unaccompanied site inspections will be undertaken by members of the ExA during its examination of the Application. A summary note will be published following any inspection.

Figure 1 Unaccompanied Site Inspection route driven by the ExA on the 13 September 2023 (USI3)


