**The Proposed Bramford to Twinstead Reinforcement Order

We are acting on behalf of East Anglia THREE Limited (“**EA3**”) (a wholly owned subsidiary of ScottishPower Renewables (UK) Limited (“**SPR**”)) and SPR in relation to the development consent application by National Grid Electricity Transmission (the “**Applicant**”) for the proposed Bramford to Twinstead Reinforcement (the “**Application**”).

EA3 and SPR have continued to have productive discussions with the Applicant. The key interface issues between the projects have been agreed upon and the Applicant’s solicitors have now issued the draft Heads of Terms for an Interface Agreement between the Applicant, SPR and EA3, as well as an opportunity to comment on the draft Protective Provisions. We are currently considering the Heads of Terms and the Protective Provisions, as well as the relationship between the two sets of documents, and are hoping to revert to the Applicant as soon as possible as part of that process.

On the basis that EA3 and SPR are happy with the progress made to date with the Applicant and the agreement reached so far on the interface issues, EA3 and SPR will **not** be attending Compulsory Acquisition Hearing 2 on 13 December 2023.
