All updated documents are labelled as Revision (B), Revision (C) etc as applicable, and supersede the documents previously submitted by the Applicant.

Each of these updated documents includes a Version History table which outlines the amendments that have been made by the Applicant since the previous version was submitted. Where applicable, these documents are provided in clean and tracked versions as requested in the Rule 6 Letter [**PD-002**].

The Navigation Document (Document 1.4 (F)) has been updated to reflect the above submissions.

The Applicant wishes to make the following observations by exception:

Statutory and Non-Statutory Sites and Features of the Historic Environment

The Statutory and Non-Statutory Sites and Features of the Historic Environment plans [**APP-015**] have been updated for Deadline 5 to include Historic England Listed Building ID references. **Document 2.8.3** (**B**) therefore supersedes the previous version submitted.

National Policy Statement (NPS) Compliance Tables

The Rule 8 Letter [**PD-003**] included the "Applicant's updated, standalone assessment of compliance with the relevant NPSs (based on Appendices A and B of the Planning Statement), if required" for submission at Deadline 5. The Applicant can confirm that in its view there are no substantive changes to the compliance of the project with the NPSs since the version submitted with the Application [**APP-160**]. Appendix A contains signposting for compliance with NPS EN-1 and Appendix B signposting for compliance with NPS EN-5. The designated NPSs for the purposes of decision making on this project remain those designated in 2011 and no changes have been made to the project that affect compliance with those policies. Therefore, the Applicant has not submitted revised versions of the NPS Compliance tables at this Deadline.

The Applicant does however note the recent Government announcement as part of the Autumn Statement of its intention to designate the revised Energy NPSs (including EN-1 and EN-5). The revised EN-1 contains confirmation of the transitional arrangements in paragraph 1.6.2: *"The Secretary of State has decided that for any application accepted for examination before designation of the 2023 amendments, the 2011 suite of NPSs should have effect in accordance with the terms of those NPS.* Therefore the 2011 NPSs remain the primary policy for determination of the Bramford to Twinstead Reinforcement.

The Applicant is however reviewing the latest draft NPSs and is intending to provide its view on these at Deadline 6 alongside other updates to the Planning Statement [**APP-160**] to reflect legislation and policy updates referred to in representations from other Interested Parties.

Book of Reference (BoR)

The Rule 8 Letter [**PD-003**] also requests submission of the "*Applicant's updated BoR and Schedule of Changes to the BoR and tracked versions (if required)*" at Deadline 5. The Applicant has not provided an update to these at this deadline as no substantive changes have been made since the previously submitted version [**REP4-037**].
