Appendix A – Details of Purpose for Which Compulsory Acquisition and Temporary Possession Powers are Sought

1.1 The specific purposes for which each plot of land subject to compulsory acquisition or temporary possession powers is required are set out in the tables in this appendix. The first column of each table identifies the plot number (as shown on the Land Plans and used in the Book of Reference). Plots are grouped in each row to the extent that they are located on the same Land Plan Sheet. Furthermore, they are grouped into tables depending on the Class of Rights (purpose) in the fourth column and further split between National Grid tables labelled (i) and UK Power Networks (UKPN) tables labelled (ii).

1.2 The second column in each of the tables below, sets out the corresponding principle DCO Work Numbers as shown on the Works Plans (application

- **document 2.5**), Schedule 1 of the draft DCO (application document 3.1(H)) and the DCO explanatory memorandum (application document 3.2(G)) which sets out the proposed use of the land required for the proposed development. The third column of each table sets out in broad terms the description for which the plot in question is required.
- 1.3 There are no cross overs between classes as a rule with the exception of Class 5 pertaining to BNG land. As BNG may be required in addition to Class of Rights 1, 2, 3, 4, 6 and 7 this is reflected on the Land Plans (application document 2.3(C)) to ensure that this is made clear on the Land Plans (application document 2.3(C)), where a plot is solely Class 5 then it is shown in dark green, but where a plot is to be subject to both Class 5 and another class, then the Class 5 dark green colour is shown hatched, so that it is clear what other class also applies.
