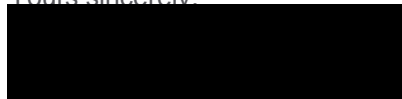
The Navigation Document (**Document 1.4 (K)**) has been updated to reflect the above submissions.

The Final Position on Protective Provisions to benefit Network Rail Infrastructure Limited (**document 8.12.4**) is submitted in response to the Examining Authority's Rule 17 Letter to the Applicant dated 27 February 2024 [PD-017]. This is the only such submission made by the Applicant at Deadline 10 as protective provisions are not believed to be in dispute with any other Statutory Undertakers.

The Applicant has also submitted a Closing Statement (**document 8.12.3**) which draws together the Applicant's case on key issues at the close of the Examination.
