
## LATE SCOPING CONSULTATION RESPONSES

This advice is given in respect of a Scoping Opinion for an Environmental Impact Assessment for an electricity connection. The cable will in part be carried overhead on pylons and in part will be buried. A scoping report prepared by National Grid has been submitted and a draft scoping report has previously been issued which Cadw responded to on the 14 March 2014.

The majority of the issues raised by Cadw in this response have been resolved in the submitted scoping paper and it is noted that the archaeological contractor preparing the Cultural Heritage will be Network Archaeology, which is an Institute for Archaeologists (IfA) Registered Organisation and that the lead compiler is the Responsible Post-holder who is a long-standing Member of the IfA. It is also welcomed that the work will be carried out to the relevant published IfA standards and guidance and that detailed project designs for each stage of the work will be approved by the responsible archaeological curators prior to work commencing. However, there is one factual error, in section 7.4.35 of the scoping report it is stated that "DMRB is the only guidance for mitigating development effects on archaeology and cultural heritage currently endorsed by Welsh Assembly and Whitehall" however the DMR&B (2007) has been not been endorsed by the Welsh Government apart for use in association with the Highways Act 1980.

There is one significant issue that has not been addressed in the scoping report that was raised in Cadw's response of the 14 March 2014 this is in regard to photomontages/wireframe studies in relation to all designated monuments within the 3km buffer. It is noted that some of the viewpoints given in Appendix 6.4, Proposed Viewpoint Locations, will provide some information but in most cases this will not be sufficient to determine the impact of the proposed development on the setting of the designated monuments. This is especially an issue in regard to the overhead sections of the route, where the impacts will be long term. Whilst Cadw understands the cost implications of providing the required photomontages/wireframe, their production would greatly assist in assessing this issue. However, if it is not possible to provide the required photomontages/wireframe we will expect photographs showing the views from and to (i.e. showing the view across the line of the connection towards the monument) of, at least, the following designated monuments to be included in the Cultural Heritage Chapter of the EIA.

The draft scoping report also considers Cadw's previous comments with regards to the need to assess the impact of the proposed development on the setting of registered parks and gardens.

The two registered historic parks and garden closest to the proposed routes are Bryngwyn PGW (Po) 41(POW) and Bodynfoel Hall PGW (Po)42(POW). According to the ZTV (Appendix 6.3) the towers will not be visible from these registered sites.

Secondly we feel the timing of the consultation could have been left until after the decision on the Wind Farm Enquiry has been made – it makes the general public feel that the Wind Farms will be developed regardless of the outcome of the Enquiry.

Thirdly it is important that the Environmental Impact Assessment deals with all aspects of the proposed wind farms including the pylon line which will pass through our village. The Assessment should include the effects on flooding of the bases of these pylons in the flood plain. and

Finally the assessment should cover the cumulative impact.
