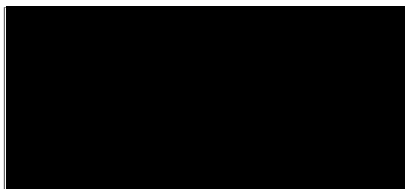
As the documents at bullet points 6, 7, 11 and 13 are in excess of 300 pages, I can confirm that I have also sent two hard copies of this document by post.
