**Other Documentation – Paper relating to Berain**

In response to SWQ 12.7, SP Manweb has been preparing a detailed paper, which explains to the Examining Authority in greater detail the impacts that have been assessed in relation to Berain and why it is SP Manweb's firm submission that such impacts in no way engage the "serious concerns" test outlined in National Policy Statement EN-5. This document is nearly finalised and will be submitted no later than Monday 23rd November 2015.

**Other Documentation – Responses to Deadline 4 and Deadline 5 submitted by Interested Parties**

A number of responses have been received from Interested Parties, submitted at both Deadline 4 and Deadline 5 respectively. SP Manweb is currently preparing a number of responses to the Deadline 4 representations and will submit these no later than Monday 23rd November 2015.

The Deadline 5 representations are also being reviewed and draft responses are being prepared. SP Manweb will submit such responses as soon as possible to the Examining Authority.


**Other Documentation – Revised Landscaping Plans for Option B**

SP Manweb is aware that landscaping plans need to be prepared and submitted in relation to Option B, as the sections of important hedgerows that will be removed under Option B are slightly different in a limited number of locations. These need to be altered as a result to the Order Limits changing as part of the Option B application. These will be provided to the Examination as soon as possible also.

SP Manweb would be grateful if the Examining Authority would use their discretion to accept such other documentation into the Examination process.
