**The North Wales Wind Farms Connection Order
Planning Inspectorate Reference: EN020014
Withdrawal of Objection of Dŵr Cymru Cyf – Welsh Water**

I am writing to inform you that Dŵr Cymru Cyf ("DCC") hereby withdraws all representations it has made to the Secretary of State and the Examining Authority in respect of SP Manweb PLC's ("SPM") application for the for the construction, installation, operation and maintenance of a 132kV overhead line between Clocaenog Forest and a terminal pole located south of Glascoed Road, B5381, near to St Asaph.

DCC and SPM have reached agreement on the protective provisions for the benefit of DCC. The agreed form protective provisions are contained in Part 2 of Schedule 9 to the draft North Wales Wind Farm Connection Order (version 3, 16 October 2015) ("Order") (Examination Library Reference REP3-031).

DCC confirms that it will not be making any future representations objecting to the Order or to any provision of the Order in its current form.
