**Planning Act 2008 (as amended) (PA 2008) – Section 89**

**Application by Western Power Distribution (South Wales) plc for an Order Granting Development Consent for the Brechfa Forest Connection**

**Notification of opportunity to notify the Examining Authority of wish to become an interested party**

The Secretary of State has appointed me to act as the Examining Authority to carry out an examination of the above electric line application under the PA 2008 (“the examination”).

The area of Powys County Council (“your authority”) borders the area of Carmarthenshire County Council in which the electric line is proposed.

I note that in June 2015 the applicant, Western Power Distribution (South Wales) plc notified your authority of the opportunity to make a relevant representation to become an interested party for the purposes of the examination; and that your authority did not make such a representation.

Following this, although your authority did not register as an interested party, it should have received my correspondence dated 3 September 2015<sup>1</sup> and 13 October 2015<sup>2</sup>, however I am now aware that due to an administrative error, it did not receive these. A copy of the above correspondence has been attached. Among other things, that correspondence invited parties to the preliminary meeting, enclosed the examination timetable and notified certain parties of their ability to notify me of their wish to become an interested party.

The preliminary meeting for the examination took place on 6 October 2015 and I am under a duty to complete the examination by 6 April 2016.
