In accordance with the ExA Rule 6 letter the Council confirms the following:

**Notification of wish to make oral representations at the December issue specific hearings**

Officers' of the Council wish to make oral representations at these hearings.

**Notification of wish to speak at an open floor hearing**

Officers' of the Council will attend the open floor hearing but do not intend to make any oral representations.

**Notification of wish to attend an accompanied site inspection, suggested locations and justifications**

We can confirm that we would want the ExA to visit the locality of poles 84-86. We note that whilst this will include the ES Viewpoint 11 that lies part way up the Byway Open to All Traffic (BOAT), views from the BOAT are not restricted to this location. The ExA should also visit the two VPs identified by AJA in Abergwili and the north-eastern edge of Carmarthen i.e. footway along Abergwili Road and pedestrian over-bridge across A40 at Abergwili linking to PRow to north side of A40. We do not consider that there are any additional locations for the ExA to visit.
