RWE say they are going to give hundreds of thousands of pounds in community benefit, may I suggest they spend some of that money on undergrounding the cables which would be much more beneficial to Wales. Land owners have worked all their lives for their property's and should be allowed to demand that the cables go underground on their property.

I would like to read out my granddaughter's comments which she sent to western power right at the beginning. "I have been coming to Wales since birth and it is a beautiful place, the county side is all well looked after and is such a nice place to start a life for any one.

The lines for the electric for the turbines is going to go straight through everyone's lively hood and everyone's HOME, and not just that, they are then going to have to look at this for the next 25 years on their land.

I understand that you may not have a farm or worked on a farm that has animals, but to have poles through the fields that you will be grazing, and cutting and so on, this is a disgrace to think that people will have to live like this and work like this.

I understand that this is a job to try and make things better for people but things have to be looked at from all aspects and who this will be affecting in the long run and now.

I understand that these can go underground, this would cause more work and money which is a slight defect but you have to understand that this will get peoples support a little bit more on the whole job that is to be done.
