In representations to both Carmarthenshire County Council and Western Power Distribution we have stated that the National Park Authority has no comments to make in relation to the proposed development. The scale of the proposal and distance from the National Park are considered to be such as to significantly limit the potential for any negative impact on the special qualities of the National Park.
