The Applicant proposes making further amendments to the DCO in respect of plans following the removal of Plot A245 and its corresponding changes to the Order Limits. As such it is proposed that the final DCO (for both the original and alternative section), together with updated Statement of Reasons are submitted at Deadline 7 on Thursday 31 March 2016.

The DCOs will be submitted with comparites against Version 1 and the Alternative Section DCO against its Version 1. We also anticipate that submitting at Deadline 7 will also allow any comments on the DCO received at Deadline 6 to be considered by the Applicant.

The Applicant will also be submitting the signed DCO SOCG with CCC when this is received from CCC – which is expected later this week.
