1. Schedule 1

1.1. Schedule 1 below provides an update on the progress of voluntary agreements based on the total number of option agreements (45) required, which was submitted at Deadline 7 (**Doc 8.58/REP8-017, Appendix B**). This also details progress based on type of apparatus as queried during the Compulsory Acquisition Hearing on 20th October 2016 (divided into pylons [60], oversail only [17], access rights only [6] and temporary land use [1]). As of 15 June 2017, offer letters (enclosing Heads of Terms) have been sent to PILs in relation to 45 option agreements, comprising 84 pieces of apparatus. To date there are signed Heads of Terms relating to 14 pieces of apparatus/sites.
