**Schedule of Compulsory Acquisition**

Introductory Text

This schedule serves two purposes. Firstly as the answer to question CA 1.1. Secondly it is intended to fulfill the requirements of Rule 8 letter Annex C 2 and will be updated throughout the examination with progress on landowner negotiations, Authority to Surveys, special category land and statutory undertakers. The table responds to parts (a) in column 12, (c) and (d) in column 13 for the relevant parties. In relation to part (b), Authority to Survey access will be secured through the option agreement, therefore the schedule below only deals with the nine Authority to Survey ponds shaded green on the Land Plans for which only Authority to Survey access rights are being sought.

Column 1 of the schedule lists the 114 landowners referred to in CA 1.1 that the Applicant is seeking to reach an agreement with in order to secure the necessary land and/or rights for the project.

\* written representation submitted by land agent as part of representation on behalf of 67 landowners.

\*\* not listed in written representation on behalf of 67 landowners however landowner is being represented by one of the land agents and the same points apply.

Columns 2 and 3 list the plots of land in which it is understood that the landowners have a freehold interests. Where the relevant landowner also has additional category 2 interests in other land, those plots are also listed

Column 4 lists the work(s) numbers (where applicable) that affect the plot.

Column 5 states whether it is intended to acquire the freehold title to the plot. (It should be noted that freehold acquisition is only required at the Substation, Substation access road, Intermediate Electrical Compound and landfall site).

Column 6 identifies:

1) whether it is proposed to acquire "All interests in" a plot pursuant to Article 14(1) of the draft DCO (identified by the word "Freehold");

(2) whether it is proposed to acquire permanent rights or to impose restrictive covenants over a plot pursuant to Article 17 and Schedule 5 of the draft DCO (for ease of reference, the terms used to describe "packages" of rights in the introduction to the Book of Reference e.g. "Cable Rights", "Unlicensed Connection Rights", have been used to identify the rights to be acquired. NB: the "packages" set out in the Book of Reference consist of the rights included in Schedule 5 of the draft DCO set out in full);

(3) whether it is proposed to take possession of a plot pursuant to Article 25(1)(a)(i) of the draft DCO, for the purposes specified in Schedule 7 of the draft DCO (for ease of reference the purpose specified in column 3 of Schedule 7 of the draft DCO as "construction and storage compound" has been abbreviated to "Temporary Compound", and the purposes specified in paragraphs (a) and (b) of column 3 of Schedule 7 of the DCO have been abbreviated to "Temporary Access");

(4) whether it is proposed to enter a plot for the sole purpose of carrying out surveys and investigations pursuant to Article 13 of the draft DCO (identified by the words "Authority to Survey")

Column 7 confirms whether the Applicant has made contact with the landowner regarding the application (through S.42/44 consultation).

Column 8 confirms whether a landowner has returned referencing questionnaires or provided ownership information through other means, e.g phone call, email, letter, site visit, meeting.

Column 9 confirms whether the Applicant or its land agents Ardent have met with the landowner or their Land Agents to discuss the Heads of Terms (HoTs) for an agreement. (It should be noted that through the initial HoTs mail out and the following chaser letters, meetings have been offered).

Column 10 states whether the landowner has received HoTs from The Applicant.

Column 11 states whether the Applicant is currently in negotiations/discussions over the HoTs with the landowner.

Column 12 indicates where an agreement has been completed with the Landowner.

Column 13 indicates whether there are any envisaged impediments to reaching an agreement.
