## 1. Introduction

## **Overview of the Statement of Community Consultation**

This Statement of Community Consultation (SoCC) sets out SP Manweb's approach to the statutory stage of consultation on the proposed development of a new 132,000 Volt electrical circuit from Oswestry to Wem. It has been prepared in accordance with s47 of the Planning Act 2008 (the 2008 Act). Section 47 (1) of the 2008 Act requires applicants to 'prepare a statement setting out how the applicant proposes to consult, about the proposed application, people living in the vicinity of the land'. This SoCC has been prepared in accordance with this requirement. It has been publicised through a public notice, as required by s47 of the 2008 Act and a copy of this notice is available in Appendix 1.

This SoCC explains the community consultation being undertaken and covers:

- The proposed development
- The consenting process
- Where and when the consultation is taking place and who is being consulted
- How the consultation will be undertaken, including the materials that will be published and other engagement activities

- Where people can view these materials and find out more
- The importance of feedback from local people and how they can provide their comments

## The consultation is running from 23 November 2017 to 2 February 2018.

The consultation is an important opportunity for local communities (including residents, businesses, organisations and visitors) to get involved and influence the proposals.

This SoCC has been developed in consultation with Shropshire Council. It is designed to help members of the public understand how they can take part in the consultation and what they can influence. This consultation follows nonstatutory consultation that commenced in June 2016 and continued to run to the end of July 2017. It is anticipated to be the last consultation on the proposed development before an application for a Development Consent Order (DCO) is made to the Planning Inspectorate. It is important to take part if you want to influence the proposed development.

### Who is SP Manweb plc?

SP Manweb plc (SP Manweb) is the licensed electricity Distribution Network Operator (DNO) which owns and manages the electricity distribution network within Cheshire, Merseyside, North Shropshire and North Wales. The network is used to distribute electricity, which has been transmitted to grid supply points, for electricity supply companies to sell onto their customers.

SP Manweb's role is to develop and maintain an efficient, co-ordinated and economical system of electricity supply in the area for which it is responsible. As such, it is the named applicant for this proposed development.

SP Manweb is part of SP Energy Networks which owns three regulated electricity network businesses in the UK. These are SP Manweb, SP Distribution and SP Transmission which transmit electricity in Central and Southern Scotland. SP Energy Networks supplies electricity to:

- 1.5 million customers in Merseyside, Cheshire, North Wales and North Shropshire
- 2 million customers in Central and Southern Scotland

# 2. The proposed development

## Why the proposed development is needed

The current local electricity distribution 33,000 Volt and 11,000 Volt network has been supplying North Shropshire reliably for many years. But with future growth in the region planned up to 2030 and beyond, SP Manweb and Shropshire Council have agreed that there is a need to reinforce the network in order to maintain the required levels of supply in this area.

To reinforce the network, SP Manweb is investing £18m to install a new permanent 132,000 Volt electrical circuit from Oswestry substation, located at the A5/ A495 roundabout, to Wem substation, located on Ellesmere Road on the western side of Wem.

The new 132,000 Volt electrical circuit will provide capacity to support development on land allocated for new jobs and homes in Oswestry, Whitchurch and Wem, as identified in Shropshire Council's adopted Site Allocations and Management of Development (SAMDev) Plan (the Local *Plan*)<sup>1</sup>. The proposed development is therefore vital for unlocking this growth in North Shropshire and Shropshire Council has recognised the need for increased capacity in its draft Economic Growth Strategy 2017-2021 which says:

We have engaged with Scottish Power Energy Networks to secure significant investment proposals in the north of the County to improve electricity infrastructure by 2021.

## What SP Manweb is proposing to build

It is proposed that the new 132,000 Volt electrical circuit will comprise of an approximately 1.2 kilometre underground cable between Oswestry substation and Round Wood and an approximately 21 kilometre wood pole overhead Trident line between Round Wood and Wem substation, consisting of around 176 wood poles with an average height of 12 metres. The installation of this new circuit will require, subject to consent being granted, temporary construction works over an approximately 18 month period between 2020 to 2021.

The installation of an overhead line with a voltage of 132,000 Volt or above, longer than two kilometres, is classified as a Nationally Significant Infrastructure Project (NSIP) under the 2008 Act. This means that a DCO is required to construct and operate the proposed development.

## **Benefits and impacts**

The proposed development will support growth – particularly at Oswestry, Whitchurch and Wem – which will bring new housing developments, new business and new jobs to the local area. All of this growth will need electricity. The existing network is, however, not capable of supporting the expansion set out in Shropshire Council's adopted Local Plan.

The benefits of the new 132,000 Volt electrical circuit cannot be achieved without some impacts related to the construction and operation of the new reinforcement. These impacts potentially include effects on local ecology and wildlife; landscape and visual amenity; archaeology and cultural heritage; and transportation and socio-economic factors.

# 3. The consenting process

DCO applications are submitted to, and examined by, the Planning Inspectorate and a decision is made by the relevant Secretary of State, in this case the Secretary of State for Business, Energy and **Industrial Strategy.** 

## Below is a summary of how the DCO application process works:

- 1 Consultation SP Manweb notifies and consults the public, statutory consultees and those with an interest in the affected land (in accordance with sections 42, 47 and 48 of the 2008 Act) on its proposed application, following earlier non-statutory consultation
- 2 Submission SP Manweb will review the feedback received during the consultation and finalise the proposals, taking this feedback into account. A DCO application will then be submitted to the Planning Inspectorate, who will appoint the Examining Authority for the application
- 3 Acceptance After the application is submitted, the Planning Inspectorate will decide whether it is suitable for examination
- 4 Pre-examination If accepted for examination, there will be an opportunity for people to register their interest in the application with the Planning Inspectorate. Anyone registering an interest will be kept informed of the progress of the application, including when and how they can provide comments. A preliminary meeting will set the timetable for examination
- **5 Examination** The Examination lasts six months. People who have registered their interest will be able to send their comments to the Planning Inspectorate and ask to speak at public hearings
- 6 Decision Following the Examination, the Planning Inspectorate will make a recommendation on the application to the Secretary of State for Business, Energy and Industrial Strategy. Ultimately, the decision as to whether to grant a DCO or not lies with the Secretary of State

NSIPs are determined with regard to National Policy Statements (NPSs) and the relevant NPSs for this proposed development are the Overarching National Policy Statement for Energy (EN-1) and the National Policy Statement for Electricity Networks Infrastructure (EN-5). The NPSs set out national policy against which proposals for major energy projects will be assessed by the Planning Inspectorate and decided by the Secretary of State.

Before submitting an application, the 2008 Act requires developers, such as SP Manweb, to carry out consultation with local communities and statutory consultees. The early involvement of local communities, local authorities and statutory consultees allows an applicant to obtain important information about the economic, social and environmental impacts of a scheme from consultees so that potential mitigation measures can be considered and, where appropriate, built into the proposed development before an application is submitted.

As part of this process, the Planning Inspectorate will follow a number of steps to receive and review the application, and seek further comment from interested bodies and individuals.

## **Environmental Impact Assessment (EIA) Development**

The development is an Environmental Impact Assessment (EIA) development as defined in The Infrastructure Planning (Environmental Impact Assessment) Regulations 2009, as amended. An EIA is being undertaken to ensure the likely effects of the proposed development are properly understood and whether appropriate mitigation can be put in place. The proposed application will therefore be accompanied by an Environmental Statement containing the results of the EIA.

A Preliminary Environmental Information Report (PEIR), which sets out survey methodologies and results, and the likely significant environmental effects of the proposed development, has been produced and copies of the PEIR will be made available on SP Manweb's website (www.spenergynetworks.co.uk/north\_shropshire) and reference copies provided at the various locations as detailed below as part of this consultation.

## 4. Consultation to date

SP Manweb is committed to early engagement with communities and has already provided local people with an opportunity to comment on the proposed development.

## Stage One Consultation

The Stage One Consultation commenced in June 2016 and enabled people living in the area to comment and influence SP Manweb's proposals while they were still at an early stage. It followed two years of previous assessment work that had established where to reinforce the network, identified a number of route corridors and then possible line route options. This led to a preferred line route being put forward at the Stage One Consultation.

Stage One Consultation and the work that had informed it was outlined in the following reports published at the start of the consultation:

- Strategic Options Report (dated May 2016) this report detailed the options considered for reinforcing the network in North Shropshire and the reasons for the preferred design
- Route Corridor Report (dated June 2016) this report set out work carried out in 2015 and early 2016 to consider alternative route corridors for the required upgrade of the electricity supply in North Shropshire
- Line Route Report (dated June 2016) this report set out work that was carried out to identify and assess alternative line route options for the proposed 132,000 Volt electrical circuit.

At the start of the Stage One Consultation, Project Update One (dated June 2016), (a community newsletter that introduced the project, outlined background work and provided details about the Stage One Consultation) was sent to around 3,000 homes, businesses and other stakeholders.

SP Manweb consulted on the preferred line route; likely environmental impacts of the preferred line route and its associated construction works; other line route options that had been considered; and the approach to consultation. The Stage One Consultation asked people to provide comments on the effects the proposals might have on the local area, such as farming, communities, the landscape, wildlife and ecology, and tourism.

Over the 10 week consultation 68 individual responses (40 emails, 21 hardcopy feedback forms, three online feedback forms and four letters), making over 120 comments, were received. 79 people also attended 4 public events in Cockshutt, Wem, Hordley and Whittington, and provided a variety of comments.


Following a review of all of the feedback received, SP Manweb carried out further assessments of suggested changes to the line route and this work resulted in an amended line route. This work was explained in:

- Stage One Consultation Feedback Report, November 2016 – this report outlined the scope of the informal Stage One Consultation and the review of feedback received
- Updated Line Route Report, November 2016 this report identified a 100 metre wide line route based on further assessment work
- Project Update Two (November 2016) this community newsletter summarised the Stage One Consultation, explained the feedback received and how this was considered when developing the revised 'preferred line route'

Following the publication of the above documents in November 2016, SP Manweb has continued discussions with local people and land owners and undertaken more specialist landscape and visual, ecological and historic assessments of the alternative line design options suggested. In particular, this has included looking closely at the preferred route near Noneley, Lower Hordley and the Woodhouse Estate.

SP Manweb continued to engage through meetings with local people and landowners on the alternative options near Noneley, Lower Hordley and the Woodhouse Estate. SP Manweb then considered it appropriate to present these options in **Project Update Three** in May 2017 and to seek feedback on these options. SP Manweb allowed feedback to be submitted up to the end of July by which time it had received around 26 responses, the bulk of which related to the Noneley option. SP Manweb then considered the feedback alongside its further technical environmental and design assessment.

The preferred line route as now published with an indicative preferred line alignment for the 132,000 Volt cable and overhead wood pole line, including construction working areas and accesses and undergrounding of existing lower voltage overhead lines, takes account of this latest feedback from local people and landowners and the further assessment work carried out by SP Manweb.

## 5. Our Statutory Consultation

#### **Overview**

The Statutory Consultation is being carried out in accordance with the requirements of the 2008 Act. This is anticipated to be the final development-wide consultation before SP Manweb makes an application for a DCO.

This consultation is to help people living in the vicinity of the proposed development to understand it and any effects it may have. This gives local people an opportunity to provide further feedback on the proposed development and to influence it.

## What SP Manweb is consulting on

The aim of the statutory consultation is to present and seek feedback on the proposed development. Whilst SP Manweb will consider all comments submitted as part of the consultation, SP Manweb is specifically seeking comments on the following:

- The preferred route for the new 132,000 Volt electrical circuit between Oswestry and Wem, comprising of an approximately 1.2 kilometre underground cable between Oswestry substation and Round Wood and an approximately 21 kilometre overhead wood pole Trident line, between Round Wood and Wem substation, consisting of around 176 wood poles with an average height of 12 metres;
- The location of the temporary construction works areas, such as areas where conductor winching equipment will need to be placed, and construction accesses and laydown areas along the preferred line route; and
- The installation of lower voltage underground cables to replace existing lower voltage overhead lines where the proposed development would be too close to existing lower voltage lines.

Feedback will also be sought on:

- the likely environmental impacts of the proposed development as set out in the PEIR;
- the proposed development's associated construction works;
- SP Manweb's approach to consultation; and
- any other aspects of the proposed development that consultees suggest SP Energy Networks should consider.

## When SP Manweb is consulting

SP Manweb is consulting on the proposed development for 10 weeks, between 23 November 2017 and 2 February 2018.

## Where SP Manweb is consulting

SP Manweb considers that an area of approximately one kilometre from the northerly and southerly edges of the route corridors published in the Route Corridor Report June 2016 is an appropriate consultation boundary to the north and south of the proposed development for the Statutory Consultation.


At the easterly (Wem) and westerly (Oswestry) edges of the consultation boundary, SP Manweb has included existing properties on the edge of the two towns that have potential views onto the proposed development who may be affected and it gives them an opportunity to comment. A map of this consultation zone is available in Appendix 2 and below.

Community consultation activities are focused on this consultation zone and SP Manweb is engaging with those living and working in the consultation zone. A newsletter will be mailed to all residential and business addresses within the consultation zone and consultation events will take place in the main communities in this zone.

SP Manweb recognises that there may be interest in the proposed development beyond the consultation zone. The proposed development will therefore be promoted beyond the consultation zone through press releases to local newspapers with a wider circulation than the consultation zone and through engagement with parish councils and the Shropshire Council, whose administrative boundaries extend beyond the consultation zone.

## Who SP Manweb is consulting

Consulting with people living near to the proposals, who may be affected by the development, is an important part of the DCO planning process. Section 47 of the Act describes these as people "living in the vicinity of the land to which the proposed application relates".

The consultation zone takes into account this requirement and SP Manweb will consult with the following people and groups:

• Local communities – people with homes and businesses in the consultation zone and those outside who have previously commented on the proposals;

- Elected representatives parish and town councils; county councillors; Members of Parliament; and Members of the European Parliament (Appendix 3);
- Hard to reach groups individuals and groups that may have difficulties taking part in the consultation process for a range of reasons (Appendix 3);
- Identified special interest groups such as local wildlife, heritage and leisure groups (Appendix 3).

#### **How SP Manweb will consult**

SP Manweb will consult using a variety of methods to help explain its proposals and encourage people to provide their comments.

## **Community materials**

These materials will help people to understand SP Manweb's proposed development and provide their comments to the consultation. They will be easy to follow and, where appropriate, make strong use of images and graphics.

- Project Update Four this newsletter will provide a summary of the latest proposals, details of the consultation and will include an A2 fold-out map of the proposed development. It will make clear how people can take part in the consultation and what the deadline for feedback is. The newsletter will be sent to homes and businesses in the consultation zone and will be made available on the website, in local libraries and at consultation events.
- Feedback form this questionnaire will provide an easy way for people to record and submit their feedback. The feedback form will be designed to encourage people to provide feedback in relation to the aspects of the proposals SP Manweb is consulting on but also to provide wider feedback in relation to the entirety of the proposed development.
- Website the website (www.spenergynetworks.co.uk/ **north\_shropshire**) will be updated to explain the latest proposals and provide the latest documents for people to download. It will also include maps of the proposals and details of where people can view hard copy materials.

## **Community events**

To give local people the opportunity to meet the SP Manweb team, better understand the proposals and ask any questions they may have, consultation events will be held in the local area. These events will be organised in the villages and towns closest to the proposals.

If, as a result of the feedback, the proposed development changes to the extent that it is necessary to undertake further consultation, this further consultation will be undertaken in accordance with the principles set out in this SoCC and targeted geographically as is appropriate to the change.

A Consultation Report will be produced that sets out how feedback from both statutory and non-statutory consultations has shaped the design of the proposed development. This Consultation Report will be submitted to the Planning Inspectorate as part of the DCO application. Any comments received from consultees may therefore be submitted to the Planning Inspectorate either in part or in their entirety with the application.

When the DCO application has been submitted to, and if accepted by, the Planning Inspectorate, SP Manweb will advertise that the application has been submitted and accepted and explain the next steps in the process. Our wider project timeline is shown below.

## 7. Consultation in addition to the community consultation

SP Manweb has been, and will continue to, contact landowners and occupiers to discuss pole positions and seek to agree rights to construct, operate and maintain the new equipment, voluntarily. Where SP Manweb is unable to reach agreement, it will seek use of compulsory acquisition powers within the submitted DCO.







# Ribera's violent art to be focus of exhibition

A stomach-churning exhibition of works depicting tortured human bodies is to open at the Dulwich Picture Gallery, described by the gallery's director as akin to watching a Quentin Tarantino movie.

Ribera: Art of Violence will be the first major UK exhibition devoted to the 17thcentury Spanish artist Jusepe de Ribera.

It will include a room containing his nightmare vision of the martyrdom of Saint Bartholomew, showing him being flayed alive. It will then shift to classical mythology and the death of Marsyas, flayed alive by Apollo for challenging the god to a music competition and losing.

Other rooms will hold Ribera's draw-

Other rooms will hold Ribera's drawings and prints, including a detailed study of a mouth screaming in pain and a scene from the Spanish Inquisition, with the chief inquisitor seated in an armchair comfortably watching a torture victim contorted in anguish, hung by his wrists from a gallows.

Dulwich Picture Gallery's director, Jennifer Scott, said: "This extraordinary 17th-century artist will be presented in a dramatic and exciting way, creating a visitor experience akin to witnessing a Quentin Tarantino film."

Even in his day, the artist's obsessive concentration on close-up views of torture, martyrdom and deformity raised some eyebrows, and two centuries later the poet Lord Byron wrote that Ribera's brush was "tainted with all the blood of all the sainted".

However, the exhibition at the gallery in south London will attempt to rescue his reputation from the accusation that he was just a brilliant sadist.

Xavier Bray, the director of the Wallace Collection and guest curator of the exhibition, described Ribera as the rightful heir to Caravaggio.

He said: "Ribera's hyper-realistic depic-

tions of extreme violence will be the object of fascination as we marvel at hincredible painterly technique."

## The proposed development

The new 132,000 Volt electrical circuit will comprise an approximately 1.2 kilometre underground cable between Oswestry substation and Round Wood and an approximately 21 kilometre wood pole line, between Round Wood and Wem substation, consisting of around 176 wood pole structures, with an average height of 12 metres.

SP Manweb will be making an application to the Secretary of State for Business, Energy and Industrial Strategy for a Development Consent Order under the Planning Act 2008.
