132,000 volt	The electrical capacity of the Proposed Development. Abbreviated to 132kv
Above Ordnance Datum (AOD)	Elevation of land above sea level (at Newlyn)
Agricultural Land Classification (ALC)	The classification system used by the Department for Environment Food and Rural Affairs based on its quality and versatility. The classification ranges from Grade 1 (the best and most versatile) through Grades 2, 3a, 3b, 3c and 4, down to Grade 5 (least versatile)
Agri-environment scheme / agreement	A UK government undertaking in which farmers are paid to farm in an environmentally sensitive way
Alluvium	Material transported by rivers and deposited along its course
Air Quality Management Area (AQMA)	Declared by local authorities for areas where objectives specified in the national Air Quality Strategy are not predicted to be met
Air Quality Action Plan (AQAP)	Produced by local authorities for AQMAs, setting out measures to improve air quality
Ancient Semi- Natural Woodland (ASNW)	Woodland composed of native tree species that have not obviously been planted
Aquifer	A body of permeable rock that is capable of storing significant quantities of water; is underlain by impermeable material, and through which groundwater moves
Area of Outstanding Natural Beauty (AONB)	An area designated under the National Parks and Access to Countryside Act 1949 (as amended) for its particularly attractive landscape and unspoilt character, which should be protected and enhanced as part of the national heritage
	AONBs are protected by the Countryside and Rights of Way Act 2000 (CROW Act) which also sets out the roles and responsibilities that different organisations must follow to manage AONBs.
Area of Search	The term given to a wide area within which the route corridors are identified
Baseline	Existing environmental conditions which are described in the ES
Best and most versatile (BMV)	Defined by the ALC as Grades 1, 2 and 3a.

Biodiversity	The biological diversity of the earth's living resources. The variety and abundance of species, their genetic composition, and the natural communities, ecosystems, and landscapes in which they occur
Biodiversity Action Plan (BAP)	UK and local level strategies for the conservation of biological resources, now largely succeeded by The 'UK Post-2010 Biodiversity Framework' but lists of priority species and habitats and forms the basis of much biodiversity work
British Trust for Ornithology (BTO)	An independent research institute aimed at using evidence of change in wildlife populations, particularly birds, to inform the public, opinion-formers and environmental policy- and decision-makers
Broad Route Corridor(s)	Initial strategic corridors identified for the Proposed Development (s in the Route Corridor Options Report (June 2016) ( <b>DCO Document 7.8</b> ))
Busbar	A Busbar is a metallic bar (typically made of aluminium) that conducts electricity within a substation.
Cable	An insulated conductor designed for laying underground
Cable Sealing End (CSE)	A Cable Sealing End's function is to connect a power cable to the substation network.
Circuit Breakers	A circuit breaker is an automatically operated electrical switch designed to protect an electrical circuit from damage caused by excess current from an overload or short circuit. Its basic function is to interrupt current flow after a fault is detected.
Competent Authority	An organisation or individual who is responsible for determining an application for a consent for a project. In the context of the Habitats Regulations, 'competent authority' has a wider meaning, which includes any Minister, government department, public or statutory undertaker, public body of any description or person holding a public office.
Concrete Tiles	Buried tiles designed to identify and protect underground and buried power cables.
Conductor	Overhead wire(s) attached to wood poles which conduct electricity
Conservation Area	Designated by local authorities on account of their special architectural or historic interest, the character and appearance of which it is intended to preserve and enhance
Conservation status	For habitats, the elements of Conservation Status that relate to extent, structure, function, and typical species are used to provide guidance on attributes and targets. For species, the elements of population dynamics, range, habitat extent and quality are important. Important elements which define Favourable Conservation Status which need to be reflected in the assessment of feature condition, are the 'long-term maintenance' and

Continuous Tension Stringing Method	A method of installing conductor on overhead lines that ensures the conductor is installed in a controlled manner under continuous tension which prevents the conductor from coming in to contact with anything other than the overhead line supports.
Construction phase	Preparatory works and construction works which will take place before the Proposed Development becomes operational
Consultation Corridors	100m wide corridor(s) within which 132kV Overhead Line could be constructed and which were the subject of pre- application consultation pursuant to the Planning Act 2008
Consultation zone	A zone that encompassed likely effects (either permanent or temporary) arising from the proposals. This included potential environmental or visual impacts, but also those arising from construction or maintenance of the route. Community consultation activities are focused with in the consultation zone.
Countryside and Rights of Way Act (CROW)	The Countryside and Rights of Way Act 2000 (as amended)which provides, amongst other matters, for public access on foot to certain types of land
Cumulative Effects	The effects of other development schemes (whether under construction, consented, or there are firm proposals for) assessed cumulatively with the Proposed Development. These effects can be temporal (e.g. construction phases occur at the same time) or spatial (e.g. the same area is affected)
Decibel (dB)	The scale on which sound pressure level is expressed. It is defined as 20 times the logarithm of the ratio between the root-mean-square pressure of the sound field and a reference pressure (2x10 <sup>-5</sup> Pa)
Department for Business, Energy and Industrial Strategy (BEIS).	Formed from the merger of the Department for Business, Innovation and Skills (BIS) and the Department of Energy and Climate Change (DECC)
Department for Communities and Local Government	The UK Government department responsible for housing, communities and local government in England. Renamed Ministry for Housing, Communities and Local Government in 2017.
Designated area	Area designated and protected by national or international law for its landscape, biodiversity, or historic interest
Development Consent Order (DCO)	An order made by the relevant Secretary of State granting development consent following the submission of an

Distribution Code	The Distribution Code covers the technical aspects relating to the connection and use of the electricity distribution licensees' distribution networks.
	The Distribution Code specifies day-to-day procedures that govern the relationship between a distribution licensee and users of its distribution system for planning and operational purposes in normal and emergency circumstances.
